WHEREAS, the annual school election held February 9, 1971, in the Town of Nutley, resulted in the defeat of the proposed "Current Expenses" Budget of \$4,851,518, and of the proposed "Capital Outlay" Budget of \$39,357; and

WHEREAS, the Board of Commissioners of the Town of Nutley, having met in consultation with the Board of Education, in conformity with R.S. 18:22-37, on the evenings of Monday, February 22, and Monday, March 1, 1971:

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Town of Nutley, in the County of Essex, New Jersey, that the "Current Expenses" Budget be revised to call for \$4,805,332, and that the "Capital Outlay" Budget be revised to call for \$32,707, for the fiscal year 1971-1972; and

BE IT FURTHER RESOLVED that the revised figures be reflected in the "Certificate of Local District School Requirements for School District of Town of Nutley in the County of Essex, New Jersey," as filed with the Essex County Board of Taxation, and as hereby made a part of this Resolution.




