## What is QSAC?

- The Quality Single Accountability Continuum (QSAC) is the Department of Education's monitoring and evaluation system for public school districts.
- It is a single comprehensive accountability system that consolidates and incorporates the monitoring requirements of applicable state laws and programs and complements federally required improvements.
- The system focuses on monitoring and evaluating school districts in five key components that, based on research, have been identified to be key factors in effective school districts.

#### What are the Indicators?

Instruction and Program	Student Performance; Use of Performance Data; Curriculum; Instruction (includes classroom visits); Supervisory practices; Attendance;
Fiscal Management	Accounting/Reporting; Standard Operating Procedures; Fiscal Analysis; Audits; Surplus/Deficit Analysis;
Governance	Maintenance of Policies; Alignment of Fiscal and Instructional Goals; Compliance; Fiscal Reporting
Operations	Student/Staff/Parent Communications; Submission of State Information; Reporting (i.e. EVVRS/HIB); Student Supports; Recordkeeping; Safety and Security
Personnel	Evaluation process; Staffing process; Hiring process; Board Approval process
