Academic Vision Plan

- Expand to Universal Preschool.
- ALL students are reading and performing on grade level by the end of third grade.
- Transition sixth grade to a 6–8 middle school model.
- Establish more deliberate career pathways CTE fields.
- Expand dual enrollment and AP offerings.



Tax Levy Incentive Waiver

- Announced/Communicated Friday March 28
- Only for Districts that Meet Criteria:

1) has an FY 2025 general fund tax levy that is less than its FY 2026 local fair share, as calculated pursuant to N.J.S.A.18A:7F-52

2) is spending below adequacy as determined

- Raise Tax Levy Amount of Underadequcy for Thorough and Efficient Education.
- Districts Receive 5% of Amount Raised in Additional State Aid



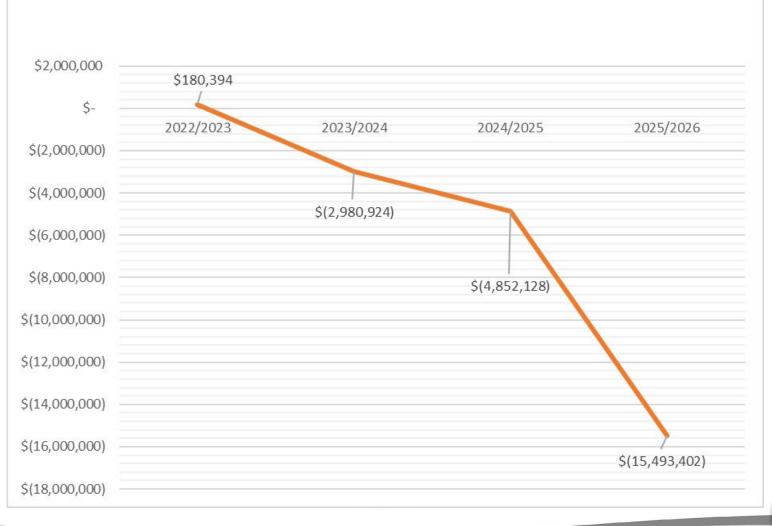
FY 25 Tax Levy vs FY 26 Fair Share

- Local Fair Share amount is \$82,829,618*
- 2024/2025 General Fund Tax Levy is \$65,488,901.
- Nutley is \$17,340,717 below its local fair share amount.

State Aid Increase

- If approved for full amount, the district will receive 5% of the additional approved tax levy in State Aid.
- State Aid increase would be \$130,750.
- State Aid increase will be used on one time expenditures, such as Maintenance/Capital Projects.



Estimated Tax Increase

- Average Assessed Home is \$493,362
- Tentative Budget Increase is \$228.14
 - 2% Tax Levy is \$65.10
 - Enrollment Waiver is \$7.46
 - Health Care Waiver is \$11.59
 - Debt Service is \$7.69
 - Amount from 2024/25 Budget is \$136.30
 - Tax Levy Incentive Increase is \$129.69
 - Total Tax Increase is \$357.83



Next Steps

- Tentative Budget has been approved by the County
- Tax Levy Incentive Paperwork gets submitted to State by 4/14/25 for their approval
- If State approves, budget then goes to County Office for their approval again.
- Advertise Budget in Newspaper
- Public Hearing at 4/28/2025 Board Meeting
 - Depending on timing of State approval, might have to be changed to following week
