4. NEW JERSEY QUALITY SINGLE ACCOUNTABILITY CONTINUUM (QSAC)

WHEREAS, on October 9, 2024, the Department issued an evaluation of the Nutley Public School District pursuant to the requirements of N.J.A.C. 6A:30, the New Jersey Quality Single Accountability Continuum (NJQSAC).

AND WHEREAS, at that time, the school district was placed on the continuum in each of the five performance evaluation areas in the district performance review (DPR): Instruction and Program, Fiscal Management, Governance, Operations and Personnel.

AND WHEREAS, following the initial evaluation, the district developed a District Improvement Plan (DIP) to address all noncompliant areas identified as less than 80% in the table below.

AND WHEREAS, the DIP was approved on March 27, 2025.

AND WHEREAS, staff from the Essex County Office of Education conducted an interim review of the district’s progress in the areas identified in the DIP.

AND WHEREAS, the initial review placement and interim review placement scores for the district are

AND WHEREAS, the New Jersey Commissioner of Education has determined that the district has now satisfied at least 80% of the weighted indicators in each of the five areas of the NJQSAC review process and has been designated as “high performing”, informed the District that these placement results will be provided to the State Board of Education at an upcoming meeting, and provided congratulations on this accomplishment.
