

MINUTES.

The regular monthly meeting of the Board of Education was held in the Board Rooms on the evening of April 24th 1906.

In the absence of the President and Vice President the meeting was called to order by the Clerk.

Upon motion duly seconded Mr. Hill was chosen Chairman pro tem.
