

MINUTES.

A special meeting of the Board of Education was held in the Board Rooms on the evening of May 10th 1906.

The meeting was called to order at 8:30 P.M. by the District Clerk in the absence of the President and Vice President.

Upon motion duly seconded Dr. Philhower was chosen Chairman pro tem.

Members present: Dr. Philhower, Messrs. Stager, Dittig, O'Neil and Hill.

Members absent: Messrs. Booth, Shepard, Clements (excuse) Goodrich (excuse)

It was stated by the Chairman of the Teachers Committee and repeated by the Chairman pro tem that the object of the meeting was to hear a report from the Teachers Committee.

This report was presented by Mr. Dittig, Chairman, and forms Exhibit A.

Upon motion duly seconded it was voted that the Teachers who names appear upon the report be elected for a term of one year, at the salaries indicated. Carried.

Upon motion duly seconded it was voted that the contracts read "to begin work Sept. 1st" and that the Superintendent be given authority to call the teachers together before that date and the date of opening schools, Sept. 10th, as his judgment may direct.

It was voted that the teachers be required to give their decision by the 18th of May as per slip attached herewith or it be considered they decline the appointment.
