The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Wednesday, June 24, 1970, at 8:00 p.m., with Mr. Edward J. Lenihan, President, presiding.

Other members present at roll call were: Mrs. John Peddieson, Mr. Carl A. Ohlson, Mr. Frank A. Cocchiola, Mr. John E. Clayton, Jr., Mrs. Thomas E. Jaworek, Mrs. Edward M. Popadick and Mr. Israel L. Sonenshein. Absent and excused: Mr. Frank V. Tangorra.

#### MINUTES:

Copies of the Minutes of the Regular Meeting held on May 27, 1970, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mrs. Peddieson moved that the minutes of the Regular Meeting be accepted, seconded by Mr. Clayton, and unanimously approved by the Board.

#### COMMUNICATIONS:

1. A letter from Evelyn Corso, teacher, to Mr. Edward J. Lenihan:

"My thanks to you and all the members of the Board for such a final parting - the delicious dinner at the Manor and the silver tray.

"I appreciate your kindnesses and with all good wishes for all to have a happy summer."

2. A letter from Cornelia Simon, teacher, to Mr. Edward J. Lenihan:

"Dick and I wish to thank you and all the members of the Board of Education for the lovely dinner and evening at The Manor in honor of my retirement from teaching. We enjoyed the friendly atmosphere which I have also experienced through all my years as a teacher and parent in Nutley.

"The silver tray is beautiful and will always have a special place in our home. I have many happy memories of the past to add to its lasting beauty.

"Thank you all for having made this possible."

3. A letter from Vivian Fisher, Miss Vivian's School of Music:

"Enclosed please find check for \$135.00. This is payment for the bill I received from you for rental of the High School on June 5th and 6th for my dress rehearsal and Recital.

"I wish to thank the Board for again allowing me the use of their lovely auditorium and I would also like to commend the Custodial Staff for their assistance as well as the boys from the audio-visual department who did a fine job."

4. A letter from Mr. Arthur Bierman, Executive Director, Occupational Center of Essex County:

"The Occupational Center of Essex County Satellite program initial grant period will soon be over. We have applied for support funds (Federal-State) for the period August 1, 1970 through July 31, 1971. It is our hope that these continuation funds will be available to us. It is our fervent hope that the project will be approved for the second year and with your continued assistance, we will be able to use the Nutley facility (Sons of Italy Orphanage).

"The following excerpt is from our application:

"Our future goals for the satellite include the securing of community leaders from the Nutley business and professional area for an Advisory Board to the satellite. This committee will serve to assist the satellite with placement, subcontracting, fund-raising and public relations. After termination of the grant support, the OCEC will retain the staff. The foundations for support and working relationships have been made during this formative period. The improvement grant has made it possible for us to reach out and see growth and progress in service to the handicapped. The Nutley Board of Education and the OCEC Board of Directors are committed to do everything possible to continue this satellite program after the support program is completed."

"I want to thank you on behalf of our Board of Directors and staff for your continued assistance."

#### SECRETARY'S REPORT:

Mr. Zabriskie presented and read the following report:

"The grounds crew, under the direction of Mr. Denadia, and custodians from the Franklin and high schools did an excellent job in setting up the bleachers and other necessary equipment for the Nutley High School graduation and the Franklin School promotion exercises. Erecting these bleachers within the short period of time allowed for this job is a tremendous task.

"On June 3, 1970 the Nutley Lodge of Elks BPOE #1290 again sponsored the Annual Junior Safety Patrol outing at the Bergen County Park in Lyndhurst, New Jersey. There were approximately 350 girls and boys who participated. Numerous games were provided, ribbons awarded to the winners of various events and most important, the boys and girls were well fed. Thanks and appreciation to the Elks BPOE #1290, Mr. Fowler, the Nutley Police Department, the First Aid Squad, the grounds crew, and the leaders from the various schools for all their help in making this program a success.

"At the present time the addition to the Nutley High School is proceeding very well. It will be impossible to renovate the guidance suite, library or the home economics room during the summer as planned because the general contractor stated that his subs were unable to provide the material and equipment necessary to complete this area by September. This work will be held up until there are areas which can be used in the new addition.

"Work at the Yantacaw School is just about complete. The crew is presently working in the nurses room. It is anticipated that this area will be finished within two weeks. Renovations of classrooms and the toilet areas should do much to improve the entire physical aspect of the school.

"The maintenance crew is also replacing wooden window frames with aluminum at the Yantacaw School. Unless there is some unforeseen problem we expect to complete the installation by the opening of school in September.

Slate and cork board frames and six classroom floors are being replaced at the Franklin School. When this work has been completed they will renovate the teachers' dining room at the Lincoln School. Univents for the Spring Garden School have arrived, however, it is doubtful if they can be completely installed by the opening of school in September.

"This is my 25th June Report to the Board of Education and I can't help but think back over the years of the many physical renovations made in the schools - parking areas constructed, play areas installed (including several thousand feet of concrete walls) plus the normal maintenance of the schools, and know that none of this could have been accomplished without the strong support given to me and my staff by the members of the Nutley Board of Education and the citizens of Nutley. I would like at this time to thank the Board of Education for their continued support and cooperation. My sincere thanks to Dr. Fleischer and his staff for the help they have given to me throughout the year and, of course, my thanks and appreciation to my staff of secretaries, custodians, maintenance, grounds and cafeteria employees for their wholehearted support."

#### FINANCIAL REPORT:

Mr. Zabriskie presented the financial report as of May 31, 1970, showing total funds available of \$6,800,058.56, contractual orders to date of \$6,232,506.92, leaving a balance of funds available of \$567,551.64.

#### SUPERINTENDENT'S REPORT:

Dr. Fleischer presented and read the following report:

"High school commencement was held on Tuesday, June 16th at the Park Oval. 489 students were graduated and we are including the program in this report for future readers. Among the honor awards were:

"The student commencement speakers, Gerard Restaino, Ralph Giordano, John Bleski, Carol DiPace, Eileen Bator, Robert Zocca, and Cecilia Espinoza were outstanding.

"Promotion exercises were held at the Franklin School and the various elementary schools beginning June 12 (Lincoln and Radcliffe schools) and ending June 18 (Franklin school.) The exercises were appropriate and well done.

"The Annual Water Safety Campaign conducted by the Nutley Red Cross started June 22 and continues through June 30. 522 children from the Nutley Public Schools are participating. This compares with 578 last year. The figures for the past five years are listed below:

"Title I summer projects (SHIELD, Summer Enrichment, and the reading program) will start June 29 and end July 24. The pre-school program sponsored by the Recreation Department will start July 6 and end August 14. This program will take place at Lincoln and Spring Garden schools.

"Forty-two (42) per cent of the Class of 1970 entered the Nutley Public Schools as kindergarteners. Ninety (90) per cent of the class were members of the ninth grade. Comparable figures for the Class of 1969 were 47 per cent and 88 per cent respectively.

"These statistics indicate the great stability in the Nutley school population.

"Mr. Eugene Duffy, school psychologist, is attending a three week Drug Abuse Workshop (June 22 - July 10) sponsored by the State Department of Education. Workshops have been instituted in the state as a result of recent legislation which mandates school districts to participate in the Drug Abuse program.

"The 1969/70 school year has been an eventful one and your superintendent of schools is appreciative of the support, encouragement, and cooperation he has received from the Board of Education, the staff, the students, and the general public.

AUTHORIZING THE ISSUANCE OF \$1,615,000 TEMPORARY NOTES OF THE BOARD OF EDUCATION OF THE TOWN OF NUTLEY, IN THE COUNTY OF ESSEX, NEW JERSEY:

RESOLVED by the Board of Education of the Town of Nutley, in the County of Essex, New Jersey as follows:

Section 1. Pursuant to Title 18A, Education, of the New Jersey Statutes, Temporary Notes of the school district in the principal amount of not exceeding \$1,615,000 are hereby authorized to be issued in anticipation of the issuance of the bonds of the school district authorized by virtue of a proposal adopted by said board of education on September 18, 1968, and approved by the favorable vote of a majority of the legal voters present and voting at a school district election held on October 8, 1968, and now remaining unissued and including any renewals thereof.

Section 2. The following matters in connection with said Temporary Notes are hereby fixed and determined:

**MATURITY:** As may be determined by the Secretary, but not later than one year after the date of the first note issued hereunder.

**INTEREST RATE:** As may be determined by the Secretary but not exceeding six per centum (6%) per annum.

**FORM:** As determined by resolution adopted June 24, 1970.

Section 3. The Secretary is hereby authorized and directed to determine all matters in connection with said notes not determined by this or a subsequent resolution, and the Secretary's signature upon said notes shall be conclusive evidence that all such matters have been so determined in manner and effect consistent with the form and substance of such notes.

Section 4. The Secretary is hereby authorized to sell said notes from time to time at public or private sale in such amounts as the Secretary may determine at a price not less than the principal amount thereof, and the Custodian of School Moneys is hereby authorized to deliver said notes from time to time

to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof and payment therefor.

Section 5. The full faith and credit of the school district are hereby pledged for the punctual payment of the principal of and interest on said notes and said notes shall be general obligations of the school district payable as to principal and interest from ad valorem taxes which may be levied upon all the taxable property within the school district without limitation as to rate of amount.

Section 6. The Secretary is hereby directed to report in writing to this board of education at the meeting thereof next succeeding the date when any sale of notes pursuant to this resolution is made, such report to include the amount, date, description and interest rate of the notes sold, the price obtained and the name of the purchaser.

Section 7. This resolution shall take effect immediately.
