#### SECRETARY'S REPORT:

Mr. Zabriskie presented and read the following report:

"The regular semi-monthly job meeting concerning the addition to the Nutley High School was held on Wednesday, January 20, 1971. A general review indicates that the general contractor must install some resilent tiles and floor base, install lockers in the corridors (including trim), permanent hardware and complete the millwork and cabinets in the classrooms. There is also a small amount of painting to be completed. Operable walls and folding partitions have been received and are ready for installation by the general contractor. The treads for the stairs in the stair towers are at the job site and are to be erected after most of the other work has been completed in order to avoid damage to the treads.

"The heating contractor has completed the installation of the heating equipment; however, the univent covers and some of the storage cabinets must be completed. The plumbing contractor has a few minor jobs to do such as installing sinks after the general contractor has completed the millwork. Also, some minor piping must be done throughout the building.

"The electrician has completed the wiring of the heating elements and has pulled the wires to the various panels, but some of the lighting fixtures that must be installed have not been delivered. The steel contractor must provide the railings for the stair towers and guard rails for the windows.

"All of the classroom furmiture, including the teachers' desks and chairs, has been ordered and is ready for delivery. We are still working with the high school staff in order to complete the ordering of the equipment for the resource centers on the second and third floors, the art room equipment, and the equipment for the teachers' room.

"The maintenance crew has been working on the renovation of the toilet facilities at the Lincoln School and has been making cabinets for the Washington School.

"I would like to take this opportunity to thank Mrs. Darrow and Mrs. Simons for their fine work in the preparation of the budget booklet and also, thanks to the other members of my staff for their assistance and cooperation. My sincere thanks to Mr. Fowler, Assistant Superintendent of Schools, and my secretary, Mrs. Darrow, for their work in producing the color slides and transparencies for the pictorial budget which you have seen this evening.

#### FINANCIAL REPORT:

Mr. Zabriskie presented the financial report as of December 31, 1970, showing total funds available of \$6,630,326.86, contractual orders to date of \$6,252,456.79, leaving a balance of funds available of \$377,870.07.

## SUPERINTENDENT'S REPORT:

Dr. Fleischer presented and read the following report:

"A recent review of the 1971/72 salary guides of the various Essex County school districts that have settled their salary contracts indicates that Nutley will be at or near the median for the B. A. minimum and for maximum salaries at each of the training levels. Once again, we reiterate that the 'lag' at the M. A. and six-year levels should not be considered as a problem in recruitment and retention of teachers. The 1971/72 guide has continued the structure of a 'career' guide. It appears that the proposed 1971/72 Nutley salary guide will maintain our competitive position in the county.

School districts not included in this survey are Belleville, Caldwell, Cedar Grove, East Orange, Glen Ridge, Irvington, Millburn, Orange, and Verona.

"Hoffmann LaRoche and the high school are again co-sponsoring a series of Saturday seminars on chemical and biological testing. The seminars started on Saturday, January 16 and will continue for six Saturdays. We are grateful to Hoffmann LaRoche for affording our students this unusual opportunity for educational enrichment.

"The annual visual examinations by the Nutley Lions Club are now taking place. This service rendered by the Lions Club is greatly appreciated.

"The 1969-70 Seminar Series, co-sponsored by the NTA and the Nutley Board of Education, was regarded as a positive and successful contribution to the community. Attendance was from about 40 to a high of 80. A total of 37 teachers from all seven schools came to at least one session. Twenty-five (25) teachers attended regularly and earned one graduate credit.

<sup>''</sup>In the final evaluation session, it was recommended that there be a continuance of the program during the 1970-1971 school year. The most persistent suggestions for improving the series were for more audience **participation** and for greater exploration of practical ways in which parents and teachers could cooperate to further strengthen the school system.

"Sharing these opinions, the committee which organized the 1970/71 series has attempted to give it the character of a human relations workshop with greater participation of teachers, parents, and students.

"The 1970/71 program, starting February 1st, will be a series of workshops on the implications of the recent Carnegie Report, <u>Crisis im</u> the Classroom by Charles F. Silberman.

"One hundred twenty-three (123) students participated in the Saturday Extension Program during the fall semester. The median gain of eight (8) months is somewhat better than our previous experience.
