The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Wednesday, June 30, 1971, at 8:00 p.m., with Mr. Edward J. Lenihan, President, presiding.

#### ROLL CALL:

#### MINUTES:

Copies of the Minutes of the Regular Meeting held on May 26, 1971, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mrs. Peddieson moved that the minutes of the Regular Meeting be accepted, seconded by Mrs. Jaworek, and unanimously approved by the Board.

#### COMMUNICATIONS:

Mr. Zabriskie read the following communications:

1. A letter to Dr. Robert Fleischer from W. N. Masten and family:

"Our sorrow is made easier to bear through the thoughtfulness of friends like you, President Edward Lenihan, members of the Nutley Board of Education and Everett Zabriskie, Secretary and Business Administrator.

"We want you all to know how much we appreciate the memorial resolution passed by the Nutley Board of Education at the public meeting held on April 28, 1971 in memory of our beloved wife and sister, Hazel. She would have been so happy had she been able to read the copy which you so graciously sent me.

"The expression of sympathy and resolution always will be treasured.

"Thank you for your sympathetic, kind and understanding letter. Please extend our Thank You to all concerned. "

2. A letter from Vivian Fishco, Miss Vivian's School of Dance:

"Enclosed please find check for \$175.00 to cover costs of rental of high school for my Dance Recital.

"Once again I wish to thank the Board for allowing me the use of your lovely auditorium and I wish to commend your custodial staff for their help and cooperation as well as the finely trained boys who are part of the stage crew. "

3. A letter from Thomas Conklin, Custodian at Yantacaw School:

"Please be advised that I would like a leave of absence because of my ill health. When my condition improves I would like to be considered for re-appointment if possible. Thank you so much. "

4. A letter from Carl L. Marburger, Commissioner of Education, State of New Jersey, Department of Education:

"In order to comply with the provisions of Section 3, Chapter 234, Laws of 1970, all Board Secretaries are directed to complete the enclosed form and return it to this department by July 31, 1971. Upon receipt of the completed form by this department, each operating school district shall be classified as basic for the school year 1972-1973.

"Request for classification other than basic cannot be considered until the Permanent Commission on State School Support shall review and approve the criteria and standards formulated by the Commissioner of Education and submit such criteria and standards to the legislature for enactment by law. Recommended criteria and standards formulated by the Commissioner were approved by the State Board of Education on March 3, 1971, and forwarded to the Permanent Commission."

#### SECRETARY'S REPORT:

Mr. Zabriskie presented and read the following:

"The grounds and maintenance crews, with the assistance of custodians from the various schools, did an excellent job in setting up the bleachers and other necessary equipment for the Nutley High School graduation and the Franklin School promotion exercises. Additional bleachers were erected to the rear of the graduating classes. I have no idea how many people attended the two events, however, I would imagine there must have been about 6,000 to 8,000 at the high school graduation and approximately 3,000 at the Franklin School promotion exercises.

"Work on the addition to the high school is progressing, with only a few items that remain to be completed. The contractors are presently working in the library area, plastering columns and working on the finishing touches. Carrols have to be installed, and the family living room must be completed. We don't anticipate any difficulty in having the total job completed for the use of the students in September.

"At the close of the winter season in March, one of the boilers at the Yantacaw School blew a section. The boiler is over fifty years of age and is impossible to repair or to secure a replacement section. A resolution is before you this evening recommending the appointment of Bickford & Spaeth Associates, engineers, to draw plans and write specifications for the installation of a new boiler at Yantacaw School. No monies were allocated in the budget for this item; consequently, it was necessary for me to curtail most, if not all, of the windows which were to be installed at the Lincoln School. A resolution is before you this evening to reject the bids for the windows, and I would like to take bids for fewer windows, hoping that some of the windows may be installed at the Lincoln School this year.

"The maintenance crew is working at the Washington School renovating a large classroom which we expect to have completed by fall. Also, the music and art rooms at the high school are scheduled for renovation.

"The Annual Junior Patrol Picnic was held on Wednesday, June 2, 1971, at the Bergen County Park, Lyndhurst, New Jersey. This picnic was once again sponsored by the Nutley Lodge of Elks BPOE #1290 and the Board of Education. This is approximately the 25th year for the annual patrol picnic, and again, we had a good turnout of approximately 350 boys and girls. These students work diligently during the year

protecting the safety and lives of their fellow students. This is only one small way in which we can thank these boys and girls. Each of the students receives a small pin in the shape of a police badge. Ribbons and other items are provided for the winners of the various types of games. Unfortunately, this was the first time in 25 years that I was unable to actively participate. My sincere thanks and appreciation to Mr. Glyn Fowler, Assistant Superintendent of Schools, Chief Francis T. Buel and members of the police department, members of the First Aid Squad, Board of Education grounds crew and the cafeteria staff, as well as the teacher patrol leaders in the various schools who all helped to make this program a real success.

"I would like to thank the Board of Education for their continued support and cooperation during the past year. My thanks to Dr. Fleischer and his staff for the assistance they have given throughout the year, and of course, my thanks and appreciation to my staff of secretaries, custodians, maintenance, grounds and cafeteria employees for their wholehearted support and cooperation.

"Promotion exercises were held at the Franklin School and the various elementary schools beginning June 16 (Lincoln) and ending June 23 (Franklin). The exercises were appropriate and well done.

"The annual Water Safety Campaign conducted by the Nutley Red Cross was to start June 25 and continue through July 2. Four hundred seventeen children from the Nutley Public Schools enrolled. This compares with 522 last year. The figures for the past five years are listed below:

"Title I summer projects (SHIELD, Summer Enrichment, reading and the Learning Packet Workshop) started June 28 and will end July 23. The pre-school program sponsored by the Recreation Department will start July 12 and end August 20. This program will take place at the Washington and Spring Garden Schools.

"Forty-two (42) per cent of the class of 1971 entered the Nutley Public Schools as kindergarteners. Ninety-three (93) per cent of the class were members of the ninth grade. Comparable figures for the Class of 1970 were 42 per cent and 90 per cent respectively.

- (1) The amounts of money provided are totally inadequate to achieve proper goals of state support.
- (2) Many districts would have to make considerable expenditure, sometimes beyond their means, to achieve any classification other than basic.
- (3) The comparison of school to school and system to system, which would follow from any state imposed testing program, would be divisive, and harmful to public support of education in many districts.
- (4) The objectives established in the criteria are extremely difficult to measure, involve much subjective judgment on the part of state officials, and have questionable validity as measures of quality. The criteria are not related, as they should be, to ability to pay.

- (5) Administrative and supervisory costs would be sharply increased at state and local levels.
- (6) There is an absence of models or examples that the kind of criteria proposed actually leads to substantial improvement in the quality of education.
- (7) While community involvement is desirable, boards of education are the legally constituted authorities for the operation of the public schools, and their judgment should not be superseded by that of community groups in the submission of local plans required for additional state aid, nor should their legal prerogatives be diminished in such a manner,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education of the Town of Nutley respectfully requests that the New Jersey Legislature and the State Department of Education give careful consideration to these concerns and involve local school administrators in the formulation of criteria for additional state aid.

Section 1 Pursuant to Title 18a, Education, of the New Jersey Statutes, Temporary Notes of the school district in the principal amount of not exceeding \$195,000 are hereby authorized to be issued in anticipation of the issuance of the bonds of the school district authorized by virtue of a proposal adopted by said board of education on January 25, 1971, and approved by the favorable vote of a majority of the legal voters present and voting at a school district held on February 9, 1971, and now remaining unissued and including any renewals thereof.

Section 2 The following matters in connection with said Temporary Notes are hereby fixed and determined:

**MATURITY:** As may be determined by the Secretary but not later than one year after the date of the first note issued hereunder.

**INTEREST RATE:** As may be determined by the Secretary but not exceeding six per centum (6%) per annum.  $3\frac{7}{8}\%$

**FORM:** As determined by resolution adopted June 30, 1971

Section 3 The Secretary is hereby authorized and directed to determine all matters in connection with said notes not determined by this or a subsequent resolution, and the Secretary's signature upon said notes shall be conclusive evidence that all such matters have been so determined in manner and effect consistent with the form and substance of such notes.

Section 4 The Secretary is hereby authorized to sell said notes from time to time at public or private sale in such amounts as the Secretary may determine at a price not less than the principal amount thereof, and the Custodian of School Moneys is hereby authorized to deliver said notes from time to time to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof and payment therefor.

Section 5 The full faith and credit of the school district are hereby pledged for the punctual payment of the principal of and interest on said notes and said notes shall be general obligations of the school district payable as to principal and interest from ad valorem taxes which may be levied upon all the taxable property within the school district without limitation as to rate of amount.

Section 6 The Secretary is hereby directed to report in writing to the board of education at the meeting thereof next succeeding the date when any sales of notes pursuant to this resolution is made, such report to include the amount, date, description and interest rate of the notes sold, the price obtained and the name of the purchaser.

Section 7 This resolution shall take effect immediately.

Education, of the New Jersey Statutes in anticipation of the issuance of bonds of the school district authorized for a capital project or capital projects for lawful school purposes by virtue of a proposal or proposals adopted by said board of education and approved by the favorable vote of a majority of the legal voters of the school district shall be designated "Temporary Note", shall refer by date of adoption to the resolution pursuant to which it is issued and to the proposal or proposals by virtue of which such bonds are authorized, shall recite that it is issued in anticipation of the issuance of such bonds, and shall be substantially the following form:

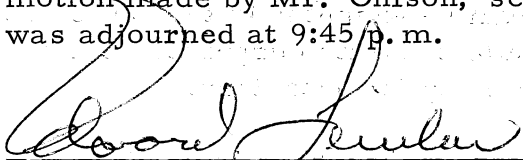
NEW BUSINESS:
