#### AUDIT:

Dr. Fleischer read the following recommendation from A. M. Hart, A. M. Hart Company, for the School Year 1970-1971:

"That the Surety Bond of the Custodian of School Moneys be Increased to a minimum of \$80,000 in accordance with Regulations of the State Department of Education."

Dr. Fleischer commented that the above had been implemented.

#### FINANCIAL REPORT:

Dr. Fleischer presented the financial report as of October 31, 1971, showing total funds available of \$6,608,605.67, contractual orders to date of \$1,488,296.54, leaving a balance of funds available of \$5,120,309.13.

# SUPERINTENDENT'S REPORT:

Dr. Fleischer presented the following report:

"It is recommended that the Board of Education approve a lay citizens committee for Title I ESEA programs. This action is necessary under the revised rules and regulations if we are to be eligible for Title I funds. This committee will be advisory to the Board of Education. There is a resolution tonight with regard to the appointment of the committee.

"A sub-committee, chaired by Mrs. Mary Whelan, has been established to develop an elementary social studies course of study. Target dates have been established so that texts and materials to be used to implement the course of study can be approved prior to the 1972-1973 school year.

"We are in receipt of memoranda from the New Jersey School Boards Association and the Commissioner of Education that, in essence, states:

- (a) Existing contracts will be allowed to operate according to their terms on or after November 14, 1971.
- (b) The question of retroactivity for increases withheld during the 90 day freeze period has not been determined.
- (c) The exact application of the 5.5% standard for new contracts, that is, those not now in existence, is not yet clear.

"Accordingly, the December check will be based on the 1971-72 contracted salary and any amounts due the employee because the 1971-72 contract went into effect as of November 14th.

"Dr. Fritz Hess, Superintendent of Schools in East Syracuse-Minoa Central Schools has been named chairman of the visiting committee, Middle States evaluation team. The visitation of Nutley High School will be March 13-15, 1972.

"It appears that there will be no increase in state aid for the 1972-73 school year, Any increases in the 1972-73 school budget will reflect a direct increase in local effort.

"The ten year enrollment trend is shown below. There has been a 15 per cent increase in total enrollment with the greatest portion of the increase at the high school.

# GRAND LODGE OF NEW JERSEY - SONS OF ITALY IN AMERICA TAX BALANCE:

Mrs. Peddieson presented and moved the adoption of the following resolution, seconded by Mrs. Popadick, and unanimously approved by the Board:

WHEREAS, on July 1, 1971, the Board of Education purchased the premises owned by the Grand Lodge of New Jersey - Sons of Italy in America, located at 529-533 Washington Avenue, Nutley, New Jersey, known as Lot 1 in Block 522 on the Tax Assessment Maps of the Town of Nutley, and

WHEREAS, the Board of Education had requested that the Board of Commissioners exempt the Board of Education from paying the balance of the taxes inasmuch as it is a tax exempt organization, and

WHEREAS, in the year 1971, taxes assessed against the said premises were in the amount of \$6, 205. 40 leaving an unpaid balance of \$3, 102. 70, and

WHEREAS, the Board of Commissioners at their meeting held on October 19, 1971 passed a resolution cancelling the outstanding tax balance of \$3,102.70 on the above mentioned premises,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education accepts this cancellation of taxes and extends its sincere appreciation to the Board of Commissioners.

#### OLD BUSINESS:

Dr. Fleischer commented that the cafeteria had been operating at a deficit and that he planned to increase the price for lunch the beginning of January. He further commented that because of the wage-price freeze we had been unable to do this before. Mr. Lenihan suggested that the increase for lunch be put into effect immediately.

#### NEW BUSINESS:

Miss Gail Folena, Nutley High School student, questioned why it was necessary for students to attend school the full day before Christmas. Dr. Fleischer commented that prior to settling the final school calendar, consultations had been held with teachers, administrators, and Board members. He further stated that educationally speaking, single session days were less than adequate, and a great deal of absenteeism was created by single session days.

Mr. Milan Getting, Music Parent's Association, thanked the Board for their help with the Music Boosters Program which assists students with their scholarships, summer school, twirlers, etc. He commented that their group had encountered some problems with regard to raising funds during the past year. Dr. Fleischer suggested that a contingent of the Music Parent's Association meet with Dr. Fleischer, the Board of Education representative, and Dr. Ersfeld shortly after Thanksgiving to see how this problem can be eliminated in the future.

Mr. Getting also commented that various bands in the area serve refreshments (orange juice and doughnuts) to the visiting band at half-time and suggested that this be done in Nutley. Mr. Lenihan suggested that this item also be put on the agenda when the above mentioned meeting takes place.

#### ADJOURNMENT:

There being no further business to come before the Board, on motion made by Mr. Ohlson, seconded by Mrs. Peddieson, the meeting was adjourned at 8:45 p. m.
