#### MINUTES:

Copies of the Minutes of the Regular Meeting held on September 20, 1972, being in the hands of each member, reading of same was dispensed. Mr. Clayton moved that the minutes be approved, seconded by Mrs. Popadick, and unanimously approved by the Board.

COMMUNICATIONS: None

#### SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"At the high school the acid waste pipe replacements have been completed and tested. The only remaining work now is to patch the ceilings where they were cut. We plan to install a removable ceiling along the main run of the corridor and patch the rest of the ceilings with acoustic material to match the existing. A recommendation for awarding of a contract to complete this ceiling work is in another part of the agenda.

"The folding doors for the music room (#101) in Franklin School have been delivered and installed. Mr. Gilligan is very happy with the new flexibility this installation affords. The new folding doors for the gym are scheduled to arrive at the end of this month and installation will take about a week.

"The new aluminum replacement windows for Lincoln School have been delivered to the warehouse where they are presently being assembled. By the time you receive this report we will probably be starting to install them at the Lincoln School. Since classes are now in session we will have to limit our operations to a room at a time. Mr. D'Andrea will cooperate in making these rooms available as the need arises.

"We have secured the temporary services of Mr. Lou Stager, who retired as maintenance foreman some years ago, to assist in the assembly and installation of these windows. Mr. Stager's experience in this work will be very valuable to us.

"The work at the Special Education Center came to a halt when we lost our plumber a few weeks ago. However, the front of the building has been renovated to some extent, in that the roof over the front entrance has been renewed and the columns have been scraped, repaired and repainted. In addition, the architects have been busy working on cost estimates for work in the area of the roof. The results of their study will be an item for discussion at our next conference meeting. A resolution of the plumber situation is also contained in another section of the agenda.

"The temporary fence to be installed at the Park Oval, which was discussed at the last Athletic Meeting to assist in handling the crowds, was installed two weeks ago and worked very well at the football game last Saturday. We met with Deputy Chief Dimichino of the Police Department, together with the high school administration, and an effective plan for crowd control was worked out. The high school administration should be commended for the work they did on this plan.

#### FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of September 30, 1972, showing total funds available of \$6,780,763.70, contractual orders to date of \$6,190,626.62, leaving a balance of funds available of \$590,137.08.

#### SUPERINTENDENT'S REPORT:

Dr. Flesicher presented and read the following report:

"Enrollment projections based on the September 30th enrollment and on variables based on experience over the last few years show that we can expect the high school enrollment of 2150-2200 and the Franklin School enrollment of 825-875 to be relatively stable for the next several years. Elementary enrollments tend to stabilize around 2700. It will be necessary to continue to make these projections annually. The variables can change rapidly and significant alterations in the projections can take

place, As reported last year, the decreased birth rate was 15.5 per cent fewer children under five years of age in 1970 than in 1960. This decrease, surprisingly, coincides with the greatest increase in the number of people most capable of having children, those between 15 and 34.

"The high school is holding its open house this evening. The various elementary schools and the Franklin School will hold or have held open house at the respective initial PTA meetings.

"Permission has been granted to Mrs. Viola Poynter to participate as a member of the committee for the Middle States Association of Colleges and Secondary Schools evaluating Pequannock High School.

"On Monday, November 6, 1972 the high school social studies department is 'sponsoring' a straw vote presidential election for the student body and faculty. The polls have been set up in such a manner to be as 'realistic' as possible.

"Meetings have been held with state department officials about several possibilities available to capitalize the remodeling needs of the Training Center. We shall be prepared to make recommendations to the Board of Education relative to this matter prior to the next public meeting. Any recommendation will have budgetary implications, so the Board will need some 'lead time' to make decisions about the Training Center.

"Arrangements have been made to hold regularly scheduled joint departmental meetings between the Franklin School and the high school in October and April each year. Other meetings may be held at the discretion of the various departments. Each group determines its own agenda and the high school department head will chair the meetings. The first meeting was held on October 16; the next scheduled meeting will be held on April 16, 1973.

"We have been advised by Judge Bellfatto that Mr. John Jacone, vice-principal at the high school, has been appointed to the Nutley Juvenile Conference Committee. Mr. Jacone replaces Mr. Ralph D'Andrea, who resigned from the Committee.

"Mr. Karekin Bakalian, principal of Radcliffe School, is chairing a math review committee. This committee has been charged with the responsibility to recommend a textbook series for the elementary schools."
