#### MINUTES:

Copies of the Minutes of the Regular Meeting held on November 29, 1972 being in the hands of each member, reading of same was dispensed. Mr. Clayton moved that the minutes be approved, seconded by Mr. Cameron, and unanimously approved by the Board.

Mr. Ramsland read the following communications:

1. A notice from the New Jersey School Boards Association with regard to the Special Delegates Meeting, January 27, 1973, Trenton, New Jersey.
2. A letter from Miriam E. Hughes, Coordinator, School Nutrition Services, Department of Education, Division of Field Services:

"Approval has been granted for your policy statement for Free and Reduced Price Meals.

"Implementation of the Free and Reduced Price Meal Policy will be reviewed and evaluated through our Administrative Review Process of the Bureau of Food Program Administration.

"School Districts may not alter or amend standards set forth in approved policy statements without advance approval from the Bureau of Food Program Administration, Department of Education."

3. Copy of a resolution from Daniel Duffield, Secretary-Business Manager, Clifton, with regard to Workmen's Compensation.
4. Copies of resolutions from Brick Township Board of Education, and Berkeley Township, with regard to collection of taxes for school districts.

5. A letter from Frances Williams, Secretary - Superintendent's Office:

"My family and I wish to express our appreciation to all those who came to call when my husband was suddenly taken from us.

"Your beautiful flower arrangement of white chrysanthemums and pom-poms gave great comfort. It was left in the church after the service to be used on the altar Sunday morning."

6. A letter to the members of the Nutley Board of Education from Terry Verdi, Secretary, Guidance Department, Nutley High School:

"May I express my appreciation for the opportunity afforded me to attend the Thirty-Fifth Annual Convention of the N.J. Association of Educational Secretaries on November 2 and 3, 1972.

"The keynote speaker was Mrs. Mary Markulin, Training Consultant in Advanced Secretarial Management Field. Mrs. Markulin discussed 'New Horizons for Professional Growth.'

"Mr. Richard F. McQuillan, Supervisor, Field Services, Division of Pensions presided at an open meeting, 'An Up-Date on Pensions and Retirement.'

"I was also fortunate to hear Ralph Nader discuss his attack of Educational Testing Service of Princeton; Art Linkletter, his participation in the fight against drug abuse; and Victor Borge who provided a very humorous and entertaining evening.

"Last, but not least, our very own 'Dr. Fleischer' was among the celebrities on stage at Convention Hall as the newly appointed President of the New Jersey Association of School Administrators.

"Again, may I say 'thank you' for the opportunity to attend this excellent program."

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"The window replacement program at Lincoln School has been progressing but at a somewhat slower pace than was anticipated. This was due to the fact that it has been necessary to take the men away to perform repairs in other parts of the system which needed immediate attention. Glass replacement has not been a small part of this problem.

"The Park Oval bleachers have not yet been dismantled and stored because the storage space is now taken up by aluminum replacement windows which have been assembled but not yet moved to Lincoln School for installation.

"The plumbers are utilizing the school vacation days to perform repairs in the schools which require shutting down the heat or draining water pipes. As soon as these emergency repairs are completed they will return to the work at the Special Education Center.

"An emergency shutdown in the electrical power system at Lincoln School was made necessary two weeks ago in order to replace the main circuit breaker which had gone bad from water running through the underground main service wire and into the breaker. The

staff did a remarkable job with the children under these adverse conditions.

"The office staff has been busy preparing the budget booklet, for distribution to the citizens early next month. As of this date, eight citizens have requested and received Nominating Petitions for the Board election to be held on February 13, 1973. The last date to file Nominating Petitions is Thursday, January 4, 1973, and the Drawing for Position on Ballot will be on Friday, January 5, 1973 at 8:00 p.m. in the Board Room. The Public Hearing on the Budget has been tentatively scheduled for Monday, January 22, 1973 in the high school auditorium.

"On Thursday, December 21, 1972, after the tentative budget had been completely assembled, a memorandum was received from the State Department of Education designating a change in the chart of accounts. The changes which affected Nutley's budget include:

- a. The budgeting of all transportation costs, including athletics, under the Transportation account (500).
- b. The budgeting of all moveable equipment, whether replacement or new, in the Maintenance account (700).

"This results in, as far as Nutley's 1973-74 Budget is concerned, the elimination of the Capital Outlay account.

"I have also just received from the State Department of Education the allocation of State Aid for the 1973-1974 school district budget. Following is a comparison with 1972-1973.

"The increase in Formula Aid is due to the higher funding of the 'Bateman' bill. Transportation Aid increase reflects increased transportation costs. The decrease in Atypical Pupil Aid is due entirely to the fact that salaries in some categories have been disallowed in the 1971-1972 report, and the allowable percentage of salaries in other categories has been decreased. These resulted in a \$49,597 reduction in allowable salaries, 50% of which amounts to a \$24,798 reduction in State Aid, but other special education cost increases reduced the decrease to \$16,919.

## FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of November 30, 1972, showing total funds available of \$6,781,730.58, contractual orders to date of \$6,328,891.48, leaving a balance of funds available of \$452,839.10.

## SUPERINTENDENT'S REPORT:

Dr. Fleischer presented and read the following report:

"The annual Yuletide program was held on Monday, December 18, in the high school auditorium. High school vocal and instrumental groups were featured and they performed exceptionally well. Dr. Ernest Ersfeld, Mr. Raymond Kohere, Mr. Leonard Tobias, Mr. Lester Hrbek and the participating students are to be commended.

"Salary negotiations with the Nutley Teachers' Association for the 1973-74 school year have been completed. The BA minimum has been increased to \$8650 (from \$8400). The overall salary increase was 6.6 per cent (including normal increment). The salary guide adjustment was four per cent.

"As of this date, two other Essex County school districts have made 1973-74 salary settlements. The salary guides for these two districts are being developed, but the overall settlements are very similar to the Nutley settlement.

"Continued increases in the cost of living accompanied by an increasing supply of teachers complicated the teacher-Board negotiations. Both the Nutley Teachers' Association and the Nutley Board of Education worked diligently to arrive at what is thought to be an equitable and reasonable settlement. It is an almost impossible task.

"On Thursday, December 21, the annual alumni meeting was held at the high school. A group of recent Nutley graduates who are attending college shared their college life experiences with high school seniors. The Class of 1973 hosted the meeting that was arranged by the guidance department.

"The possibility of getting our 1972-73 Title I application approved is rather remote. We have been advised that our 1972-73 allocation will be available for 1973-74 in the event that we do not have a Title I program in 1972-73. Funds have been provided in the 1973-74 budget to assure the continuance of our Title I programs (SHIELD and the Summer Enrichment Program).

"On Thursday, December 21, there was an all-day display at Radcliffe School of teacher-made and classroom-tested multi-media instructional material boxes prepared by apprentice teachers from Jersey City College. There was also a continuous multi-image projection of color slides showing Nutley elementary children and apprentice teachers in 'action' - sciencing.

"We are now working on the script and film slides for the visual presentation of the 1973-74 school budget. Groups interested in this presentation should contact the Board of Education office."

Total "A" lunch - 13,616. Total milk sold - 18,924. Free lunches - 1,877. 16 school days.
