The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board of Education Office, 149 Chestnut Street, on Tuesday, May 27, 1975, at 8:00 p.m., with Mrs. Thomas E. Jaworek, President, presiding.

FLAG SALUTE:

The meeting was opened with Mrs. Popadick leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

ROLL CALL:

The other members present at roll call were: Mr. John E. Clayton, Jr., Mr. Walter S. Lindstrom, Mr. Carl Perez, Mrs. Edward M. Popadick, Mrs. Bernard Rabinowitz, Mr. Gerard T. Restaino, Mr. Frank V. Tangorra and Mr. Louis F. Williams. Approximately 25 citizens present.

MINUTES:

Copies of the minutes of the Regular Board Meeting held on April 28, 1975, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mr. Clayton moved that the minutes be approved, seconded by Mrs. Popadick, and unanimously approved by the Board.

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"Strange things are happening. Last Friday's Supreme Court decision revoking State aid for over half the school districts in New Jersey is somewhat bewildering. One must assume that we were misled when, two years ago, the same august body of men confirmed a previous decision that the financing of education is the State's responsibility, and that local property taxes may not be levied for this purpose, for now they are telling us that we in Nutley must raise an additional million dollars in 1976-77. They don't say we must do it with additional property taxes, but I'm sure they are aware, as we are, that Mr. Onassis did not provide for us in his will. This loss of State aid will boost Nutley's tax rate by approximately 38 points over the two year period, calculated at present ratables, and there will be no corresponding reduction in taxes that Nutley citizens will be paying to the State.

"Probably the first reaction of reasonable people was that this was all a bluff, a power play to prod the Legislature into enacting an income tax. This explanation might suffice if the decision had been made by you or me, who might employ such tactics to win in this 'real world' game, but is it possible that the highest judicial office

in the state could speak with tongue in cheek? When, however, one beholds the spectacle of the judiciary taking excursions into the province of the legislature, at the urging of the executive, one has good cause to wonder.

"The broken window replacements for the month ending last Friday stands at 55. This would appear to be something of a record, but not one to be proud of. I truly hope it stands unbroken for many years to come. No doubt the youngsters responsible for these acts will eventually come to realize the utter wastefulness of a window replacement program that is being pressed upon an already hard-pressed tax-paying public. I hope that this realization comes soon.

FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of April 30, 1975, showing total funds available of \$8,244,977.92, contractual orders to date of \$7,381,879.44, leaving a balance of funds available of \$863,098.48.

FINANCIAL REPORT - ATHLETIC:

Mr. Ramsland presented the athletic financial report as of April 30, 1975, showing a balance as of July 1, 1974 of \$859.39, total receipts of \$72,724.14, total expenditures of \$69,989.88, leaving a cash balance of \$3,593.65.

SUPERINTENDENT'S REPORT:

Mr. Fowler presented and read the following report:

"The Nutley Junior Olympics was held in the Park Oval on May 16, 1975 before an enthusiastic audience of fifth and sixth grade students. For the third consecutive year the young athletes from Lincoln School left the field as the winning team. The team scores were as follows:

"The National Honor Society induction ceremony for juniors was held in the high school auditorium on the evening of May 6, 1975.

"The parents of the Music Boosters Association are to be commended for the excellent work they did in the preparation of an itinerary for the Nutley High School Cadet Band trip to Canada. We have received nothing but favorable reactions to this trip.

"Students of Nutley High School have forwarded letters of appreciation to officials of Hoffmann-La Roche for allowing them to participate in a seminar related to 'Chemical and Biological Testing.'

"The varied posters on display throughout the community are indicative of the interest that has been stimulated in the program, 'Pride in Nutley'. All committee members are hopeful that this initial impact will have a lasting effect.

"Recently 344 New Jersey high school students were selected to try out for the All State Chorus. Nutley High School students Laura Liloia, grade 10 and Lisa Zorn, grade 11, were among those selected to participate with this honored group.

"On Thursday, May 29, 1975 at 2:00 p.m. in the auditorium, 23 seventh graders and 20 eighth graders will be inducted into the National Junior Honor Society, Franklin School Chapter. This is the first induction for seventh graders. This induction will bring the eighth grade total up to 86 members.

"On Thursday, June 12, 1975, at 8:00 p.m. the Franklin School P. T. A. meeting will include a fashion show presented by the eighth grade girls in the school auditorium and an Industrial and Fine Arts exhibit in the gymnasium.

"The high school and Franklin School Mathematics Departments are to be commended for their excellent showing in Essex County Mathematics Competition. Seven schools sent 180 students to participate in the varied areas of competition. Paul Callaghan, a Nutley High School junior, gained the highest score of all participants in the Geometry competition. Alan Giambattista led his Franklin School team to a first place finish in the Algebra team competition. Alan also received first prize in the individual competition. Nutley's team efforts in the Geometry competition gained for them a second place finish.

"On May 15, Nutley High School Drama Club, under the direction of Mrs. Thomasina Hyland, participated in the annual Bucks County Playhouse drama competition for secondary schools. The day's events included the presentation of ten high school productions. Nutley's Drama Club performed four selections from 'Story Theatre.' Two of the cast, Sharon Humiston and Gina Bochicchio, were commended for their performance.

"Last week we were notified that Jeff DeBarbieri was selected as a member of the All Area All Star Baseball Team. This is a special tribute to one of Nutley's fine young athletes.

"The annual Activities Awards Assembly for seniors will be held on the morning of May 28th. The Scholastic Awards Assembly for seniors will be held on the morning of June 4, 1975.

"As the school year comes to a close students in all schools are busily engaged with the professional staff in planning programs that will be informative and entertaining for parents.

"The six week Summer School session for grades 7 - 12 is scheduled for June 25 to August 5, 1975. The Summer Enrichment Program will be held at Yantacaw School starting on June 30th and ending on July 25, 1975.

"By law, we are required to keep schools open for 180 days. As a result of our last year's mandated closing in compliance with the energy crisis; this year we overscheduled four days bringing the total up to 184 days. Inasmuch as we did not have to use any of these four days the schools will officially close at noon on Friday, June 20th. In-Service programs for teachers will be scheduled on June 23rd and 24th will be a half day for teachers."

HEARING OF CITIZENS:

Mr. Ernest Della Penna, 197 Satterthwaite Avenue, asked to what age the Board maintains youngsters in the Special Education Program under the Beadleston Act, to which Mrs. Jaworek replied that youngsters who are twenty years of age, and those who reach the age of twenty during the school year, are maintained until the end of the school year.

Mr. Della Penna questioned whether the Orphanage on Washington Avenue had been purchased as a school or as a workshop. Mrs. Popadick replied that it was purchased for a school.

Mr. Della Penna commented that with regard to the safety of school buses, there were no safety belts on the buses, no attendants, buses were not equipped with flashing lights, and there were no signs on the buses indicating they are school buses. Mr. Ramsland replied that with the single exception of our athletic bus, none of our vehicles come under the "school bus" classification as established by the State Department of Education. Vehicles with a capacity under 17 are Type II vans or station wagons and are prohibited by law from using flashing lights, the yellow color, or the designation "school bus". However, he commented the Board does have "Board of Education" printed on the vans and that the Board does employ one attendant for a school van but that this was because of the nature of the children involved who were being transported.

Mr. J. S. Fasano, 11 DeVausney Place, commented that many times the bus had come to pick up his son and that the van which picked his son up was marked on the sides, but not on the rear. He felt that there should be some type of marking on the buses since all Town vehicles were clearly marked. He also stated that many times it was

necessary for his son to run into the street to board the bus on the opposite side. Mr. Perez suggested that possibly some wording could be printed on the van and also suggested that the driver should pull up close to the curb in order to pick up passengers. Mr. Ramsland indicated that he would investigate the items mentioned.

Mrs. D. Rubino commented that at the recent function of the Junior Olympics the children were allowed an additional 20 minutes for lunch, and when they returned to school there were no crossing guards, and she suggested that it would be a good idea next year to let the Police Department know in order that the guards would be available.


