# ADOPTION OF TENTATIVE BUDGET:

Mr. Tangorra presented and moved the adoption of the following resolution, seconded by Mrs. Popadick. Upon being put to a roll call vote the resolution was adopted with Mrs. Jaworek, Mr. Clayton, Mr. Lindstrom, Mr. Perez, Mrs. Popadick, Mrs. Rabinowitz, Mr. Tangorra and Mr. Williams voting aye. Mr. Restaino abstained.

WHEREAS, N.J.S.A. 18A:22-7 as amended by Chapter 191, PL 1974 requires the preparation on or before February 11, 1976 of a school budget for the ensuing year,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education hereby adopts a tentative budget for the 1976-1977 school year in the total amount of \$8,588,548, and

BE IT FURTHER RESOLVED, That the Secretary be authorized to submit this budget to the County Superintendent for his examination to determine that all the information submitted therein is verifiable from records on file in his office and is consistent with such records, and

BE IT FURTHER RESOLVED, That upon receiving the approval of the County Superintendent the Secretary is authorized to publish the 1976-1977 Budget in THE NUTLEY SUN.

WHEREAS it is of utmost importance that both the public and the Board of Education are fully aware of both the privileges and restraints placed upon all concerned.

NOW, THEREFORE, BE IT RESOLVED, That the Nutley Board of Education adopts the following guidelines for implementation of the 'Open Public Meetings Act', sometimes referred to as the "Sunshine Law'."
