Board of Education Nutley, New Jersey

The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, April 25, 1977, at 8:00 p.m., with Mr. Walter Lindstrom, President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Rusignuolo leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

ANNOUNCEMENT OF ADEQUATE NOTICE:

Mr. Lindstrom read the following notice:

ROLL CALL:

The other members present at roll call were: Mrs. Roy Imhoff, Mr. Carl Perez, Mrs. Bernard Rabinowitz, Mr. Gerard T. Restaino, Mr. Robert Rusignuolo, Mr. Frank V. Tangorra, Mrs. John Wightman, and Mr. Louis F. Williams. Approximately 25 citizens were present.

MINUTES:

Copies of the minutes of the Special Meeting held on April 4, 1977, at 7:30 p.m., being in the hands of each member, reading of same was dispensed. Mr. Tangorra moved that the minutes be approved, seconded by Mrs. Wightman, and unanimously approved by the Board.

Copies of the minutes of the Regular Meeting held on April 4, 1977, at 8:30 p.m., being in the hands of each member, reading of same was dispensed. Mrs. Wightman moved that the minutes be approved, seconded by Mr. Perez, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented the following communications:

1. A letter from Mrs. Eunice P. Drake, Town Clerk:

"Enclosed is your copy of the Certificate of Local District School Requirements for the School District of the Town of Nutley, in the County of Essex, N.J., complete with a certified copy of the Resolution which was adopted by the Board of Commissioners at a meeting on April 13, 1977, showing the Local District School Tax Levy for the Calendar Year 1977 to be \$7,635,020.50.

"The certificate was mailed today, by certified mail, to Mr. George E. McCormack, Secretary of the Essex County Board of Taxation."

2. A Resolution from the Board of Commissioners, Town of Nutley, New Jersey:

"WHEREAS, the Annual School Election held March 29, 1977, in the Town of Nutley, resulted in the defeat of the proposed 'Current Expense' Budget of \$7,244,206; and

"WHEREAS, The Board of Commissioners of the Town of Nutley, having met in consultation with the Board of Education, in conformity with the requirements of N. J. S. 18A:22-37, supplemented by Chapter 267 of the Laws of 1975, on the evenings of Monday, April 4, and Monday, April 11, 1977:

"NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Town of Nutley, in the County of Essex, New Jersey, that the 'Current Expense' Budget be revised in the following manner for the fiscal year 1977-1978

3. A copy of the Certificate of Local District School Requirements for School District of Town of Nutley in the County of Essex, New Jersey received from Mrs. Eunice P. Drake, Town Clerk:

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report;

"It is indeed unfortunate that a situation growing out of unfamiliarity with, and lack of understanding of, school district financial reports seems to have erupted into a 'tempest in a teapot'. The accuracy of a detailed analysis of the surplus account has been questioned. My only reason for making mention of it in this report is to read into the record my unequivocal statement that the report I furnished to that meeting is absolutely accurate.

"In a footnote on that report, I clearly indicated that the existing surplus figure would be increased by whatever surplus would be generated from the current budget. This figure, of course, cannot be determined until the fiscal year is ended on June 30, 1977; however, some preliminary estimates can be made, and these estimates have now been made, and will be submitted to the Board this evening.

"Two of our drivers will be competing in the Sixth Annual School Bus Drivers' Safety Competition to be conducted in Randolph Township on Saturday, May 21, 1977. The purpose of the competition is to foster

bus safety practices by making drivers aware of the skills required to transport students safely. The competition is designed to sharpen these skills through drivers competing against each other. Our drivers who have been entered in the competition are Claire Redmond and Robert Nichols.

FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of March 31, 1977, showing total funds available of \$9,515,169.89, contractual orders to date of \$8,513,738.33, leaving a balance of funds available of \$1,001,431.56.

SUPERINTENDENT'S REPORT:

Mr. Fowler presented and read the following report:

"The kindergarten enrollment as of April 14, 1977 is as follows:

Spring Garden - 47

Total - 219

"Elementary teachers will participate in an in-service orientation program for the implementation of our new Safety Education Curriculum at 2:30 p.m. on May 2, 1977. This will necessitate an early dismissal. Parents and police will be notified of this change in schedule.

"We have received the results of the Metropolitan Achievement Tests administered to Nutley's fourth and sixth grade students. The results indicate that the median Nutley student is achieving above grade level in all areas of the test.

"During the month of March special recognition was given to the Nutley High School students listed below:

"The Maroon and Gray won second place in national competition at the Columbia Scholastic Press Association Conference held March 16, 17, 1977.

"The Nutley High School math team came in third place in competition sponsored by Montclair State College with 30 schools being represented on March 12, 1977. The students who participated were sophomores Robert Lombardi, Richard Keseling and Alan Giambattista.

"Adelina Lupinacci, freshman at Nutley High School, won first place March 31, 1977, in an Italian Club poetry contest at Montclair State College.

"On April 11th Dr. Edward Fry, Rutgers University, gave a verbal presentation of his evaluation concerning Nutley's reading program. Generally speaking, his report was most positive. Persons wishing to see this report may do so by contacting the Superintendent's Office.

"The Nutley Junior Olympics will be held on the morning of May 19th at the Park Oval. The rain date is scheduled for May 20th. Fifth and sixth grade students of all elementary schools participate in these events.

"Nutley's annual Junior Patrol picnic will be held at Booth Park on June 1st. Traditionally, the Nutley Elks have been responsible for the sponsorship of this program. We would like to thank the Elks for all they have done for the youth of this community.

"The annual vision survey conducted by the Nutley Lions Club has just been completed. Once again, we would like to thank the members of this organization for the service they provide to those students involved in this program."

CAFETERIA REPORT:

Mr. Restaino presented the cafeteria report for March 31, 1977, showing a cash balance as of July 1, 1976 of \$1,747.46, total receipts of \$153,734.29, total disbursements of \$128,173.28, leaving a balance of \$27,308.47. Total "A" lunch - 25,265. Total milk sold - 24,360. Free lunches - 4,073. Reduced price lunches - 1,325. School days - 23.
