Board of Education Nutley, New Jersey September 6, 1977

A Special Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Tuesday, September 6, 1977, at 7:30 p.m., with Mr. Walter Lindstrom, President, presiding.

FLAG SALUTE:

The meeting was opened with Mrs. Rabinowitz leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

ANNOUNCEMENT OF ADEQUATE NOTICE:

Mr. Lindstrom read the following notice:

"As required by the 'Open Public Meetings Act' (Chapter 231, P. L. 1975), notice of this meeting was provided to the public and the press at least 48 hours in advance by:

- "1. Posting at the entrance of the Board offices.
- "2. Mailed or delivered to The Nutley Sun, the Newark-Star Ledger, and the Passaic Herald-News, and
- "3. Delivered to the Nutley Town Clerk."

ROLL CALL:

The other members present at roll call were: Mrs. Roy Imhoff, Mr. Carl Perez, Mrs. Bernard Rabinowitz, Mr. Gerard T. Restaino, Mr. Robert Rusignuolo, Mr. Frank V. Tangorra, Mrs. John Wightman, and Mr. Louis F. Williams. Approximately 15 citizens were present.

NOTICE OF PURPOSE OF MEETING:

Mr. Lindstrom read the following notice:

"The agenda for the special meeting of the Board of Education of the Town of Nutley, which was previously posted to be held on Tuesday, September 6, 1977 at 7:30 p.m. in the Board Conference Room, 149 Chestnut Street will also include the possible ratification of the teachers contract along with appointments and pending business prior to the opening of the school year."

MINUTES:

Copies of the minutes of the Regular Meeting held on June 27, 1977, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mr. Tangorra moved that the minutes be approved, seconded by Mr. Perez, and unanimously approved by the Board.

SUPERINTENDENT'S REPORT:

Mr. Fowler presented and read the following report:

"As we prepare for the opening of the 1977 school year it is good to be able to say that the negotiations teams for the N.T.A. and Board of Education have arrived at a two year contract agreement. It would be unfair to say that all concerned are happy with the settlement, but that is the way of negotiations. At best, it can be described as a compromise between both parties. It is rare that either party gains claim to all of its demands.

"Reflecting back upon the process which brought about the settlement, one cannot help but give praise to both parties; the N.T.A. for their presentation of realistic demands and the Board of Education for their sincere approach to doing what is best for the total community. Mr. Walter Lindstrom and Mr. Louis Williams, Board members, are to be commended for their leadership role in bringing about a settlement.

"It is my sincere opinion that the settlement will be one of the best in the county. Nutley's teachers will not be at the top of the competition, nor will they be at the bottom. Hopefully, when all of the settlements are completed, our guide will retain the professional salaries in a competitive position. Nutley's teachers should continue to be paid what their counterparts in other surrounding districts receive. In the last analysis, an educational program is only as good as the teachers servicing the children of a community. Nutley has an excellent staff and every effort should be made to continue this high degree of excellence.

"I would be remiss if I did not pay special tribute to the professional staff for their behavior during the difficult period of negotiations. Throughout the year as I moved from building to building, it was evident that all staff members were committed to a program of excellence.

"This was the first year in the history of negotiations that Nutley's schools closed without contractual arrangements with teachers being closed. This in itself can cause a great deal of uncertainty for those concerned. Once again, the behavior of the staff exemplified the highest type of professionalism.

"A special committee made up of Mr. Karekin Bakalian, Mrs. Rosemary Vivinetto and Mr. Max Kletter completed a course of study in the area of mathematics, K-12. Mr. Kletter, chairman of this committee, will be present at a future board meeting to discuss the work of this committee.

"We, on the professional staff, are looking forward to the opening of school with a great deal of enthusiasm. I can assure you that every attempt will be made to continue providing quality educational programs for all the children of this community."

REQUESTS FOR USE OF SCHOOL BUILDINGS & GROUNDS:

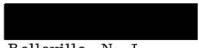

WHEREAS, the provisions of Chapter 212, Thorough and Efficient, Public Education Act of 1975, N.J.A.C. 6:8.3.8 are applicable to the Town of Nutley, and

WHEREAS, the State Compensatory Education Program meets the provisions and intent of this legislation,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education approve the program known as State Compensatory Education, and

BE IT FURTHER RESOLVED, That the Superintendent of Schools be authorized to prepare the necessary forms to be submitted to the State Department of Education for approval, and

BE IT FURTHER RESOLVED, That the Superintendent of Schools be authorized to make the necessary arrangements for the implementation of the State Compensatory Education Program upon receiving approval from the State Department,

BE IT FURTHER RESOLVED, That such placements shall be reported to the Board of Education at its next succeeding meeting.

AGREEMENT BETWEEN THE NUTLEY BOARD OF EDUCATION AND THE NUTLEY TEACHERS' ASSOCIATION:

Mr. Williams presented and moved the adoption of the following resolution, seconded by Mrs. Wightman. Upon being put to a roll call vote the resolution was adopted with Mr. Lindstrom, Mrs. Imhoff, Mrs. Rabinowitz, Mr. Tangorra, Mrs. Wightman, and Mr. Williams voting aye and Mr. Perez, Mr. Restaino and Mr. Rusignuolo voting nay.

WHEREAS, the Nutley Board of Education and the Nutley Teachers' Association recognize and declare that providing a quality education for the children of the Nutley School District is their mutual aim and that the character of such education depends predominantly upon the quality and morale of the teaching service, and

WHEREAS, the members of the teaching profession are particularly qualified to advise the formulation of policies and programs designed to improve educational standards, and

WHEREAS, the Board has an obligation, pursuant to Chapter 123, Public Laws of 1974, to negotiate with the Association as the representative of employees hereinafter designated with respect to the terms and conditions of employment, and

WHEREAS, the parties have reached a two year salary settlement which calls for a 6.2% increase plus longevity equal to \$225 after 20 years of service (see attached guide) and in the second year the agreement calls for a 6.5% increase over the 1977-1978 year plus longevity equal to \$175 after 25 years of service (guide to be developed).

WHEREAS, the parties have agreed that it is important that all parents have an opportunity to meet with teachers on a designated school day between the hours 1:00 p.m. through 5:30 p.m.

NOW, THEREFORE, BE IT RESOLVED, That the Nutley Board of Education hereby approves the Salary Agreement between the Nutley Board of Education and the Nutley Teachers' Association, effective July 1, 1977 through June 30, 1979.

BE IT FURTHER RESOLVED, That the Nutley Board of Education also approves the closing of school for one day between the hours of 1:00 p.m. through 5:30 p.m. for the purpose of conducting teacherparent conferences.

BE IT FURTHER RESOLVED, That the Board of Education authorizes the Superintendent of Schools to establish a date for the accomplishment of these conferences.

Prior to the roll call vote, Mr. Restaino, Mr. Rusignuolo and Mr. Williams read statements with regard to the above resolution.

MEMORIAL - Mrs. Ruth M. Ball:

Mr. Williams presented and moved the adoption of the following resolution, seconded by Mr. Rusignuolo, and unanimously approved by the Board:

WHEREAS, it is with a sense of sorrow and regret that the Board of Education of the Town of Nutley records the death of Mrs. Ruth M. Ball on July 29, 1977, and

WHEREAS, Mrs. Ball had a distinguished educational career spanning twenty-two years in the Nutley Public Schools serving the youth of Nutley, and

WHEREAS, it was as an educator and friend that she was held in high esteem by all who knew her,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education of the Town of Nutley expresses its feeling of loss and extends its heartfelt sympathy to her family, and

BE IT FURTHER RESOLVED, That this resolution be made a part of the minutes of this meeting and a copy sent to the members of her family.

Mrs. Wightman suggested that since there has been several articles in the newspapers with regard to the drop in enrollment, it would be well to point out the decrease in the number of teachers rehired.
