Board of Education Nutley, New Jersey

The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, September 26, 1977, at 8:00 p.m., with Mr. Walter Lindstrom, President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Tangorra leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

ANNOUNCEMENT OF ADEQUATE NOTICE:

ROLL CALL:

MINUTES:

Copies of the minutes of the Special Meeting held on September 6, 1977, at 7:30 p.m., being in the hands of each member, reading of same was dispensed. Mr. Rusignuolo moved that the minutes be approved, seconded by Mr. Perez, and unanimously approved by the Board.

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"Another school year is now well under way, and, with few exceptions, everything seems to be going well.

"Mr. Louis Phillips, who has been serving as custodian in Franklin School, is cashing in his 30 years worth of pension deductions on October 1. We wish him good health and happy days in his retirement.

"An in-service training program for custodians was conducted during this past summer on the mornings of July 6 and 7. A number of topics in the area of housekeeping and sanitation were covered during these informative sessions.

"Much work was done in the schools and on the grounds during the past summer, both by outside contractors and by our own custodial, maintenance, and grounds crews. Among the jobs which were awarded under bids by outside contractors were the painting of Spring Garden and Franklin Schools, repair of the Park Oval bleachers, concrete and blacktop paving at various schools, installation of a new clock & program system at Lincoln School, renovation of the air conditioning systems at the high school, renovation and/or replacement of the kitchen range hoods at the high school, Franklin, Lincoln, and Washington Schools, and repair and resurfacing of the tennis courts at Margaret Avenue-DeMuro Park.

"Among the work done by our own maintenance crew was the preparation of Spring Garden and Franklin Schools for painting, which included repairs to ceilings, walls, floors, and trim. Two new exhaust fans were also installed at the Franklin School shops, and a new hot water heater was installed at the Franklin cafeteria.

Also, re-arrangement of kitchen facilities was made necessary in connection with the renovation of the range hoods. At Washington School, four kindergarten and primary grade toilet rooms were remodeled, and rusted steam pipes under the gym floor were replaced, eliminating a particularly troublesome problem.

"Our custodial department put all our buildings in A-1 shape. Our maintenance department replaced 47 windows, performed 23 other items of carpenter repairs and 42 items of plumbing and heating repairs. Our grounds crew worked incessantly at cleaning, repairing, fertilizing and cutting fast-growing lawns and shrubbery, and also did a truly professional job of rebuilding the baseball field and rejuvenating the whole Park Oval.

FINANCIAL REPORTS:

Mr. Ramsland presented the financial report for the 1976-1977 school year showing total funds available of \$9,577,126.39, contractual orders to date of \$8,589,173.64, leaving a balance of funds available of \$987,952.75.

Mr. Ramsland presented the financial report as of August 31, 1977 showing total funds available of \$10,016,427.56, contractual orders to date of \$1,865,779.82, leaving a balance of funds available of \$8,150,647.74.

Mr. Ramsland presented the athletic financial report for the 1976-1977 school year showing a cash balance as of July 1, 1976 of \$91.73, total receipts of \$117,882.67, total disbursements of \$117,813.54, leaving a cash balance as of June 30, 1977 of \$69.13.

Mr. Ramsland presented the Training Center Special Projects Account financial report for the 1976-1977 school year showing a balance as of July 1, 1976 of \$3,954.42, total receipts of \$9,510.51, total disbursements of \$7,823.47, leaving a cash balance as of June 30, 1977 of \$5,641.46.

SUPERINT ENDENT'S REPORT:

Mr. Fowler presented and read the following report:

"When walking through our public schools it becomes evident that teachers and administrators have spent a great deal of time and effort in providing a good learning environment for Nutley students. One cannot help but feel that much time has been spent in organizing for instruction.

"The custodial staff of all schools are to be commended for the excellent job they did in preparing our schools for the students' return.

"Enrollment statistics at the conclusion of the second week of school are as follows:

"Once again, these figures indicate that Nutley's enrollment continues to decline. It is important that the total community support the work of the Planning Committee when they bring forth their recommendations to the Board of Education.

"Building principals, in cooperation with their staffs, are preparing for National Education Week. The established dates are November 13 through 19. We extend an invitation to all citizens to visit our schools during this period of time.

"State Compensatory and E.S.E.A. Title I programs are being implemented in all of our school buildings. The money for State Compensatory programs comes from the state. Title I is a federally funded program. Both programs are servicing students in need of remediation.

"Mr. Louis Zwirek, principal of Nutley High School, has been informed by the Department of Educational Services of the National Merit Scholarship Program that the following Nutley High School seniors have been designated as commended students or semi-finalists.
