Board of Education Nutley, New Jersey May 22, 1978

The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, May 22, 1978, at 8:00 p.m., with Mr. Louis F. Williams, President, presiding.

FLAG SALUTE:

The meeting was opened with Mrs. Imhoff leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

COMMUNICATIONS:

Mr. Ramsland presented the following communications:

1. A letter from James H. Wallwork, New Jersey State Senate:

"Thank you for your recent letter concerning proposed changes for the state funding of the Public School System.

"The information that you have provided and the suggestion that family income be taken into consideration are certainly sound recommendations for a state aid program. I would encourage the School Board Association to do a study in this area and present their recommendations to the Legislature.

"I was pleased to hear from you and hope you will contact me whenever I can be of service."

- A petition from 217 Nutley High School students with regard to school activities which have been cancelled due to the teachers' job action and requesting that the Board solve the dilemma in order that many functions can be carried on as in the past.
- A letter from Joseph F. Cappello, Chief, Office of State Compliance, Division of School Programs, replying to a letter sent by the Nutley Board of Education with regard to local districts assuming financial responsibility for residential costs related to educational programs for handicapped pupils.

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"The report to the Governor and the Legislature of the Task Force on Business Efficiency of the Public Schools has been released. I am sure that much thought was given to the problems identified and the recommendations offered, and these deserve serious consideration by every local Board of Education. I have condensed some of my thoughts into a memo which I distributed to you last week.

"In passing, I might observe that the State government might be an interesting area for further study. While fully recognizing that newspaper articles sometimes contain more or less than 'The truth, the whole truth, and nothing but the truth', this morning's Star-Ledger article, indicating that the number of N.J. State government employees has increased from some 63,000 to over 78,000 since 1974, an increase of 24%, is somewhat disturbing.

"The music concert last Friday night at the Nutley High School deserves more than just passing notice. It was excellent. But then it usually is. We are proud of our kids who have accomplished so much and performed so well. I would also like to publicly recognize the dedication of the music staff and the professionalism which they chose to display rather than espouse. Actions truly speak louder than words.

"Everyone seems happy that Spring is here. Or almost everyone. Every Spring brings renewed window-breaking activity, and this has been no exception. Sixty three windows were replaced during the past month. Other items of carpentry repairs totalled 13, and plumbing/heating repairs and replacements amounted to 31 separate jobs.

FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of April 30, 1978 showing total funds available of \$9,975,816.18, contractual orders to date of \$9,007,764.63, leaving a balance of funds available of \$968,051.55.

SUPERINTENDENT'S REPORT:

Mr. Fowler presented and read the following report:

"The Nutley High School Industrial and Fine Arts Program was held on May 18th and 19th. This year parents and students were afforded the opportunity of seeing projects being completed on site.

"We have received verbal notification from the Essex County Superintendent's Office that Nutley's program for trainable children will be retained in its present form (ages 5 to 20). Twenty of the younger children will be located at Radcliffe School and the remainder will be housed at Lincoln School.

"The National Honor Society induction for juniors was held on May 17th in the high school auditorium.

"Inclement weather made it necessary to cancel the Junior Olympics for fifth and sixth grade children. This program has been rescheduled for the morning of May 26th.

"On the afternoon of May 24th all sixth grade teachers and students will spend the afternoon at Franklin School. This is an attempt to provide teachers and students the opportunity to meet with the faculty of Franklin School.

"Through the cooperation of the Nutley Chapter of the American Red Cross and the high school administration we will be able to offer a pilot program for ninth grade students in the area of cardiopulmonary resuscitation (CPR). The Red Cross provided the training for those teachers who will teach this course.

"We would like to take this opportunity to thank Mr. DeGregorio for his unselfish sacrifice of time while providing CPR instruction to the central office staff.

"Early in September Dr. Fred Streit and Dr. Elliot Spack will offer a course to some of our teachers titled 'Interpretation of Test Results.'

"A comparison of kindergarten enrollment for the 1977/1978 - 1978/1979 school years is as follows:

"This shows a decline of 35 for comparable dates and further emphasizes the need for a constant update on enrollment trends.

Questions were asked concerning the use and sale of the Special Education building. There was a lengthy discussion with regard to closing the Special Education Center, the placement of the students and the placement of the Child Study Team.

Mr. Perez questioned the schedule of rental fees for the use of school property with regard to use by the Town of Nutley. Mr. Williams said that this would be discussed at a conference meeting in the near future.

Mr. Walter Schaffer asked various questions concerning the appointment of the new Superintendent, Dr. Fadule.
