A Special Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Friday, April 27, 1979, at 7:30 p.m., with Mr. Louis F. Williams, President, presiding.

FLAG SALUTE:

The meeting was opened with Mrs. Wightman leading the Board members in the Pledge of Allegiance to the American Flag.

ANNOUNCEMENT OF ADEQUATE NOTICE:

Mr. Williams read the following notice:

"As required by the 'Open Public Meetings Act' (Chapter 231, P.L. 1975), notice of this meeting was provided to the public and the press at least 48 hours in advance by:

ANNOUNCEMENT OF PURPOSE OF MEETING:

Mr. Williams read the following notice:

"Notice is hereby given that a Special Meeting of the Board of Education will be held on Friday, April 27, 1979, at 7:30 p.m. in the Board Conference Room, 149 Chestnut Street, Nutley, New Jersey.

"The purpose of this meeting is to authorize the Secretary of the Board to notify certain non-tenure teachers that their contracts will not be renewed for 1979-80, and to transact any other business which may properly come before the Board.

"A portion of this meeting will be closed to the public to discuss the personnel involved, but the resolution will be acted upon in open session."

RESOLUTION TO CLOSE MEETING TO THE PUBLIC:

Mr. Williams read the following:

"WHEREAS, the remaining items on tonight's agenda concern personnel, an area exempt from public discussion,

"THEREFORE, BE IT RESOLVED, That the remainder of this meeting be closed to the public, and

"BE IT FURTHER RESOLVED, That the results of the discussions be made public by inclusion on the agenda of the Special Meeting following the conclusion of this discussion."
