Board of Education Nutley, New Jersey

September 24, 1979

The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, September 24, 1979, at 8:00 p.m., with Mr. Louis F. Williams, President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Tangorra leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

ROLL CALL:

The other members present at roll call were: Mrs. Roy Imhoff, Mr. Walter S. Lindstrom, Mr. James Murray, Mrs. Bernard Rabinowitz, Mr. Gerard T. Restaino, Mr. Frank V. Tangorra, and Mrs. John Wightman. Absent and excused: Mr. Carl Perez. Twelve citizens were present.

MINUTES:

Copies of the minutes of the Regular Meeting held on August 27, 1979, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mr. Lindstrom moved that the minutes be approved, seconded by Mr. Tangorra, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

1. A letter from a teacher in the Nutley School System:

"While many teachers and staff members may find the proposed salary guides acceptable, they are so patently unfair to those in career service that I must ask the Board to reject it until such time as it can be altered. Although the majority of those in the Nutley Teachers Association has approved the package, please consider these inequities which apply at the bachelor's maximum step:

1. Last year our raise was 3.2%.

- 2. This year the raise is 5% and next year it will be 4%. These figures are obviously lower than shorter term teachers and lower than the public believes to be true.
- 3. A teacher one step behind me will \$600 more than I this year. What a sad penalty one must accept for reaching maximum during inflationary times. What good is it to be theoretically best?
- 4. While firemen, policemen and town workers receive 13% for these two years, those of us at the top of a column representing one fourth of all the teachers will receive 9% during the same two years. Publicity in the press and on TV does not reflect the plight of top teachers.
- 5. Some of our employees can attain longevity in half the time that a teacher can.

"Thank you for your consideration of a more equitable guide not only in relation to all town workers versus career teachers but also in annual steps between new teachers and a career guide in these times when all of us must buy gasoline, food and shoes. Such changes prior to adoption for three long years will demonstrate the Board's efforts in fair play and will favorably affect the morale factor for those of us who are career oriented."

2. A thank you note from Louis F. Williams, President, Nutley Board of Education, with regard to his recent hospitalization.

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"The most ambitious program of replacement of classroom unit ventilators by our own maintenance staff which we have ever undertaken in one summer is in its final stage. This completes the modernization of the heating units at Lincoln School, although some work on controls and allied equipment, which was not a part of this project, is yet to be done. Also, the cabinets have not yet been delivered. After the third postponement of delivery dates, the latest is September 28.

"The Senate Education Committee held hearings on budget caps on September 11 and 18. I discussed these with Ted Reid, Deputy Executive Director of the New Jersey School Boards Association, and he feels that a good case was made for some attention by the Legislature. He is hopeful that the Committee will recommend some modification of the cap law to

alleviate the impossible situation in which some districts find themselves, and in which we can expect to be found by next year, or at the very latest, the year after.

"The count on window replacement for the past month stands at 34. In addition to completing the heating system renovation at Lincoln School, eight other plumbing repairs were taken care of and 15 items of carpentry and general maintenance were accomplished.

"The playground at Spring Garden School was completely renovated. The two softball diamonds were resurfaced with clay, and the rest of the area was plowed up, graded, enriched with topsoil and fertilizer, and seeded. The area was then fenced off and will remain closed until next summer. Thus given a chance to develop, the turf should be strong enough by next September to withstand the use to which this field is put, and thereby we will have eliminated one problem that has seemed insoluble for many years.

Mr. Restaino commented that he had read in the newspaper that the County Superintendent of Schools planned to have an outing for administrators and that he had previously discussed this at a conference session. He further stated that he was completely against any of the Nutley administrators attending. Mrs. Wightman also agreed with this but stated that no administrator had expressed any interest in attending. Mr. Williams stated that a response would be compiled by Mr. Ramsland to be sent to the Essex County Superintendent of Schools.

HEARING OF CITIZENS:

Mrs. Joan Rubino, 48 North Road, asked when the non-public students were going to be able to participate in the CAT program conducted in the Nutley schools, to which Dr. Fadule replied that he would like to receive letters from each parochial school, and after Miss Barbara Hirsch contacts the various parochial schools, he would be prepared to discuss this program for parochial schools with the Board members.

Mr. Donald Heerwig, 148 Lakeside Drive, asked whom he should go to as far as Board policy is concerned with regard to students having to purchase and carry individual spiral binders for several classes. Dr. Fadule informed Mr. Heerwig that the correct procedure would be to go to the principal. Mr. Williams commented that the Board did not and would not establish a policy to govern supplies to be used in the classroom.

Mr. Richard Griese, 16 Edgar Place, asked if the athletic program in Nutley came under the guidelines of T & E, to which Mr. Williams replied. Mr. Griese then proceeded to ask various and sundry questions with regard to the no-cut policy to which Mr. Williams, Mr. Restaino and Mrs. Rabinowitz replied.

Mrs. John Conway, 10 Paterson Avenue, commented that much of the problems with the youngsters was caused because they do not feel that they have been given a fair deal. She also commented that a strict policy should be adopted by the Board as to where and when the band could appear, to which Mrs. Rabinowitz replied that the Board had a policy which specifically spelled out where the band could go. Mrs. Conway said that for the last five years she has complained that there was no place on the report card which indicated just what score A, B, C, D represented, and also that she has made many requests that a grade be given for citizenship.
