Board of Education Nutley, New Jersey

A Special Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, May 19, 1980, at 7:30 p.m., in order that the present Board of Education may complete pending business prior to the organization of the new Board. Mr. Louis F. Williams, President, presided.

FLAG SALUTE:

The meeting was opened with Mr. Murray leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

ROLL CALL:

The other members present at roll call were: Mrs. Roy Imhoff, Mr. Walter S. Lindstrom, Mr. James Murray, Mr. Carl Perez, Mrs. Bernard Rabinowitz, Mr. Gerard T. Restaino, Mr. Frank V. Tangorra, and Mrs. John Wightman. Approximately 50 citizens were present.

MINUTES:

Copies of the minutes of the Regular Meeting held on April 28, 1980, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mr. Murray moved that the minutes be approved, seconded by Mrs. Rabinowitz, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

A letter from Joseph V. Doria, Jr., Assemblyman:

"Thank you for your letter of opposition to the State mandated Family Life Education Program.

"I have already gone on record stating that I am opposed to the State Board of Education mandating a Family Life Education Program. In my opinion, the State Board of Education has extended its prerogatives too far.

"I am presently actively working in the Legislature to overturn the mandate of the State Board of Education in this area.

Mr. Ramsland presented and read the following report:

"The new policy books have been delivered. Board action to adopt these new and revised policies is on the agenda for tonight's meeting.

"All too soon the time has come to say goodby to Walt Lindstrom as a member and past president of the Board of Education. Walt's wise counsel and steadying influence will surely be missed. He has truly been a 'team' player, considering every decision in the light of what's best for the system as a whole, and the children in particular. I have been privileged to know him as a friend, as well as an employer. I hope, Walt, that you will continue your interest in Board affairs as a citizen, even if not as a member.

"Doug Eisenfelder officially joins the Board tonight. Because of the long time span between election and organization, Doug has enjoyed a bit of pre-marital participation, and his intense interest has been very evident. Welcome, Doug, you're stepping into big shoes.

"As the average daily temperature rises, so also does the average monthly window breakage. Our maintenance men replaced 17 windows last month. Thirteen other maintenance projects were completed, including the installation of cabinets at Lincoln School in connection with the univent replacement program.
