Board of Education Nutley, New Jersey June 23, 1980

The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, June 23, 1980, at 8:00 p.m., with Mr. Louis F. Williams, President, presiding.

### FLAG SALUTE:

The meeting was opened with Mr. Perez leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

## ROLL CALL:

The other members present at roll call were: Mr. Douglas Eisenfelder, Mrs. Jacqueline Imhoff, Mr. James Murray, Mr. Carl Perez, Mrs. Ann Rabinowitz, and Mr. Gerard T. Restaino. Absent and excused: Mr. Frank V. Tangorra and Mrs. Marilyn Wightman. Seven citizens were present.

## MINUTES:

Copies of the minutes of the Special Meeting held on May 19, 1980, at 7:30 p.m., being in the hands of each member, reading of same was dispensed. Mr. Murray moved that the minutes be approved, seconded by Mrs. Rabinowitz, and unanimously approved by the Board.

Copies of the minutes of the Regular Meeting held on May 19, 1980, at 8:50 p.m., being in the hands of each member, reading of same was dispensed. Mr. Murray moved that the minutes be approved, seconded by Mrs. Rabinowitz, and unanimously approved by the Board.

#### COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

1. A letter to Louis F. Williams, President, from Fred G. Burke, Commissioner of Education, State of New Jersey:

"The Governor has asked me to reply to your recent letter regarding Family Life Education.

"Dr. Block was chosen for this committee because of his expertise in this area. He has written on family life education since 1970 and is known nationally. In addition, he helped develop the program in current use in the Cherry Hill Public Schools.

"When Dr. Block was asked to become a member of the committee it was clearly understood that this would not mean that his materials were condoned or recommended by the State Department. The materials in question were designed for special education pupils and were not intended for general classroom use.

"Dr. Block was replaced on the committee because of the possibility that his membership could be interpreted as a conflict of interest. The State Board did not want districts to feel that a state curriculum was going to be mandated. The regulations give the responsibility of curriculum development, determination of topics to be taught, and the selection of materials to the local district. These tasks are to be achieved with the help of parents or guardians, members of the clergy, and representative members of the community. The processes necessary clearly have the intent of the T & E legislation.

"The programs that are developed locally will meet the needs of the district and the costs will be determined by these needs.

"Please thank the other members of your board for their interest in New Jersey education."

# 2. A letter from James H. Wallwork, State Senator, 25th District:

"Thank you for your recent letter concerning Senate Bill #750.

"Please advise the Board of Education that I voted against this bill when it was released from committee. I will not support a bill that undermines management prerogatives. Only legislation that would specifically spell out areas for voluntary bargaining should be considered by the Legislature. Not this type of broad brush legislation.

"I was pleased to hear from you."

## 3. A letter from Frank J. Dodd, State Senator, 26th District:

"Thank you for your recent correspondence expressing the concern regarding Senate Bill 750 and Assembly Bill 673 which would provide for three categories of negotiations in public sector collective bargaining.

"I share your conviction as to the importance of this issue. Please be assured that your views will receive careful consideration before I cast my vote on either bill.

"Again, thank you for taking the time to advise me of the Board's views, please feel free to contact me on future legislation."

## 4. A letter from Buddy Fortunato, Assemblyman, 27th District:

"Please extend to the members of the Board my thanks for their letter opposing S. 750. I appreciate having the views outlined therein, and will bear them in mind should the legislation come before the Assembly for consideration."

# 5. A letter from Dr. John A. Rocco, Assemblyman, District 6:

"I have recently read your letter urging my support of Assembly Bill 1368, which would stop the State Board of Education from mandating Family Life Curriculums. It has always been my belief as an educator and a legislator that a curriculum should not be mandated by the State or Federal Government. It should be a decision made by the local school boards and not some far removed bureaucrat. In addition, the mail I have received has been overwhelmingly in support of Assembly Bill 1368. I have therefore joined my colleague Assemblywoman Marie S. Muhler as a co-sponsor of Assembly Bill 1368.

"During the May 19, 1980 session of the General Assembly, Assemblywoman Muhler made a motion to move Assembly Bill 1368 out of the Education Committee to the floor. Unfortunately the motion was tabled and the bill is still in committee. Hopefully we will determine the status of the bill within a few weeks.

"In addition to A-1368, there is another bill that I have drafted that I would like you to consider supporting; that is Assembly Bill 1666. This bill would give the Assembly or Senate Education Committees the power to postpone the effective date of a mandate by the State Board of Education for forty-five days. This Legislative Veto could permanently stop unpopular mandates such as the Family Life/Sex Education Curriculums because it would not require the Governor's approval for it to be effective. The forty-five delay would not be used to deal with the everyday affairs of the State Board. I have enclosed a copy of this bill for your edification.

"It is always a pleasure to hear from the educational community on matters of importance to our children's education. I hope you will let me know what you think of A-1666 and any other matter of your concern."

6. A notice from the Essex County Educational Services Commission of a meeting to be held on July 1, 1980 at 7:30 p.m.

#### SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"Since I have attempted to keep the Board completely informed at our weekly meetings, there is little to report here besides the activities of our maintenance and grounds crews.

"The grounds crew has had a busy month. They set up the bleachers in the Oval, set up for two outside graduations, handled the equipment and feeding for the patrol picnic at Boys Park which was financed by the Elks Club, delivered and returned equipment for other picnics, and delivered and returned equipment for a variety of other school functions. All of this was in addition to trying to keep up with the grass cutting and grounds cleaning operations.

"The maintenance staff replaced 15 windows during the past month. They made and installed shelving in the high school, Franklin, Washington, and Radcliffe schools. They also completed ten other items of carpentry and general repairs, and 20 items of plumbing and heating repairs.

"You will note that we will have realized something over \$182,000 from interest on investments this year. This, however, will not be repeated next year. The current rate on 6 month Certificates of Deposit is 6%. The last time it was 6% was in the summer of 1977. From then until April 11, 1980, it rose steadily to 16.5%. From April 11 to May 30, in a period of seven weeks, the rate dropped from 16.5% to 6.0%, where it still is. Three month certificates, however, are still bringing 8%.

Dr. Fadule presented and read the following report:

"Attached is a copy of the student enrollment statistics as of May 31, 1980.

"The Superintendent attended and spoke at the eight promotion and commencement exercises.

"The Nutley Summer School began Monday, June 23rd. Mr. Alex Conrad is coordinating the program.

"The Summer Enrichment Program begins on July 7th with Mr. John Walker as Director. This year's program will be conducted at the Radcliffe School.

"Most of the summer will be spent on staffing concerns for the 1980-1981 school year."

### CAFETERIA REPORT:

Mrs. Rabinowitz presented the cafeteria report as of May 31, 1980, showing a cash balance as of July 1, 1979 of \$16,706.11, total receipts of \$248,856.69, total disbursements of \$231,958.36, leaving a balance of \$33,604.44. Total "A" lunch - 23,526. Total milk sold - 18,640. Free lunches - 3,751. Reduced price lunches - 984. School days - 21.

- 6. He/She will follow the Constitution Bylaws and policies of the Student Council. He/She will follow the policies of the Board of Education and of the school and be mandated by state and local laws.
- 7. Review Board business packet.
- 8. The representative or his delegate is in power to write columns to be put in the school/town paper.
- 9. Be it understood by the officer that he is to follow the chain of command of the administration of the High School."

Both Mr. Williams and Mrs. Rabinowitz thanked John for his interest and faithfulness in attending Board conferences. John commented that Sue Foote would be the Student Council representative next year.
