January 26, 1981

The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, January 26, 1981, at 8:55 p.m., with Mr. Louis F. Williams, President, presiding.

FLAG SALUTE:

The meeting was opened with Mrs. Imhoff leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

CALL OF ROLL:

The other members present at roll call were: Mr. Douglas Eisenfelder, Mrs. Jacqueline Imhoff, Mr. James Murray, Mr. Carl Perez, Mrs. Ann Rabinowitz, Mr. Gerard T. Restaino, and Mrs. Marilyn Wightman. Absent and excused: Mr. Frank V. Tangorra. Five citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on December 15, 1980, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mrs. Rabinowitz moved that the minutes be approved, seconded by Mrs. Wightman, and unanimously approved by the Board.

Copies of the minutes of the Special Meeting held on January 12, 1981, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mrs. Rabinowitz moved that the minutes be approved, seconded by Mrs. Wightman, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

1. A letter and resolution from the Trenton Board of Education:

"The Trenton Board of Education has been taken over by the State. Three judges in the Appellate Court have decreed that local control means nothing.

"The Trenton Board of Education is the only agency in the State of New Jersey that is fighting to maintain the right to local control and the right of the individual to vote his conscience without being forced to state reasons for doing so.

"We in Trenton are fighting not only to preserve our rights but yours as well. What has happened in Trenton can happen in any school district in the State of New Jersey.

"We have enclosed a resolution passed by the Trenton Board of Education at a public meeting on November 18, 1980. We ask your public support of this resolution.

"We also urge you to contact the New Jersey School Boards Association and your State legislators to ask for an explanation of this oppressive and undemocratic interpretation of the Thorough and Efficient law."

"WHEREAS, The Trenton Board of Education's budget has always been balanced and each fiscal year has ended with a surplus;

"WHEREAS, the Trenton Board of Education also closed the fiscal year 1979-80 with a balanced budget;

"WHEREAS, the test scores of the students in the Trenton School District have risen appreciably on both the California Achievement Test and the State Minimum Basic Skills Test;

"WHEREAS, some administrative deficiencies may have existed in program areas corrections have been made by the Board in these areas;

"WHEREAS, the Special Education Program is now in compliance and we believe is equal to or superior to most programs in the State;

"WHEREAS, the Bilingual Program has shown great improvement and we believe is equal to or superior to most programs in the State;

"WHEREAS, the Compensatory Education and Title I Programs have been developed into a Basic Skills Program as directed;

"WHEREAS, no guidelines or time lines have been established by the State Department of Education, the State Board of Education, the Commissioner of Education, the Monitor General or the Monitoring Team to acknowledge or recognize these positive events;

"WHEREAS, the Trenton Board of Education believes strongly in the philosophy of local control and has taken a stand to support the New Jersey School Boards Association resolution on local control;

"WHEREAS, the aforementioned goals have been achieved;

"WHEREAS, the presence of the State in Trenton costs the local taxpayer \$85,000 per year; and

"WHEREAS, the presence of the State in Trenton serves no purpose at this time except to further erode the principle of local control; therefore be it

"RESOLVED, that the State leave the Trenton District immediately and present an exit report to the Board not later than January 1, 1981."

2. A letter to Louis Williams from Mildred Barry Garvin, Assemblywoman - District 26:

"This is to acknowledge receipt of your Resolution dated November 24, 1980.

"Thank you for taking the time to forward this material to me. I have given it careful review and you can be assured of my support.

"I appreciate your sharing these comments and views with me."

3. A notice from the New Jersey School Boards Association with regard to the last date for submission of resolutions for consideration at the June 13, 1981 delegates' meeting being April 14, 1981.

#### SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

1. "The budgets and all accompanying statements and reports for last year and this year, and the proposed budget for next year, were delivered to the County Superintendent's office this afternoon. Our date for a budget review with the County Superintendent is March 2, 1981.

2. "The plans for the proposed addition to DeMuro fieldhouse have been reviewed in some five or six meetings with the Architect. He has been extremely cooperative in incorporating all valid suggested changes. He will now prepare the specifications, and we should be ready to put the project out for bid by the middle of February. The bidding agent will be the Town, since it is to be partially funded by Federal money.

3. "Mrs. Sally Goodson has asked me to announce to all prospective candidates for the coming Board of Education election that the Nutley Democratic Club will hold their candidates night at the Nutley Savings & Loan at 8:00 p.m. on March 25, 1981.

4. "Mr. Zwirek reported this morning that a fire was discovered in a waste basket in a first floor girls room at Nutley High School at 10:55 a.m. The extent of damage was the waste basket and scorched paint on one of the toilet stall partitions. The fire department responded to the automatic alarm and extinguished the blaze.

5. "Showers - We have tried several different types of flow-restricting shower heads. We have measured the one-minute output of each and compared it with the adequacy of the shower pattern. A number of our present shower heads can be adjusted to reduce the flow, and these have been so adjusted. For the remainder we have ordered flow restricting heads, and these should be in this week. When the installations are complete, we will again open the showers to night time users of our facilities.

6. "Maintenance jobs during the past month totalled 15 items of carpentry and general maintenance, 4 window replacements, and 19 items of plumbing and heating, one of which was the very extensive repair of frozen pipes and coils at Radcliffe School during the Christmas holidays.

#### FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of December 31, 1980, showing total funds available of \$12,555,548.13, contractual orders to date of \$11,413,051.45, leaving a balance of funds available of \$1,142,496.68.

#### SUPERINTENDENT'S REPORT:

Dr. Fadule presented and read the following report:

"A review of the 1979-80 academic year New Jersey Minimum Basic Skills results is in order for compliance with Thorough and Efficient regulations. Dr. Davis. (Please bring your booklets entitled Minimum Basic Skills Analysis and include the attached errata sheets.)

#### Informational Items

"Second quarter report cards will be distributed on January 30.

"The implementation of our priorities is progressing quite well and reports to the Board on the Kindergarten and Composition Writing Skills are forthcoming."

Dr. Fadule requested that Dr. Davis review the Minimum Basic Skills Analysis for the 1979-1980 school year, of which copies were presented to the Board and citizens. Mr. Williams commented that the Board had reviewed the results of the test scores previously but that this evening was a formal presentation of the Basic Skills Analysis. He further commented that the results speak for themselves and stated that he was sure the Board would see further results.

Mrs. Wightman gave a verbal report on her three day attendance at the New Jersey State Department of Education Academy, at which time the members were guests of Commissioner of Education, Fred Burke.

#### CAFETERIA REPORT:

Mrs. Rabinowitz presented the cafeteria report as of December 31, 1980, showing a cash balance as of July 1, 1980 of \$21.34, total receipts of \$114,924.90, total disbursements of \$97,181.11, leaving a balance of \$17,765.13. Total "A" lunch - 17,340. Total milk sold - 16,075. Free lunches - 3,016. Reduced price lunches - 1,028. School days - 15.

Mrs. Marilyn Craine, 464 Prospect Street, questioned whether all eleventh grade students were eligible to take the Minimum Basic Skills Math test to which Dr. Fadule replied in the affirmative.
