Board of Education Nutley, New Jersey July 27, 1981

The Regular Meeting of the Board of Education of the Town of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, July 27, 1981, at 8:30 p.m., with Mrs. Ann Rabinowitz, President, presiding.

FLAG SALUTE:

The meeting was opened with Mrs. Imhoff leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

CALL OF ROLL:

OLD BUSINESS:

Mr. Restaino questioned whether anyone had checked as to whether services to private and parochial schools were received as contracted for with the Educational Services Commission. Dr. Fadule replied that he had checked and although the time was somewhat shorter than anticipated, the nuns and priests had received services and they do want to continue to receive them.

Mr. Restaino read a statement requesting the resignations of Dr. White, Mr. Buehler and Mr. Leary as they had not fulfilled their obligations to the taxpayers as the watchdogs of public funds, pointing out that such behavior would not be tolerated in Nutley administrators. He suggested that letters be sent to the Education Committees, the Commissioner, the Governor, the State Board of Education, and our legislators requesting the resignations.

Mr. Tangorra, Mrs. Wightman, Mr. Eisenfelder, Mrs. Rabinowitz and Mr. Williams made comments pertaining to the issues and agreeing in principle with the statement of Mr. Restaino.

Mr. Murray suggested that we go all the way and rescind our agreement with the Educational Services Commission to provide direct services to private and parochial schools. This was discussed briefly, then the Chair suggested separating this issue from the one involving the County Superintendent, and taking it up at another time. This was done.

Mr. Restain then moved that the Nutley Board of Education request the resignation of Dr. White, Essex County Superintendent of Schools, for not fulfilling the duties of his position, seconded by Mr. Murray and unanimously approved by the Board.

Mrs. Rabinowitz commented that the Essex County School Boards Association and the New Jersey School Boards Association should also receive copies of this resolution.

Dr. Fadule stated that with regard to contracts for direct services, we should stay flexible because the private school children are receiving services which the parochial school people feel are useful, and they would like to continue to receive them. Mrs. Imhoff asked if things fall through for this fall semester, is there an alternative plan, to which Dr. Fadule replied in the negative.
