The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey, was held in the Board Room, 149 Chestnut Street, on Monday, July 26, 1982, at 8:00 p.m., with Mrs. Ann Rabinowitz, President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Perez leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

CALL OF ROLL:

The other members present at roll call were: Dr. Anthony N. Baratta, Mr. Douglas Eisenfelder, Mrs. Jacqueline Imhoff, Mr. Charles W. Kucinski, Jr., Mr. Joseph Malanga, Mr. Carl Perez, Mr. Frank V. Tangorra, and Mr. Louis F. Williams. One citizen was present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on June 21, 1982, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Dr. Baratta moved that the minutes be approved, seconded by Mrs. Imhoff, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

1. A letter from the Board of Adjustment, Township of Nutley -  
re: Radcliffe School:

"At a meeting of the Board of Adjustment held on July 19, 1982 a decision was rendered granting your appeal for a variance from the provisions of the Nutley Zoning Ordinance, in connection with the subject property.

"A copy of the resolution adopted is attached hereto.

"An application for a building permit must be made within ninety (90) days from the date of the granting of this variance. Extensions of thirty days beyond this period may be granted upon timely and proper application to the Board of Adjustment made prior to the termination of the ninety-day period."

Mr. Ramsland stated that the resolution passed by the Board of Adjustment had not been received. Mr. Eisenfelder suggested that a copy be requested and also that it be reviewed.

#### SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"The attached report on vandalism for the 1981-1982 school year shows an overall increase of 20%. However, this figure reflects both a substantially higher figure for the cost of glass replacement (63%) and an 83% reduction in the cost of damages other than glass.

"Glass replacement costs were declining in recent years (47% in 1979-1980 and 11% in 1980-1981) but rose again last year. Other damages have been declining steadily since the high year of 1978-1979.

"Delivery of the computer equipment to the Radcliffe School site is scheduled for this week. It will be stored in a secure place until the computer room is ready. The telephone equipment is scheduled for delivery the latter part of August.

"The major project occupying both the maintenance department and grounds crew has been the renovation of areas in Radcliffe School to which classes and facilities have been moved to make the space available for the Administrative offices. In conjunction with the custodial crew, and under the supervision of Mr. Giua, a lot of work has been done there since school let out a month ago.

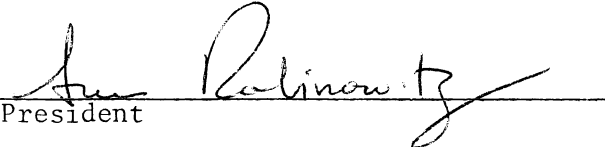

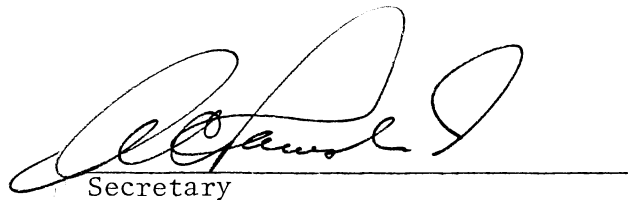

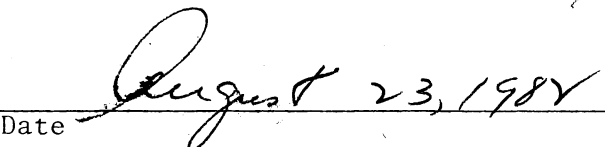
