Board of Education Nutley, New Jersey November 22, 1982

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey, was held in the Board Room, 375 Bloomfield Avenue, on Monday, November 22, 1982, at 8:20 p.m., with Mrs. Ann Rabinowitz, President, presiding.

FLAG SALUTE:

The meeting was opened with Dr. Baratta leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

CALL OF ROLL:

The other members present at roll call were Dr. Anthony N. Baratta, Mr. Douglas Eisenfelder, Mrs. Jacqueline Imhoff, Mr. Joseph Malanga, Mr. Carl Perez, Mr. Frank V. Tangorra, and Mr. Louis F. Williams. Absent and excused: Mr. Charles W. Kucinski. Five citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on October 25, 1982, at 8:15 p.m., being in the hands of each member, reading of same was dispensed. Mr. Eisenfelder moved that the minutes be approved, seconded by Mr. Williams and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

- 1. A notice of a meeting to be held on Tuesday, November 30, 1982, by the Essex County Educational Services Commission.
- 2. An invitation to attend the dedication ceremony of the New Jersey Regional Day School in the area from Saul Cooperman, Commissioner of Education.

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"Good news and bad news. Let's start with the bad.

"The most recent State Aid figures for the current budget year (1982-83) indicate that our Equalization Aid will be \$35,513 less than was budgeted last March. However, this figure is not firm, and we should anticipate a further three to six percent reduction in State Aid for this year. The new figures should be available by December 15.

"The State Aid figures for 1983-84 have been received; however, these are numbers derived from the formula, and only indicate what our entitlement is. Who among us is naive enough to believe them? In case you're curious, the number for non-categorical aid is \$1,402,109, compared to \$1,554,547 for 1981-82, and a current number of \$1,009,934 for 1982-83, which we expect will be cut by another 3% to 6%.

"The good news? Oh yes. Well, for one thing, Christmas is coming, and maybe Santa Claus will put some extra shekels in our corporate stocking. For another, S-1831 and A-2000 are dead. These bills, deferring the date for notification of State Aid and pushing the school elections off until the third week in April, have been taken off the boards.

"In the maintenance department, glass replacements this past month totalled 19. Carpentry and general items amounted to 32, and 21 separate plumbing and heating repairs were made.
