Board of Education Nutley, New Jersey December 20, 1982

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey, was held in the Board Room, 375 Bloomfield Avenue, on Monday, December 20, 1982, at 8:00 p.m., with Mrs. Ann Rabinowitz, President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Tangorra leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

CALL OF ROLL:

The other members present at roll call were Dr. Anthony N. Baratta, Mr. Douglas Eisenfelder, Mrs. Jacqueline Imhoff, Mr. Charles W. Kucinski, Jr., Mr. Joseph Malanga, Mr. Carl Perez, Mr. Frank V. Tangorra, and Mr. Louis F. Williams. Three citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on November 22, 1982, at 8:20 p.m., being in the hands of each member, reading of same was dispensed. Mr. Tangorra moved that the minutes be approved, seconded by Mr. Kucinski and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

1. A letter from Joseph V. Doria, Jr., Assemblyman, District 31:

"Thank you for your letter of November 15th concerning A-2000.

"Let me begin by assuring you that I do not support this piece of legislation. At one point, we believed that this bill might provide a solution to some of the problems boards of education faced when funds are cut back.

"However, after reviewing the bill and discussing it with various boards of education, I have determined that this is not a solution.

"I do not plan to support this bill and do not see any chance of it passing.

"Thank you for your interest and support."

2. A letter from Joel L. Harrison:

"I thought the enclosed article that appeared in the December 9, 1982 issue of the Journal of Commerce would be of interest to you.

"Since the Japanese have absolutely refused to cooperate with American manufacturers, may I respectfully urge you to consider this when purchasing sporting goods and other items. As you will see from the enclosed article they have reneged on all commitments and promises.

"Please buy American and let's get our people back to work.

"Thank you for your cooperation."

3. A letter from Lloyd Newbaker, Executive Director, New Jersey School Boards Association:

"It is with a deep sense of frustration that I report to you concerning the fiscal crisis in Trenton. As of this writing, the Governor and the Legislature remain mired in a partisan, political battle which shows no sign of abating or resolving itself in any responsible manner.

"School districts across the State are reeling from the Governor's just announced \$42.3 million cut in state aid for this year, a cut which, because of its timing, can only result in educational program reductions. This latest cut does not stand alone but comes on the heels of an \$83 million reduction in state aid to education which was imposed last summer.

"Until now, NJSBA has focused all of its efforts on the Legislature, the body with primary responsibility for our education system under the Constitution. Ultimately, no other branch of government can resolve this crisis, and we felt from a tactical lobbying standpoint that any collateral actions would be counterproductive to that primary effort.

"Our pleas for legislative action, including our support for necessary revenue raisers, has thus far fallen on deaf ears, and we must launch an assault on a second front -- in the courts. Accordingly I have directed our Legal Department to immediately commence litigation challenging the constitutionality of all cuts in 1982-83 public school aid. The action will be filed within seven days, and we will seek an expedited hearing in early January.

"The basis for the lawsuit will be the 1976 Supreme Court decision in Robinson v. Cahill. In that case, the Court upheld the constitutionality of the present funding formulas (as set forth in the Public School Education Act of 1975, the so-called 'T & E' law), but did so only on the assumption that the formulas would be fully funded. The appropriations bill for this school year fell \$83 million short of full funding, and the Governor's recent action brings about an additional \$42.2 million shortfall. NJSBA will argue that these actions by the Governor and the Legislature violate the minimum constitutional requirements for state funding of education as interpreted in Robinson v. Cahill.

"NJSBA's challenge will go to <u>all</u> cuts in formula aid to local school districts made for this school year. The cumulative tally is as follows:

"While vigorously pursuing its legal action, NJSBA has no intention of letting up on the legislative front. Our lawmakers must be made aware that partisan bickering must be put aside in favor of responsible action. Spread the word. It is time to alarm every member of your community about the losses they suffer now and those to come. Call for a massive outpouring of sentiment to our state legislators and Governor to act responsibly, to resolve the state's fiscal crisis and to fulfill their obligation to education. Our message must be loud and clear:

SAVE STATE SCHOOL AID. ENACT THE TAXES THAT ARE NECESSARY. STOP BLAMING EACH OTHER. WE DON'T WANT TO HEAR EXCUSES. WE WANT YOU TO TAKE THE LEADERSHIP. MAKE THE NECESSARY COMPROMISES.

"Contacts should be made with the Governor, your own legislative representatives and the leadership of both houses. The latter includes President of the Senate Carmen Orechio, Senate Minority Leader Donald DiFrancesco, Speaker of the General Assembly Alan Karcher and Assembly Minority Leader Dean Gallo.

"Act now! We need your support."

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"The New Jersey School Boards Association's Management Information Department has released its annual Cost of Education Index using 1982-83 advertised budget figures. The comparisons are of individual districts with averages in five groupings.

'More specifically, Nutley is compared with the averages of 509 districts in the State, 20 districts in Essex County, 130 districts having a Socio-Economic Status (SES) similar to Nutley's, 47 K-12 districts with an Enrollment Grouping (ENRGRP) of 3,000 to 6,000, and 26 districts in Nutley's ENRGRP which are in our region, consisting of Passaic, Bergen, Essex, Hudson, Union, and Morris Counties.

"Since the comparisons are on the current year's originally submitted and advertised budget, and many budgets, including ours, were realigned after budget defeats, comparisons of line items are somewhat misleading. The totals, however, would have enough validity to make them worth noting.

"The average current expense budget in the State is 3349 budgeted dollars per pupil. Essex County is 3413. Our Socio-Economic group is 3386. Our Enrollment group is 3457. Our Enrollment group/Region is 3618. Nutley's is 3220.

"The average total budget per pupil presented in the same order as above is 3521, 3478, 3581, 3644, and 3792, with Nutley's total being 3276.

"What do these figures tell us? First, they confirm the fact that education, like groceries, clothing, cars, and houses, costs more every year. But they also tell us that we are still educating children in our little corner of the State at less cost than any other group with which we are being compared.

"So much for costs. What about revenues? While we continue to contribute our fair share to the State in the form of sales, income, and other taxes, too much of our money loses its way and never makes the return trip. If our total State aid for this year were to be tripled, it would still be far short of the State aid average of all the State's school districts.

Mr. Eisenfelder presented the cafeteria report as of November 30, 1982, showing a cash balance as of July 1, 1982 of \$428.60, total receipts of \$77,984.91, total disbursements of \$72,046.30, leaving a balance of \$6,367.21. Total "A" lunch - 12,546.
