FLAG SALUTE:

The meeting was opened with Mr. Williams leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

CALL OF ROLL:

The other members present at roll call were: Dr. Anthony N. Baratta, Mr. Douglas Eisenfelder, Mr. Charles W. Kucinski, Jr., Mr. Joseph Malanga, Mr. Carl Perez, Mr. Frank V. Tangorra, and Mr. Louis F. Williams. Absent and excused: Mrs. Jacqueline Imhoff. One citizen was present.

HEARING OF CITIZENS:

APPOINTMENT - Teacher:

Miss Anne Marie Kowalski

Mr. Eisenfelder presented and moved the adoption of the following resolution, seconded by Mr. Malanga. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Miss Anne Marie Kowalski be appointed physical education instructor effective February 1, 1983 through June 30, 1983 at the annual salary of \$13,686.00, (B.A.-2) which is in accordance with the 1982/1983 teachers' salary guide.

Mr. Malanga presented and moved the adoption of the following resolution, seconded by Dr. Baratta. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the following teachers be appointed to teach the Scholastic Aptitude Tests Review Classes to be held on February 5, 12, 19 and March 5, 12, 1983 from 8:30 to 11:30 a.m. at the rate of \$60 per session:

Mr. Tangorra presented and moved the adoption of the following resolution, seconded by Mr. Kucinski. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mrs. Miriam Kirsten be approved as teacher in the Scholastic Aptitude Tests classes for seventh grade academically talented students at the rate of \$60 per session.

CHANGE OF MEETING DATE - Public Hearing on 1983-1984 Budget:

Mr. Perez presented and moved the adoption of the following resolution, seconded by Mr. Eisenfelder, and unanimously approved by the Board:

BE IT RESOLVED, That in view of the rescheduling of the date of the Annual School Election, the Public Hearing on the 1983-1984 budget be rescheduled from March 7, 1983 to March 14, 1983.

TERMINATION OF CONTRACT:

Mr. Williams presented and moved the adoption of the following resolution, seconded by Mr. Kucinski. On a roll call vote the resolution was unanimously adopted:

WHEREAS, was suspended with pay on February 4, 1983 for an incident which occurred in the Franklin School on January 31, 1983, and

WHEREAS, was provided with an opportunity to present his version of the incident before the Board of Education, and

WHEREAS, the Board of Education afforded a hearing at an executive session of the Nutley Board of Education on February 14, 1983, and

WHEREAS, there exists good cause for invoking the sixty day termination provision of ______''s employment contract,

BE IT RESOLVED, That the Board of Education hereby invokes the sixty day termination provision of semployment contract, and

BE IT FURTHER RESOLVED, That semployment with the Nutley Board of Education shall be terminated effective April 15, 1983, and

BE IT FURTHER RESOLVED, That is hereby suspended with pay during the sixty day period.

OLD BUSINESS:

Mr. Tangorra made comments and asked questions with regard to the intramural program, to which Dr. Fadule and Mr. DeCesare responded.

NEW BUSINESS:

Mr. Eisenfelder stated that there is a bill before the Assembly with regard to a uniform construction code. He added that the New Jersey School Boards Association is against passage of this bill. Mr. Kucinski and Mrs. Rabinowitz also commented.

Mr. Tangorra stated that S-1962 mandates math and science to be taken by all students in the high school and elementary grades, and he expressed his opposition to this. Mrs. Rabinowitz and Mr. Eisenfelder also commented. Dr. Fadule is to draft a statement to be sent to the legislators involved.

ADJOURNMENT:

There being no further business to come before the Board, on motion made by Mr. Eisenfelder, seconded by Mr. Williams, the meeting was adjourned at 9:35 p.m.
