The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey, was held in the Board Room, 375 Bloomfield Avenue, on Monday, April 25, 1983, at 8:10 p.m., with Mr. Charles W. Kucinski, Jr., Vice-President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Malanga leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

CALL OF ROLL:

The other members present at roll call were: Dr. Anthony N. Baratta, Mr. Frank V. Hermo, Mr. Joseph Malanga, Mrs. Ann Rabinowitz, and Mr. Gerard T. Restaino. Absent and excused: Mr. Frank V. Tangorra, Mr. Carl Perez, and Mr. Louis F. Williams. Approximately 46 citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Organization Meeting held on April 15, 1983, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Dr. Baratta moved that the minutes be approved, seconded by Mr. Malanga and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communication:

1. A letter to Dr. James J. Fadule, Jr., from Ruth G. Bedford:

"Thank you for sending us the memorial resolution passed by the Board for my mother. We appreciated this action by members of a Board who did not know her, except for Frank Tangorra.

"Please extend our thanks and appreciation to the Board."

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"Just a few comments on the recent school board election. First, my sincere congratulations to Mr. Tangorra, Mr. Restaino, and Mr. Hermo on their victories at the polls. The vigor with

which you conducted your campaigns indicates your intense interest in Board matters, and this must result in only the best for the students of the Nutley School System.

"Secondly, I would like to extend my personal thanks to Mrs. Imhoff and Mr. Eisenfelder for their unflagging devotion to the Board during their terms of office. Their deep insight and wise counsel will surely be missed.

"Then I would take this opportunity to publicly recognize the men and women of our town who gave unselfishly of their time and talent to conduct the election for us. We are truly fortunate in Nutley to have this corps of volunteers. Surely this is one of the reasons why Nutley is special.

"Many others worked diligently behind the scenes to make the election a success. Attempting to name them all would be foolhardy on my part. However, I could not even mention election without mentioning Louise Simons, and a great big 'thank you' to her.

"What can I say about big Charlie K? His contribution to publicizing the budget is now legendary. But we must also recognize that with the slim margin of approval, the effort of every Board member, and indeed of every candidate, was important.

"On another note, the dock extension at the boathouse in Kearny was completed a week ago on Saturday and Sunday. The new float, which was built in sections, has been ready since mid-February, and we're waiting for the most opportune time to put it in place. As of now, that is scheduled for next Monday, May 2.

"In the maintenance department, eight windows were replaced and five maintenance projects were completed by the carpenters. Nineteen plumbing and heating repairs were accomplished.

Mr. Kucinski commented that he had accompanied the Nutley High School Band to Nassau in the Bahamas where they performed on three different occasions, and he was privileged and honored to be associated with them because of the outstanding way in which they had conducted themselves.
