The Special Meeting of the Board of Education of the Township of Nutley, New Jersey, was held in the Board Room, 375 Bloomfield Avenue, on Monday, August 15, 1983, at 8:15 p.m., with Mr. Charles W. Kucinski, Jr., Vice President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Malanga leading the Board members and citizens in the Pledge of Allegiance to the American flag.

ANNOUNCEMENT OF ADEQUATE NOTICE:

Mr. Kucinski read the following notice:

"As required by the 'Open Public Meetings Act' (Chapter 231, P.L. 1975), notice of this meeting was provided to the public and the press at least 48 hours in advance by:

CALL OF ROLL:

The other members present at roll call were: Dr. Anthony N. Baratta, Mr. Frank V. Hermo, Jr., Mr. Joseph Malanga, Mr. Carl Perez, Mr. Gerard T. Restaino, and Mr. Louis F. Williams. Absent and excused: Mrs. Ann Rabinowitz and Mr. Frank T. Tangorra. Three citizens were present.

ANNOUNCEMENT OF PURPOSE OF MEETING:

Mr. Kucinski read the following notice:

"The purpose of this meeting is to take formal action on personnel contracts for the 1983-1984 school year, and to transact any other business which may properly come before the Board."

APPOINTMENT - Teacher:Mr. Frank Giovanucci

Mr. Malanga presented and moved the adoption of the following resolution, seconded by Mr. Perez. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mr. Frank Giovanucci be appointed physical education teacher effective September 1, 1983 through June 30, 1984, at the annual salary of \$25,139.00 (M.A. - 14) which is in accordance with the 1983-1984 teachers salary guide.

APPOINTMENT - Athletic:Mr. Frank Giovanucci

Mr. Perez presented and moved the adoption of the following resolution, seconded by Mr. Malanga. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mr. Frank Giovanucci be appointed head basketball coach for the 1983/1984 school year at a salary of \$2,657.00 which is in accordance with the 1983/1984 athletic salary guide.

APPOINTMENT - Teacher:Mr. Richard Koegel

Dr. Baratta presented and moved the adoption of the following resolution, seconded by Mr. Perez. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mr. Richard Koegel be appointed science teacher effective September 1, 1983 through June 30, 1984, at the annual salary of \$21,813.00 (B.A.-12), which is in accordance with the 1983/1984 teachers' salary guide.

APPOINTMENT - Teacher:Mrs. Joyce Thomas

Mr. Restaino presented and moved the adoption of the following resolution, seconded by Dr. Baratta. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mrs. Joyce Thomas be appointed science teacher effective September 1, 1983 through June 30, 1984, at the annual salary of \$16,879.00 (M.A.-3 $\frac{1}{2}$), which is in accordance with the 1983/1984 teachers' salary guide.

APPOINTMENT - Part-time Athletic
Director:Mr. Thomas Gallucci

Mr. Williams presented and moved the adoption of the following

resolution, seconded by Mr. Perez. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mr. Thomas Gallucci be appointed part-time athletic director for the 1983-1984 school year for a salary in the amount of \$3,900.00, separate from and in addition to his regular salary.

APPOINTMENT - Athletic Trainer:

Mr. John Calicchio

Mr. Hermo presented and moved the adoption of the following resolution, seconded by Dr. Baratta. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mr. John Calicchio be appointed athletic trainer for the 1983-1984 school year for a salary in the amount of \$1,827.00 (Step 4) in accordance with the 1983-1984 athletic salary guide.

APPOINTMENT - Manager, Athletic Equipment:

Mr. John Flanigan

Mr. Malanga presented and moved the adoption of the following resolution, seconded by Mr. Perez. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mr. John Flanigan be appointed Manager, Athletic Equipment for the 1983-1984 school year for a salary in the amount of \$1,842.00 (Step 4), which is in accordance with the 1983-1984 athletic salary guide.

APPOINTMENT - Assistant Manager, Athletic Equipment:

Mr. Gino Giua

Mr. Perez presented and moved the adoption of the following resolution, seconded by Dr. Baratta. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mr. Gino Giua be appointed Assistant Manager, Athletic Equipment for the 1983-1984 school year for a salary in the amount of \$1,085.00 (Step 4), which is in accordance with the 1983-1984 athletic salary guide.

APPOINTMENT - Assistant Soccer Coach:

Mr. Joseph Bertuzzi

Dr. Baratta presented and moved the adoption of the following resolution, seconded by Mr. Williams. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mr. Joseph Bertuzzi be appointed Assistant Soccer Coach for the 1983-1984 school year at a salary in the amount of \$1,720.00 (Step 3), which is in accordance with the 1983-1984 athletic salary guide.

NEW BUSINESS:

Mr. Perez made reference to a new law which allows boards of education to require increased proof of residency with regard to affidavit students, and asked about Nutley's manner of conducting investigations, to which Dr. Fadule replied.

Mr. Perez quoted an article which appeared in the July 27, 1983 issue of the Star Ledger regarding savings effected with regard to the purchase of gasoline by the West Orange Board of Education in conjunction with the Township. Mr. Perez wishes to pursue this with the Township of Nutley, to which Mr. Kucinski and Mr. Ramsland replied.

Mr. Malanga commended the Nutley Police Department for doing a fine job in helping curtail some of the vandalism that could have occurred this summer and for apprehending youngsters who had broken into the high school. Mr. Malanga suggested that alarm systems be installed on the entire first floors of the high school and Franklin School, to which Dr. Fadule replied. Mr. Ramsland added that he should have prices before next week's Board of Education meeting.

Dr. Fadule thanked Mr. Malanga and Mr. Donadia who were directly responsible for the police apprehending two of the people who had broken into the high school.

Mr. Perez questioned if the fingerprinting program is ready to go into operation in September, to which Mr. DeCesare replied.

ADJOURNMENT:

The meeting was adjourned at 8:30 p.m.
