Board of Education Nutley, New Jersey December 19, 1983

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey, was held in the Board Room, 375 Bloomfield Avenue, on Monday, December 19, 1983, at 8:00 p.m., with Mr. Gerard T. Restaino, President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Hermo leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Dr. Anthony N. Baratta, Mr. Frank V. Hermo, Mr. Charles W. Kucinski, Jr., Mr. Joseph Malanga, Mr. Carl Perez, Mrs. Ann Rabinowitz, Mr. Robert Rusignuolo, and Mr. Louis F. Williams. Three citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on November 21, 1983, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mr. Perez moved that the minutes be approved, seconded by Mr. Kucinski and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

- 1. A Notice from the Essex County School Boards Association of its Legislative Brunch to be held on Sunday, January 15, 1984 at the Nutley Manor, 800 Bloomfield Avenue, Nutley, between the hours of 11:00 a.m. and 2:30 p.m.
- 2. A Notice from the Essex County Educational Services Commission of its regularly scheduled meeting to be held on Tuesday, December 20, 1983 at 7:00 p.m.

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"The latest word from the County Superintendent's office is that there is as yet no change in anticipated State Aid figures. This is, however, not a cause for optimism, since they fully expect a reduction in the numbers submitted to us last month, but 'probably not any greater than last year's.' Last year's reduction in Equalization Aid was \$258,232, or 19% below the figure given to us in November. This year the going-in figure is already \$173,161 below last year's.

"Window replacement was again minimal last month, the number was 5. Aside from that, 16 items of carpentry and general repairs were made, and 22 of plumbing and heating.

FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of November 30, 1983, showing total funds available of \$15,827,285.65, contractual orders to date of \$13,817,752.65, leaving a balance of funds available of \$2,009,533.00.

SUPERINTENDENT'S REPORT:

Dr. Fadule presented and read the following report:

''On Tuesday, December 20, 1983, Nutley High School will present its annual Christmas cantata at 8:00 p.m.

'On Thursday, December 22nd, schools will close at 12:30 p.m. for the holiday recess and resume on Tuesday, January 3, 1984.

"Committees working on school district priorities are progressing quite well.

"Attached is the November 30, 1983 student population chart."

CAFETERIA REPORT:

Mr. Kucinski presented the cafeteria report as of November 30, 1983, showing a cash balance as of July 1, 1983 of \$327.78, total

receipts of \$88,692.75, total disbursements of \$73,456.87, leaving a balance of \$15,563.66. Total "A" lunch - 14,069. Total milk sold - 12,673.

HEARING OF CITIZENS:

A citizen raised the issue of cars parking in front of the schools on rainy days, stating that this poses a danger to children, and asking if this is a Board of Education problem or a police department problem, to which Mr. Ramsland, Mr. Kucinski, Mr. Perez and Dr. Baratta replied. Mr. Restaino suggested that this be brought up by Board members when attending PTA meetings. Also, Dr. Fadule will send a notice to the principals.

GROUP TRIP INSURANCE:

WHEREAS, the Board of Education is aware of a proliferation of trips during vacation periods organized and participated in by members of the staff and the student body, and

WHEREAS, the Board has played no role in either organizing or approving said trips, and

WHEREAS, the Board is concerned that students and parents may presume that such trips are arranged under the auspices of the Board of Education, and

WHEREAS, the Board is concerned about both the propriety of some of these trips as well as its potential liability for accident or injury which may occur during said trips, and

WHEREAS, it is currently in the process of developing a policy to review all such trips as well as reviewing its insurance coverage for same,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education purchase group trip insurance thru the C.W. Bollinger Company for the remainder of the 1983-84 school year only in order to further protect it from any claimed liability pending its complete review of insurance and adoption of policy to be effective for school year 1984-85.

OLD BUSINESS:

Mr. Kucinski questioned the status of providing some form of communications system in the Oval, to which Mr. Ramsland and Mr. Restaino replied.

NEW BUSINESS:

Dr. Baratta made reference to resolution #21, Program Plans for the Education of all Handicapped Children, stating that the Board recognizes many children in our school district for various accomplishments, and questioning whether the Board recognizes the accomplishments of the handicapped children. Dr. Fadule replied to this, adding that consideration would be given to this suggestion.

ADJOURNMENT:

There being no further business to come before the Board, on motion made by Mrs. Rabinowitz, seconded by Mr. Malanga, the meeting was adjourned at 8:40 p.m.
