June 25, 1984

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey, was held in the Board Room, 375 Bloomfield Avenue, on Monday, June 25, 1984, at 9:10 p.m., with Mr. Gerard T. Restaino, President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Battaglia leading the Board members and citizens in the Pledge of Allegiance to the American Flag.

CALL OF ROLL:

The other members present at roll call were: Dr. Anthony N. Baratta, Mr. Sam Battaglia, Mr. Frank V. Hermo, Mr. Charles W. Kucinski, Jr., Mr. Joseph Malanga, Mr. Charles J. Piro, Mr. Robert J. Rusignuolo, and Mrs. Rosalie C. Scheckel. Approximately 30 citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on May 21, 1984, at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mr. Kucinski moved that the minutes be approved, seconded by Dr. Baratta, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communication:

1. A letter from Mrs. Dottie Silvestri
re: "Family Life Course (K-12)":

"Recognizing the fact that the Family Life Course (K-12) is already N. J. law, therefore enclosed article is 'after the fact', I think it's important to read some of the research of various knowledgeable people who have persued this subject.

"As I understand the law, I may take my child out of certain subjects which offend my sense of moral integrity. Being realistic you can understand what embarrassment this would be to the child involved because of peer pressure, etc. Therefore, I bring my concerns directly to you.

"The enclosed subjects, as I understand it, are to be taught in co-ed health class. This I find grossly repugnant and completely unnecessary to be discussed in such a co-ed group as 12 year olds. Children have

an inborn modesty & when you work at corroding that for no good reason, you are doing, in my opinion, as well as that of many psychologists, damage to their character. I urge you to consider segregated classes for these very vulnerable children.

"My right as a parent, I know, permits me to withdraw my child from subjects I find morally objectionable. I would very much hate to do this, but I feel I will be forced to if no change is made.

"My understanding of the law is that the way the law is carried out, the subjects to be presented, are left up to the individual districts.

"Moving with the times is one thing, but to go to such extremes when there is still so much research needed on whether or not this openness is beneficial or detrimental to our children seems completely unnecessary to me. I pray you will at least consider preceding facts."

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"This being the fourth Board Meeting this month, everything of a reportable nature has already been reported. Hence the brevity of this report.

"In the maintenance department, glass breakage has been light this month, with only six replacements. This compares to 32 in June of last year. Other items of carpentry and general maintenance amounted to 20. Plumbing and heating repairs totalled 15.

"The grounds crew, in addition to their regular Spring clean-up and grass cutting, lined baseball fields on an almost continuous basis. Then they set-up seats, stands and fences for graduation, and took them all down again.

FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of May 31, 1984, showing total funds available of \$16,002,591.03, contractual orders to date of \$14,370,222.98, leaving a balance of funds available of \$1,632,368.05.

SUPERINTENDENT'S REPORT:

Dr. Fadule presented and read the following report:

"The Superintendent attended and spoke at all eight promotion and commencement exercises.

"Attached is a copy of the student enrollment statistics as of May 31, 1984.

"Attached is a copy of some 1984/85 achievement scores.

"The Superintendent has considered the question of the elimination of elementary school specialist positions."

Dr. Fadule reported on the well attended and well received promotion and graduation ceremonies. It is a pleasant experience watching our young people grow and develop. He congratulated the parents, teachers, administrators and the Board in the pride taken developing these young people.

The student enrollment statistics continue to show a drop in enrollment.

Dr. Fadule reported on the excellent achievement of students in the elementary schools with regard to math and reading results. The entire Nutley community can be proud of these outstanding scores.

He further commented on the 9th grade test scores. In view of the fact that this test is being administered on a trial basis for the next two years, the scores will not be recorded on the student's record, however, the State of New Jersey has endorsed it and mandates effective June 1986, a student must pass State requirements before he/she receives a high school diploma.

Dr. Fadule remarked that because of normal attrition, no individuals would be laid off as a result of eliminating the specialist positions in art, music and physical education in the elementary schools. All elementary schools will not offer the same schedule in the arts.

MOMENT OF SILENCE:

Mr. Restaino asked for a moment of silence in memory of Mr. Frank Wiggins, a teacher in the industrial-arts department of Nutley High School, who died suddenly on June 22, 1984.

CAFETERIA REPORT:

Mr. Kucinski presented the cafeteria report as of May 31, 1984, showing a cash balance as of July 1, 1983 of \$327.78, total receipts of \$259,934.59, total disbursements of \$236,661.10, leaving a balance of \$23,601.27. Total "A" lunch - 18,225. Total milk sold - 15,612.

HEARING OF CITIZENS:

Mr. Michael Duffy, 272 Kingsland Street, read a letter from John Peccarelli, this year's recipient of the Orchestra Scholarship offered by the Music Booster Association of Nutley, thanking them for their interest and commenting on the low priority music instruction is given in Nutley.

Mr. Duffy expressed his disapproval of the reduction in staff in the arts program. Dr. Fadule replied that the arts are still and will continue to be an important part of a student's education. All students will now receive equal time in the arts instruction.

Mr. Restaino stated that the specialist positions are not the only positions affected, in other areas of instruction 15 teachers will not be replaced for the 1984/1985 school year.

Mrs. Pat Lepore, 41 Howard Place, asked if the tests scores of the children receiving the additional periods in the arts were lower than the other students, to which Dr. Fadule replied.

Mr. Michael Batty, 32 Renner Avenue, inquired about the number of periods that the students will now receive in the arts and strongly recommended that more emphasis be placed on the music program.

Dr. Fadule explained that in some of the schools the instruction will vary, but the end result will be that all students will complete the same instruction. The smaller schools, that is Washington, Radcliffe and Spring Garden, will now follow the same structure that Lincoln and Yantacaw schools follow.

Mr. John Walker, principal of Yantacaw School, spoke in favor of eliminating these positions.

Mr. Evan Powderly, principal of Radcliffe School and Mr. Anthony Stivala, principal of Spring Garden, both were supportive to this program change.

Mr. Restaino thanked the principals and commented that it is our objective to serve all our youngsters equally.

A representative from Washington School voiced her opinion that too much emphasis placed on academic excellence in the early years of education may tend to "burn out" the student.

Mrs. Carol Cook, 451 Chestnut Street, asked how the sharing of physical education, music and art would be handled, to which Dr. Fadule responded.

Mrs. Carol Bender, 108 Joerg Avenue, asked Dr. Fadule if consideration was given to fact-facting, to which he responded.

Mr. Duffy stated that the scheduling was all done and Mr. Kohere was not included, and Mr. Duffy felt that he had been misled.

Dr. Fadule assured Mr. Duffy that he was not misled. Mr. Kohere does not do the scheduling. The scheduling is done by the principal of each school.
