Mr. Hermo presented and moved the adoption of the following resolution, seconded by Mr. Malanga. On a roll call vote the resolution was unanimously adopted:

WHEREAS, N.J.S.A., 18A:7A-28, as amended, requires the preparation on or before January 15, 1986 of a school budget for the ensuing year,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education hereby adopts a tentative budget for the 1986-1987 school year in the total amount of:


Current Expense	\$16,333,512

Total Budget	\$16,975,714


BE IT FURTHER RESOLVED, That the Secretary be authorized to submit this budget to the County Superintendent for his examination to determine that all the information submitted therein is verifiable from records on file in his office and is consistent with such records, and

BE IT FURTHER RESOLVED, That upon receiving the approval of the County Superintendent the Secretary be authorized to publish the 1986-1987 Budget in THE NUTLEY SUN.
