Nutley, New Jersey

March 24, 1986

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey, was held in the Board Room, 375 Bloomfield Avenue, on Monday, March 24, 1986, at 8:35 p.m., with Mr. Charles W. Kucinski, Jr., President, presiding.

FLAG SALUTE:

The meeting was opened with Mr. Rusignuolo leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Dr. Anthony N. Baratta, Mr. Sam Battaglia, Mr. Frank V. Hermo, Mr. Joseph Malanga, Mr. Charles J. Piro, Mr. Gerard T. Restaino, Mr. Robert J. Rusignuolo, and Mrs. Rosalie C. Scheckel. Approximately 14 citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on February 24, 1986, at 8:05 p.m., being in the hands of each member, reading of same was dispensed. Mr. Malanga moved that the minutes be approved, seconded by Mr. Rusignuolo, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Ramsland presented and read the following communications:

1. A letter from Michael A. Batty, President, Nutley High School Parent's Council:

"Recently the Nutley High School Parents' Council ran an Italian dinner. This was the first attempt at a fund raiser by our organization and I am happy to say it was a success.

"A major ingredient to this success was the cooperation and support we received from Dr. Frank T. Votto and his staff at the High School. In particular Mrs. Lynda Scarpa, Director of Food Services, was an absolute professional in assisting us in the procurement of some items and ensuring the kitchen and cafeteria area was ready for us when we

arrived. She also took time out to familiarize some of our committee with the kitchen and cafeteria area a few days prior to our dinner.

"As you can appreciate, to run this type of affair requires a lot of planning and hard work with no guarantee's of success. Even though our committee did a fine job in planning, if it was not for one particular board of education employee we would have had great difficulty in preparing and serving the dinners in an acceptable and timely manner. The person to whom I am referring to is Mrs. Barbara Gayder a cafeteria employee from Washington School, a last minute replacement for the high school cook who was out sick. Barbara stepped right in and took charge and worked the entire time side by side with our workers as if she were a member of our committee. Her assistance was invaluable and her work ethic should not go unrecognized.

"The intent here is not to imply that this situation is unique in our system, but document the fact that this type of joint effort does exist and should be encouraged."

2. A letter from Dorothea E. McCann, Secretary, Kearny Board of Education:

"We have been having serious leaking problems with an area of the roof at the crew building. We had this area checked and our Board at their Regular Meeting last night, awarded the contract to have this area of the roof repaired to Guymar Construction Co., Inc. at a cost of \$7,850.00. The following work will be done:

1. Remove existing roof including saturated insulation down to roof deck and cart away.
2. Mechanically fasten 1/2" roof insulation board to this entire area.
3. Install a single ply membrane adhered system as per manufacturer's specifications.

"Guymar Co. will give a seven (7) year warranty against leakage on this roof section.

"If you have any questions, please call."

The Board expressed its disapproval regarding the manner in which Kearny presented this bill for payment. A motion was made by Mr. Piro, seconded by Dr. Baratta, requesting Mr. Ramsland to write a letter to Kearny to the effect that payment was being withheld pending a full explanation as to the procedure used by Kearny to determine the awarding of this contract.

SECRETARY'S REPORT:

Mr. Ramsland presented and read the following report:

"You will note that the totals of the budget being adopted tonight are different than the totals in the budget book. Since the book was completed, two additional items of State Aid have been certified to us.

"The teacher salary account (213) is increased by \$52,567, which is the amount the State is reimbursing us for increasing the minimum salary to \$18,500. This increases the Current Expense total from \$16,293,231 to \$16,345,798.

"The Compensatory Education account is increased by \$38,157 to provide additional funds for remedial instruction for those students who may fail the new High School Proficiency Test (HSPT).

"While the Governor's recommendation for education funding was \$48.6 million short of full funding, he did set aside that amount for additional Compensatory Education Aid due to HSPT.

"Our problem is that our contribution to the \$48.6 million which is \$265,669, after being redistributed, comes back to us as \$38,157, which is only 14% of the amount taken from us, and even at that, the \$38,157 is categorical, which means that it can be used only for Compensatory Education.

"In effect, we're contributing \$265,000 of unrestricted money to a pot from which we are going to get \$38,000 in restricted funds.

"Getting back to the budget figures, please also note that since both these budget additions are offset by the same amounts of additional State Aid, the district tax figure of \$13,335,064 remains unchanged.

FINANCIAL REPORT:

Mr. Ramsland presented the financial report as of February 28, 1986, showing total funds available of \$16,320,273.03, contractual orders to date of \$11,246,766.56, leaving a cash balance of \$5,073,506.47.

REPORT OF THE TREASURER OF SCHOOL MONEYS:

Mr. Ramsland presented the Report of the Treasurer of School Moneys as of February 28, 1986, showing total receipts of \$11,395,313.51, cash expenditures of \$10,290,821.09, leaving a cash balance of \$1,104,492.42.

SUPERINTENDENT'S REPORT:

Dr. Fadule presented and read the following report:

"Attached is the February 28, 1986 enrollment report.

"Budget presentations will be made at Radcliffe School on Tuesday, March 25th and at Washington School on Wednesday, March 26th.

"The Annual Winter Sports Awards Program will be conducted at the high school auditorium on Wednesday, April 2, 1986, at 7:30 p.m.

"The Franklin School mathematics team coached by Mrs. Mary Peele, Miss Deborah Pinto and Mr. Mark Maniscalco finished second in the North Jersey contest by seven-tenths of a point. The team members are as follows:

CAFETERIA REPORT:

Mr. Hermo presented the cafeteria report as of February 28, 1986, showing a cash balance as of July 1, 1985 of \$1,588.95, total receipts of \$166,488.90, total disbursements of \$157,197.69, leaving a balance of \$10,880.16. Total "A" lunch - 9,236. Total milk sold - 9,645.

REPORT OF COMMITTEES:

Mr. Malanga, Chairman of the Athletic Committee, reported he had met with the Athletic committee and asked Dr. Fadule to address the meeting. Dr. Fadule spoke about Crew and the boathouse. Dr. Fadule, Dr. Votto, Mr. Gallucci, Mr. Kucinski, and Mr. Malanga, spent many hours at the boathouse observing the complete operation. They observed unsafe conditions and discussed means of remedying them. The Nutley Board is in total agreement that something must be done to improve the situation and has temporarily scheduled the 9th graders to start at a later hour than the rest of the Crew. The safety of our youngsters is of utmost importance. A formal letter is to be sent to the Belleville and Kearny Boards of Education alerting them to the unsatisfactory conditions existing at the boathouse.

HEARING OF CITIZENS:

Mrs. Joan Rubino, 48 North Road, asked what the Board policy was regarding teachers taking credits off a grade as a disciplinary action. Mr. DeCesare replied that credits are not taken off a grade for disciplinary purposes. Mr. Kucinski stated if in fact such a situation did exist, it would be looked into and corrected.

Mr. Donald Heerwig, 470 Chestnut Street, asked if a decision had been reached concerning his request of last January regarding closing schools if the temperature goes below a certain degree. Mr. Kucinski replied that due to negotiations and preparation of the budget, no time was available for looking into this situation, but he assured Mr. Heerwig that it will be handled. Mr. Ramsland commented that the system is operational.

Mrs. Joseph Shuster, 462 Chestnut Street, addressed her comments to Mr. Ramsland, saying she was sorry to see him leave and complimenting him on his many years of dedication and endless efforts, an asset to the Nutley system.

Two seniors enrolled in the AP-Physics course at the high school objected to Dr. Fadule about taking the exam recommended by this course. There is a nominal fee involved, which the Board previously agreed to absorb if a student was unable to finance the fee. The students claim that if they do not take the exam, they will not receive credit for the four marking periods. Mrs. Scheckel, Mr. Piro, Dr. Baratta and Mr. Hermo, also asked questions regarding this specific course. Dr. Fadule responded that he would check into all phases of this situation.

Mrs. Rubino commented that this test is an optional test and there are colleges that will not accept it.

Mrs. Maria Heider, 3 Whitford Ave., asked if a decision had been made regarding the grading system used in Nutley, to which Mr. Kucinski replied.

ADVERTISED NOTICE OF BUDGET HEARING:

Mr. Ramsland read the following legal notice, which appeared in the March 6, 1986 issue of THE NUTLEY SUN:

"The Board of Education of the Township of Nutley, New Jersey will hold a Public Hearing on the tentative budget for the school year 1986/1987 at an open meeting in the Board of Education Meeting Room, 375 Bloomfield Avenue, Monday, March 24th, 1986, at 8:00 p.m. Citizens are invited to attend this meeting, ask questions and offer suggestions pertaining to the budget. The proposed tentative budget will be open to inspection at the office of the Board of Education for seven days prior to the Public Hearing."

PRESENTATION OF THE 1986/1987 BUDGET:

Mr. Kucinski made comments with regard to the proposed 1986/1987 budget. All members in attendance were supportive of the budget, stating it was fiscally responsible and educationally sound. Mr. Kucinski then opened the meeting for questions from the floor.

Mr. Heerwig questioned the amount of money in the surplus account to which Mr. Ramsland responded.

ADOPTING BUDGET FOR THE 1986/1987 SCHOOL YEAR:

Mr. Hermo presented and moved the adoption of the following resolution, seconded by Mr. Malanga. On a roll call vote the resolution was unanimously adopted:

WHEREAS, the proposed tentative budget for the 1986/1987 school year has been properly published in the local newspaper and adequately presented to the public at the budget hearing,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education of the Township of Nutley hereby adopts the budget for the 1986/1987 school year in the following amounts:

NOW, THEREFORE, BE IT RESOLVED, That at the Annual Meeting of the legal voters of the school district to be held on Tuesday, April 15, 1986 for the election of three members to the Board of Education for a term of three years, there be submitted the question of voting taxes to support the 1986/1987 budget as follows:

WHEREAS the New Jersey School Boards Association has previously sought legislation to abolish the position of Treasurer of School Moneys, transferring his or her duties to the Secretary of the Board of Education, and

WHEREAS, a bill to accomplish this result was introduced by Senator Hagerdorn in January 1985, has had a second reading and is identified as S-277, and

WHEREAS Senator Hagerdorn's untimely and unfortunate death last summer has been followed by no further action on the bill, and

WHEREAS, the reasons for the passage of said legislation are no less valid today than they have been in the recent past,

THEREFORE, BE IT RESOLVED, That the New Jersey School Boards Association seek another sponsor for S-277 and encourage the legislature, both Senate and Assembly, to move the bill along to final passage.

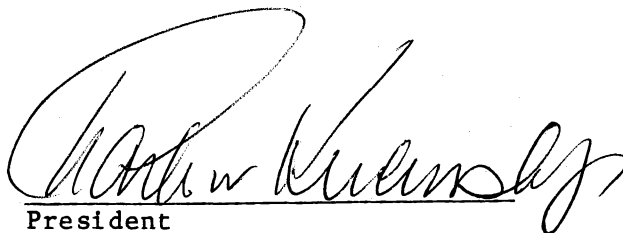

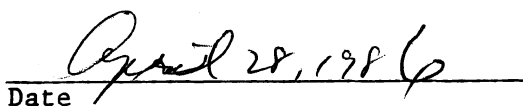
