January 23, 1989

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, January 23, 1989 at 8:00 p.m., with Dr. Anthony N. Baratta, President, presiding.

ANNOUNCEMENT OF MEETING:

Dr. Baratta read the following:

"According to the provisions of the 'Open Public Meetings Act' (Chapter 231, P.L. 1975), proper notice of this Regular Meeting of the Board was provided in the Annual Notice of April 11, 1988. Said Notice was:

FLAG SALUTE:

The meeting was opened with Mr. Hermo leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Mr. Sam P. Battaglia, Mrs. Sally Goodson, Mr. Frank V. Hermo, Mr. Charles W. Kucinski, Jr., Mr. Charles J. Piro, Mr. Robert J. Rusignuolo and Mrs. Rosalie C. Scheckel. Absent: Mr. Gerard T. Restaino. Ten citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on December 19, 1988 at 8:02 p.m., being in the hands of each member, reading of same was dispensed. Mrs. Scheckel moved that the minutes be approved, seconded by Mr. Kucinski, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Sincaglia presented and read the following communications:

- A petition from 68 Nutley residents and one Bloomfield resident concerning continuation of the German language program.
- 2. A letter from the Sterling Board of Education concerning litigation before the Commissioner of Education.

SECRETARY'S REPORT:

Mr. Sincaglia presented the Report of the Secretary as of December 31, 1988. (See attached report.)

Mr. Sincaglia announced that the February 13 meeting of the Board is scheduled as a Conference Meeting but will, instead, be designated as a Special Meeting to adopt the tentative budget to be submitted to the Essex County Superintendent of Schools.

TREASURER'S REPORT:

Mr. Sincaglia presented the Report of the Treasurer of School Moneys as of December 31, 1988. (See attached report.)

SUPERINTENDENT'S REPORT:

Dr. Fadule presented and read the following report:

"Second quarter report cards will be distributed on February 3, 1989.

"The implementation of our priorities is progressing quite well and reports to the Board are forthcoming over the next several months.

"Comments pertaining to the school district's curriculum articulation activities on January 9, 1989."

Dr. Votto reported that the teachers met on January 9 from 1:30 - 4:00 p.m. in departments, grade level and districtwide committees. These meetings would be the genesis of the Superintendent's Advisory Committee report which will be forthcoming in a matter of weeks. He added that the most important items would probably be made priorities over the summer months. Dr. Votto further stated that the priorities implemented are going quite well; six committees met last Saturday, and the Board would hear from them in the coming weeks and months. Dr. Votto reported that the University of Medicine and Dentistry is involved in a dietary intervention screening program for school children. Nutley students in grades 3, 4 and 5 will have their cholesterol levels checked. He explained that this is a voluntary program, and the students could work with the University on a long-term study. Dr. Votto added that in Nutley, 250 youngsters would be tested.

Mr. Sincaglia explained that with regard to the Asbestos Hazard Emergency Response Act, the required training for custodial and maintenance workers would take place on February 23 and 24.

CAFETERIA REPORT:

Mrs. Scheckel presented the cafeteria report as of December 31, 1988, showing a cash balance as of July 1, 1988 of (\$4,584.61), total receipts of \$128,695.65, total disbursements of \$114,872.22, leaving a cash balance of \$9,238.82. Total "A" lunch - 10,677. Total milk sold - 8,383.

Dr. Baratta commented that there are fewer lunches and milks sold this year and asked if there was any particular reason for this. Mr. Sincaglia responded that it is partly caused by enrollment, and Mr. Battaglia added that when the weather is nice, the students do not stay at school for lunch.

COMMITTEE REPORTS:

Mrs. Goodson stated that she was distributing a summary of what transpired at the Semi-Annual Delegates Assembly of the New Jersey School Boards Association. She also thanked Mrs. Scheckel for attending the January Radcliffe School P.T.A. meeting in her place, and she also reminded everyone that the Radcliffe P.T.A. fund raiser would take place at Rascals Comedy Club on March 6.

Mrs. Goodson thanked Mr. Sincaglia for writing letters to Senator Orechio and Assembly members Kelly and Crecco regarding the loss in State aid for 1989-90. She informed the Board that a rally would be held in Trenton this Thursday concerning the cutbacks in aid and representation from all boards would be appreciated.

Mrs. Scheckel reported that she had attended a meeting of the Parent Council, and the main discussion was scholarships for seniors. Mrs. Scheckel explained that she gave them information relating to their concerns regarding special subjects, and they seemed to accept the explanations. Mrs. Scheckel announced that the High School Parent Council will be having a fish and chip dinner in March for their fund raiser.

Mr. Piro, Chairman of the Athletic Committee, reported that the Committee met on January 9 and reviewed the athletic budget. After discussion, the budget was cut another \$2,691.60.

Mr. Kucinski stated that the Music Boosters had an executive meeting, and there will be a fund raiser to help support the trip to Orlando.
