The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, March 27, 1989 at 8:00 p.m., with Dr. Anthony N. Baratta, President, presiding.

ANNOUNCEMENT OF MEETING:

Dr. Baratta read the following:

"According to the provisions of the 'Open Public Meetings Act' (Chapter 231, P.L. 1975), proper notice of this Regular Meeting of the Board was provided in the Annual Notice of April 11, 1988. Said Notice was:

1. Posted at the entrance of the Board Office.
2. Mailed to The Nutley Sun, the Star Ledger, the North Jersey Herald & News and the Nutley Journal.
3. Mailed to the Nutley Township Clerk.

"Formal action will be taken."

FLAG SALUTE:

The meeting was opened with Mr. Kucinski leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Mr. Sam P. Battaglia, Mrs. Sally Goodson, Mr. Charles W. Kucinski, Jr., Mr. Charles J. Piro, Mr. Robert J. Rusignuolo and Mrs. Rosalie C. Scheckel. Absent: Mr. Frank V. Hermo and Mr. Gerard T. Restaino. Approximately forty-five citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on February 27, 1989 at 8:00 p.m., being in the hands of each member, reading of same was dispensed. Mr. Kucinski moved that the minutes be approved, seconded by Mr. Rusignuolo, and unanimously approved by the Board.

Copies of the minutes of the Special Meeting held on March 13, 1989 at 7:30 p.m., being in the hands of each member, reading of same was dispensed. Mr. Kucinski moved that the minutes be approved, seconded by Mr. Rusignuolo, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Sincaglia presented and read the following communications:

1. A letter from the President of the Essex County School Boards Association regarding negotiations networking.
2. A letter to Mrs. Goodson from the Kearny Crew Parents indicating that they will be hosting a regatta on April 8.

Mrs. Goodson expressed the hope that there would be a good turn-out for the regatta. She explained that the finish line was moved back towards Newark, and a permit was obtained for the river bank park for picnics, although food would also be available. Mrs. Goodson further stated that ten towns from New Jersey, Pennsylvania and New York would be participating, and she urged everyone to attend.

Mrs. Scheckel questioned when the regatta would begin and end. Mrs. Goodson replied that she did not know as yet, but it would start late morning to allow time for all participants to travel to Kearny.

Mr. Sincaglia stated that the next three pieces of correspondence were related, explaining that the New Jersey School Boards Association encouraged boards of education to write to the New Jersey Assembly urging the restoration of \$98,000,000 in school aid. Such restoration would have meant \$91,000 for Nutley. Mr. Sincaglia further explained that on March 6 he had written to Assembly Speaker Hardwick on behalf of the Board, with copies of the letter to Assembly members Kelly and Crecco.

3. A letter from Assemblyman John V. Kelly stating that he had contacted Assembly Speaker Hardwick to request that he call a special session of the Assembly.
4. A letter from the New Jersey School Boards Association expressing appreciation for our sending the letter to Assembly Speaker Hardwick and explaining why they were endorsing the restoration of \$98,000,000 rather than full State funding.
5. A letter from Assembly Speaker Chuck Hardwick indicating that we would be pleased to know that in February, the Assembly voted for full State funding. The Senate approved another bill. The latest is that there is still some hope for approval of the \$98,000,000 aid restoration bill.

Mr. Sincaglia remarked that passage of this bill would be too late to affect the budget to be voted on next week.

6. A memo from the Nominating Committee of the Essex County School Boards Association concerning the status of the Association's current officers.

SECRETARY'S REPORT:

Mr. Sincaglia presented the Report of the Secretary as of February 28, 1989. (See attached report.)

TREASURER'S REPORT:

Mr. Sincaglia presented the report of the Treasurer of School Moneys as of February 28, 1989. (See attached report.)

Mr. Sincaglia stated that last week, the district received a check in the amount of \$11,774 from our insurance agent, William Searle. This check represented a dividend on our premium for the 1987-88 school year. Mr. Sincaglia further stated that this check was welcome and pointed out the wisdom of working with such a fine broker as the Searle Agency.

SUPERINTENDENT'S REPORT:

Dr. Fadule commented that Mr. Searle does a splendid job of watching over the interests of the school district, which is highly commendable.

Dr. Fadule presented and read the following report:

"Attached is the student enrollment chart as of February 28, 1989.

"The district-wide Instrumental Music Program will be conducted at the high school auditorium on Tuesday, March 28, 1989 at 7:30 p.m.

"The Annual Winter Sports Program will be conducted at the high school auditorium on Wednesday, April 5, 1989 at 7:30 p.m.

"Third quarter report cards will be distributed on Friday, April 14, 1989."

Dr. Fadule explained that our district believes in recognizing the achievements of our youngsters and tries very hard to build a true sense of self-confidence and a positive image. He added that tonight we have present some fine students in the elementary area who distinguished them-

selves, their families and schools by their participation in the Dr. Martin Luther King, Jr. Day Essay Contests. He further stated that a second group present this evening is the Franklin School Mathcounts team which once again did very well with stiff competition.

Dr. Votto explained that for the Dr. Martin Luther King, Jr. Day Essay Contests, Nutley had eight winners at the County level. There were 900 applicants and 90 winners.

Mr. John Walker, Principal of Yantacaw School, stated that he was proud to know our youngsters participated at such a high level. He then presented certificates to the following Yantacaw School students:

Dr. Votto explained that for the State-wide Dr. Martin Luther King, Jr. Day Essay Contest competition, more than 5,000 students entered, there were 23 winners, and Nutley had one winner.

On behalf of the Board, Dr. Baratta commented that the students accomplished something very difficult in the field of writing. He added that this Board is involved in trying to do whatever is necessary to assist students to obtain a good education, and tonight is a great honor. Dr. Baratta also recommended that the students' pictures be placed on the Board room walls. He thanked the parents, teachers and all involved.

Dr. Fadule stated that the honors for the Mathcounts team are due to the commitment of so many people in the Franklin School - teachers in the math program, staff, the principal and vice-principal and the students themselves. He added that once again, despite tremendous competition, the students have distinguished themselves by doing so well.

Mr. Primamore, Principal of Franklin School, explained that this year, the Mathcounts organization, which is a national organization, redistricted the state and reduced the number of regions. Nutley was in competition with students from Warren, Sussex, Morris and Essex Counties, and we did very well, coming in fifth this year.

CAFETERIA REPORT:

Mrs. Goodson, Board representative to two schools, stated that she had attended musical programs at Radcliffe and Lincoln Schools, and also at Yantacaw School in place of Mr. Kucinski, adding that everyone had done a beautiful job. She added that Radcliffe School has done a very interesting poetry anthology, having had a workshop from January 3 to February 3, and she urged all Board members to read it.

Mrs. Goodson further stated that as UNICEF Chairman, she received a certificate of appreciation for all Nutley schools for their participation in the Halloween program, where the schools raised \$2,342.95.

Mr. Rusignuolo commented that he had the pleasure of attending the Washington School musicale the other evening, adding that the students do a wonderful job each year. He extended his congratulations to Rose DiGeronimo, Washington School Principal, the teachers, parents and students for a job well done.

Mrs. Scheckel stated that she attended the Senior Benefit "Phantom of the Opera," and she commended the students for a fine performance and also commended the faculty members who directed the play. She added that the performances were well attended.

OLD BUSINESS:


Mr. Kucinski questioned if any investigation has been made regarding before-school and after-school programs. Dr. Fadule and Dr. Votto replied that this was being examined.
