The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, December 18, 1989 at 8:01 p.m., with Dr. Anthony N. Baratta, President, presiding.

ANNOUNCEMENT OF MEETING:

Dr. Baratta read the following:

FLAG SALUTE:

The meeting was opened with Mrs. Scheckel leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Mrs. Sally Goodson, Mr. Frank V. Hermo, Mrs. Aileen Hresko, Mr. Charles W. Kucinski, Jr., Mr. Robert J. Rusignuolo and Mrs. Rosalie C. Scheckel. Absent: Mr. Sam P. Battaglia and Mr. Charles J. Piro. Eight citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on November 27, 1989 at 8:02 p.m., being in the hands of each member, reading of same was dispensed. Mrs. Scheckel moved that the minutes be approved, seconded by Mr. Rusignuolo, and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Sincaglia presented and read the following communications:

1. A thank you for the Board's expression of sympathy from the family of Everett Zabriskie.
2. A letter from Kathy McQuarrie, Associate Director for Public Relations, New Jersey Education Association, thanking Mr. Paul Kocum, Franklin School teacher, for the performance he helped lead at the Creative Arts Festival at the NJEA Convention.
3. A notice from the Essex County School Boards Association regarding a Negotiations Data Exchange to be held on January 10, 1990 in the Nutley Board of Education Conference Room.

Mr. Rusignuolo explained that this is a first step in bringing the county group together.

4. A letter from Assemblyman Bill Schluter regarding the Local Government Ethics Bill.


NEW BUSINESS:
