ADOPTION OF TENTATIVE BUDGET:

Mrs. Scheckel presented and moved the adoption of the following resolution, seconded by Mr. Rusignuolo. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the Board of Education hereby adopts a tentative budget for the 1990/1991 school year in the amount of:

Current Expense	\$23,055,953.00
Debt Service	<u>95,153.75</u>
Total Budget	\$23,151,106.75, of which

the following amount shall be raised by local tax levy:

Current Expense	\$19,075,213.00
Debt Service	<u>86,887.75</u>
Total	\$19,162,100.75

BE IT FURTHER RESOLVED, That the Secretary be authorized to submit this budget to the County Superintendent for approval, and

BE IT FURTHER RESOLVED, That upon receiving the approval of the County Superintendent, the Secretary be authorized to publish the 1990/1991 budget in The Nutley Sun.

There being no further business to come before the Board, on motion made by Mr. Battaglia, seconded by Mrs. Scheckel, the meeting adjourned at 8:04 p.m.
