ANNOUNCEMENT OF MEETING:

ADOPTION OF REVISED TENTATIVE BUDGET:

Mr. Kucinski presented and moved the adoption of the following resolution, seconded by Mr. Rusignuolo. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the Board of Education hereby adopts a revised tentative budget for the 1990/1991 school year in the amount of:

Current Expense	\$23,097,345.00	
Debt Service	<u>95,153.75</u>	
Total Budget	\$23,192,498.75	of which

the following amount shall be raised by local tax levy:

Current Expense	\$19,677,881.00
Debt Service	<u>89,593.75</u>
Total	\$19,767,474.75

BE IT FURTHER RESOLVED, That the Secretary be authorized to submit this budget to the County Superintendent for approval, and

BE IT FURTHER RESOLVED, That, in accordance with P.L. 1990, c. 2, the Secretary be authorized to publish the 1990/1991 budget in The Nutley Sun.

RESOLUTION TO CLOSE MEETING TO THE PUBLIC:

Dr. Baratta asked Mr. Sincaglia to read the following resolution:

WHEREAS, the Board of Education will be discussing matters exempt from public discussion pursuant to N.J.S.A. 10:4-12,

NOW, THEREFORE, BE IT RESOLVED, That the Board of Education adjourn to closed executive session at this time, and

BE IT FURTHER RESOLVED, That the results of the discussions will be made public by inclusion on the agenda of a subsequent meeting of the Board of Education, or when the reasons for discussing such matters in closed session no longer exist.
