Board of Education Nutley, New Jersey

March 26, 1990

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, March 26, 1990 at 8:00 p.m., with Dr. Anthony N. Baratta, President, presiding.

ANNOUNCEMENT OF MEETING:

Dr. Baratta read the following:

"According to the provisions of the 'Open Public Meetings Act' (Chapter 231, P.L. 1975), proper notice of this Regular Meeting of the Board was provided in the Annual Notice of April 10, 1989. Said Notice was:

"Formal action will be taken."

FLAG SALUTE:

The meeting was opened with Mr. Battaglia leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Mr. Sam P. Battaglia, Mrs. Sally Goodson, Mrs. Aileen Hresko, Mr. Charles W. Kucinski, Jr., Mr. Robert J. Rusignuolo and Mrs. Rosalie C. Scheckel. Absent: Mr. Frank V. Hermo and Mr. Charles J. Piro. Approximately 50 citizens were present.

PRESENTATION OF AWARDS:

Dr. Fadule stated that he was very pleased and proud of the accomplishments of the students who have been named Garden State Distinguished Scholars, adding that they have distinguished themselves, their families and school. Dr. Fadule then introduced Mr. John Jacone, principal of Nutley High School.

On behalf of the student body, Mr. Jacone thanked the Board, Dr. Fadule and Dr. Votto for arranging to have this outstanding evening. He added that it was a pleasure to be here this evening and to be the representative of the youngsters who are present. Mr. Jacone introduced Mr. Paul McCarthy, Director of Guidance, who, together with Mr. Battaglia, Chairman of the Academic Committee, presented awards to the Garden State Distinguished Scholars.

Mr. Jacone then presented a picture of the Garden State Distinguished Scholars to the Board on behalf of the high school. Dr. Fadule commented that it would be added to the gallery of pictures in the conference room.

Dr. Baratta congratulated the scholars on behalf of the Board.

CAFETERIA REPORT:

Mrs. Scheckel presented the cafeteria report as of February 28, 1990, showing a cash balance as of July 1, 1989 of (\$4,262.78), total receipts of \$201,338.75, total disbursements of \$191,531.69, leaving a cash balance of \$5,544.28. Total "A" lunch - 9,035. Total milk sold - 6,203.

COMMITTEE REPORTS:

Mr. Rusignuolo reported that he and Mrs. Goodson had attended the legislative session of the Essex County School Boards Association yesterday, adding that it was very well attended by Board members throughout the county. He mentioned that the most important issue discussed was the dissatisfaction with the Governor's cuts in education aid.

Mr. Kucinski read the following statement:

"Once again, Nutley High School was successfully represented in swimming competitions at both the county and state levels.

"The Essex County Swimming Championships were held at Saint Benedict's Preparatory School in Newark on Wednesday, January 24, 1990. The following students entered and placed in their respective events:

Debra Golden (Senior) Placed first in both the 50 Yard Free Style and the 100 Yard Breast Stroke.

Jennifer Heider (Senior) Placed third in both the 100 Yard Back Stroke and the 100 Yard Free Style.

Melissa Heider (Sophomore) Placed first in both the 200 Yard Individual Medley and the 100 Yard Butterfly.

Karen Currie (Freshman) Placed second in both the 100 Yard Butterfly and the 200 Yard Individual Medley.

Lori Golden (Freshman) Placed third in the 50 Yard Free Style and second in the 100 Yard Free Style.

"A combined effort by the Heider sisters and the Golden sisters resulted in a First Place for Nutley in the Girls 200 Yard Medley Relay.

"Four of the five girls mentioned above went on to enter the NJSSAA 17th Annual Swimming Championships which were held at Trenton State College on Saturday, March 3, 1990. Two of the girls placed in the following events:

Debra Golden - Placed eleventh in the 100 Yard Free Style and fifth in the 50 Yard Free Style.

Jennifer Heider - Placed twelfth in the 200 Yard Individual Medley and second in the 100 Yard Back Stroke.

"I would publicly like to congratulate the girls and thank Anne Marie Kowalski for her dedication to this group."

Mrs. Goodson questioned why the swimmers are not sponsored by the district. Dr. Fadule explained that the district sponsors them so they can enter New Jersey state activities. Mrs. Goodson stated that she would like to put the swimming situation on the table for discussion at the proper time.

RESOLUTION AUTHORIZING SUBMISSION OF PROPOSAL TO VOTERS AT THE ANNUAL SCHOOL ELECTION:

Mr. Rusignuolo presented and moved the adoption of the following resolution, seconded by Mr. Kucinski. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED by the Board of Education of the Township of Nutley, in the County of Essex, New Jersey as follows:

1. At the annual election the following proposal shall be submitted to the voters for their approval:

PROPOSAL

The Board of Education of the Township of Nutley in the County of Essex, is authorized (a) to undertake various capital projects within the school district including (1) asbestos abatement activities and related work at Franklin School, Lincoln School, Nutley High School, Radcliffe School, Spring Garden School, Washington School and Yantacaw School including all work necessary therefor and incidental thereto; (2) removal of existing fuel oil storage tanks at Franklin School, Lincoln School, Nutley High School, Radcliffe School, Spring Garden School, Washington School and Yantacaw School including all work necessary therefor and incidental thereto; (3) making necessary modifications to the heating plants at Franklin School, Lincoln School, Nutley High School, Radcliffe School, Spring Garden School, Washington School and Yantacaw School including all work necessary therefor and incidental thereto; and (4) replacing the roof above the auditorium and main gymnasium at Nutley High School including all work necessary therefor and incidental thereto, and to expend for the aforesaid an amount not to exceed \$1,985,000 and (b) to issue bonds of the school district for said purposes in the principal amount not exceeding \$1,985,000.

2. This Board of Education hereby approves and adopts the proposals Paragraph 1 above and, subject to the approval of the legal voters of the school district, hereby determines to carry out the same.

- 3. The Board Secretary is hereby directed to include the proposal in all notices posted or published with respect to the annual election, such posting and publication to be at least ten days before the date of the annual election.
- 4. This Board of Education hereby acknowledges and confirms that, in accordance with N.J.S.A. 18A:24-16 and 18A:24-17, a supplemental debt statement has been prepared as of the date of this resolution by the Chief Financial Officer of the Township of Nutley, being the only municipality comprised within the School District giving effect to the proposed authorization of bonds of the School District in the amount stated in the proposal set forth in the notice and that the supplemental debt statement has been filed in the office of the Clerk of the Township of Nutley and in the office of the Secretary of the Board of Education prior to the adoption of this resolution. This Board of Education hereby directs the Secretary of the Board of Education to have the supplemental debt statement filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs prior to the date of the annual election.

Mr. Sincaglia explained that the resolution was carefully drafted by the Board attorney since a bonding referendum is strictly regulated by the State of New Jersey and reviewed by the Attorney General's office.

Mr. Sincaglia indicated that the Board has known for some time that we had to address an asbestos issue and the underground storage tanks, and this year the high school roof problem became evident. Mr. Sincaglia indicated that he is hopeful that many of the projects can be done this summer and be complete within three years. The bond issue is a very important item that the voters will have to decide at this upcoming election.

Mrs. Hresko questioned if the entire resolution would appear on the ballot, to which Mr. Sincaglia responded that the "Proposal" portion would be on the ballot.

APPOINTMENT OF ENGINEER (Underground Storage Tanks):

WHEREAS, there exists a need for professional engineering services in connection with upcoming projects concerning underground fuel oil storage tanks, and

WHEREAS, the firm Energy for America, Inc., Springfield, New Jersey is qualified and capable of performing these services, and
