The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, October 22, 1990 at 8:08 p.m., with Mrs. Rosalie C. Scheckel, President, presiding.

ANNOUNCEMENT OF MEETING:

Mrs. Scheckel read the following:

"According to the provisions of the 'Open Public Meetings Act' (Chapter 231, P.L. 1975), proper notice of this Regular Meeting of the Board was provided in the Annual Notice of May 1, 1990. Said Notice was:

"Formal action will be taken."

FLAG SALUTE:

The meeting was opened with Mr. Hermo leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Dr. Anthony N. Baratta, Mr. Sam P. Battaglia, Mrs. Sally Goodson, Mr. Frank V. Hermo, Mrs. Aileen Hresko and Mr. Robert J. Rusignuolo. Absent: Mr. Charles W. Kucinski, Jr. and Mr. Charles J. Piro. Approximately 17 citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on September 24, 1990 at 8:04 p.m., being in the hands of each member, reading of same was dispensed. Dr. Baratta moved that the minutes be approved, seconded by Mr. Rusignuolo and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Sincaglia presented and read the following communications:

1. An expression of thanks for the Board's expression of concern from Ruth Marino, district bus driver who underwent a serious operation and came through successfully.
2. An expression of thanks for the Board's expression of sympathy from the family of Ann Polukort, the mother of an employee, who had passed away.
3. A copy of a letter sent to the President of the New Jersey School Boards Association from the Ringwood Board of Education indicating its concern over some of the recent actions taken by the New Jersey School Boards Association and asking for some public responses to certain issues.
4. A notice from Commissioner Peter Scarpelli advising the district of construction taking place on Church Street.
5. Thank-you letters from Louis Williams and James Murray for the complimentary football tickets.
6. Two resolutions from the Cranford Board of Education concerning the New Jersey School Boards Association and its activities and use of funds and calling for the New Jersey School Boards Association to create a permanent suburban and rural boards standing committee to address needs of children in those districts.
7. A letter from Captain Frederick Scalera and Inspector David Wilson, Nutley Fire Department:

"The Nutley Fire Department held fire drill evaluations at all the Nutley schools during Fire Prevention Week. Problem solving activities were an important part of these drills. The Nutley Public Schools excelled in their overall state of emergency readiness. Blocked stairways, missing students and general induced confusion did not hinder well executed evacuations.

"We appreciate our reception throughout the educational system. It is apparent that educators have prepared the students for our assembly programs.

"Our firefighters look forward to continuing fire safety programs in the school system."

Mr. Sincaglia commented that each year the fire department's program gets better, and it is enjoyed by the students and staff but also taken seriously.

#### SECRETARY'S REPORT:

Mr. Sincaglia presented the Report of the Secretary as of September 28, 1990. (See attached report.)

Mr. Sincaglia commented that the contractual orders are high because September is the month that employees' salaries are committed for the year.

Mr. Sincaglia announced that a sale of temporary notes in the amount of \$995,000 was conducted on October 11, 1990, and these notes were dated October 18, 1990. He explained that this was the remaining portion of the monies authorized by the voters last April. Mr. Sincaglia further indicated that the district received a very good rate of 6.27% from First Fidelity Bank, the low bidder. The high bid was 6.54%. He mentioned that those monies are on deposit at First Fidelity in the proper accounts and will be used to fund the projects on the referendum. He added that these monies will earn interest at a greater rate than that at which we borrowed it.

Mr. Sincaglia stated that the Certificate of Determination and Award will be added to the minutes. He thanked the Board attorneys for their efforts regarding the paperwork on this issue.

#### TREASURER'S REPORT:

Mr. Sincaglia presented the Report of the Treasurer of School Moneys as of September 28, 1990. (See attached report.)

#### SUPERINTENDENT'S REPORT:

Dr. Fadule presented and read the following report:

"As of this meeting every open house in the district has been conducted. The Administration and many Board members carried the message of priorities, accomplishments and high standards to the public. Appreciation was expressed to the P.T.A.'s and staff whose diligence made the evenings successful."

Dr. Fadule indicated that the attached enrollment report is self explanatory.

Dr. Fadule remarked on the reports being filed with the County Superintendent regarding consolidated enrollment, suspensions, dropouts and expulsions.

Dr. Fadule reminded everyone that monitoring would begin soon, adding that there is only one more public Board meeting before monitoring commences. Dr. Fadule indicated that all these items and many others would be discussed at length during that period of time.

#### CAFETERIA REPORT:

Mr. Battaglia presented the cafeteria report as of September 28, 1990, showing a cash balance as of July 1, 1990 of (\$5,483.68), total receipts of \$36,835.53, total disbursements of \$23,523.17, leaving a cash balance of \$7,828.68. Total "A" lunch - 9,884. Total milk sold - 6,502.

#### COMMITTEE REPORTS:

Mr. Hermo reported that the Facilities Committee met with Dr. Fadule and Mr. Sincaglia last week to discuss a number of things, among which were the Lincoln School renovation, the appointment of an engineer to oversee the project, changes in the gas burner installations and underground storage tanks project, as a result of recent events affecting oil supply and price, and the revised Facility Maintenance Plan, 1989-1994.

Mr. Hermo indicated that five of the resolutions before the Board this evening are the outcome of that meeting.

Mr. Hermo mentioned that the Public Information Committee met with the Mayor's Project 2000 Committee to discuss a joint venture in creating a brochure. He added that the Board would be apprised of progress in this area.

Mr. Rusignuolo, President of the Essex County School Boards Association, discussed the Association's activities in having Bob Braun, Star Ledger education reporter, speak on the Quality Education Act. He mentioned that Peter Carter, Essex County Superintendent of Schools, had spoken at an earlier meeting, and at a meeting held at Hoffmann-LaRoche, Marilyn Morhauser, Executive Director of the Educational Law Center and chief counsel for the plaintiff in Abbott vs. Burke, had spoken.

Mr. Rusignuolo indicated that the December meeting of the Association would feature a point-counterpoint discussion between the suburban and urban districts in Essex County. He added that he is anxiously awaiting the State aid figures to see how it will affect the Nutley school district.

Mr. Rusignuolo mentioned that Hoffmann-LaRoche had donated 5,000 tulip bulbs to the district and recommended that a thank-you letter be sent.

Mrs. Goodson reported that she attended a meeting of the PT Council to explain the pre and afternoon pilot program at Lincoln School, adding that she answered a number of questions. She added that she believed some of the elementary schools would be sending out surveys in their own local areas. The Lincoln School program has 17 youngsters at present, and two more will be added in November.

Mr. Sincaglia explained that the district is using a few rooms which are called substandard because they involved a change of use or may need to be upgraded to State standards. He indicated which rooms in Lincoln, Washington, Franklin and Radcliffe Schools were involved and the reasons why. He made assurances that there are no safety issues involved; this is a standard procedure.

APPOINTMENT OF ENGINEER - Lincoln School Fire Repair/Renovation:

Mr. Hermo presented and moved the adoption of the following resolution, seconded by Mr. Rusignuolo. On a roll call vote the resolution was unanimously adopted:

WHEREAS, there exists a need for professional engineering services in connection with repair/renovation of fire damaged areas at Lincoln School, and

WHEREAS, the firm of A.G.A., Inc., Linden, New Jersey is qualified and capable of performing these services, and

WHEREAS, A.G.A., Inc. has submitted a proposal acceptable to the Board of Education for these services, and

WHEREAS, N.J.S.A. 18A:18A-5 provides for the award of contracts for this type of professional service without competitive bidding,

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Township of Nutley as follows:

1. The firm of A.G.A., Inc., Linden, New Jersey is hereby appointed as the engineering firm for the Nutley Board of Education for repair/renovation of fire damaged areas at Lincoln School during the 1990/1991 school year which require professional engineering services and all other work related thereto.

2. A.G.A., Inc. shall be paid an amount equal to 6% of the total cost of the repair/renovation project, but not to exceed \$19,250.
3. This contract is awarded without competitive bidding as a professional service.

APPROVAL OF CHANGE ORDER - Underground Storage Tanks:

Mr. Hermo presented and moved the adoption of the following resolution, seconded by Mr. Rusignuolo. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the Board of Education approves change order #2 in the contract for underground storage tank removal with Active Oil Service, Inc. in the amount of \$2,000 in connection with the tank removal project at Franklin School.

APPROVAL OF CHANGE ORDER - Installation of Gas Burners:

Mr. Hermo presented and moved the adoption of the following resolution, seconded by Dr. Baratta. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the Board of Education approves change order #1 in the contract for installation of gas burners at various schools with Metco in the amount of \$8,625.

Mr. Sincaglia explained that the Township Code Enforcement Department required us to add sprinkler systems to the boiler rooms at Franklin and Washington Schools, necessitating the change order. He commented that Radcliffe School already had a sprinkler system in the boiler room.

APPROVAL OF REVISED BUDGET - Basic Skills Improvement Program - 1990/1991 School Year:

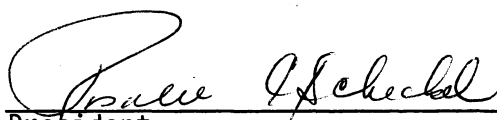

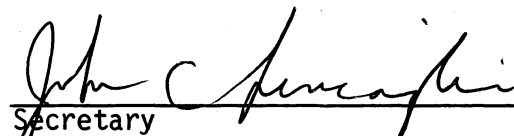
