The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, March 22, 1993 at 8:00 p.m., with Mr. Sam P. Battaglia, President, presiding.

ANNOUNCEMENT OF MEETING:

Mr. Battaglia read the following:

"According to the provisions of the 'Open Public Meetings Act' (Chapter 231, P.L. 1975), proper notice of this Regular Meeting of the Board was provided in the Annual Notice of April 13, 1992. Said Notice was:

1. Posted at the entrance of the Board Office.
2. Mailed to The Nutley Sun, the Star Ledger, the North Jersey Herald & News and the Nutley Journal.
3. Mailed to the Nutley Township Clerk.

"Formal action will be taken."

FLAG SALUTE:

The meeting was opened with Mr. Griwert leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Mr. John G. Griwert, Mr. Frank V. Hermo, Mrs. Aileen Hresko, Mr. Robert J. Rusignuolo and Mrs. Rosalie C. Scheckel. Absent: Mrs. Sally Goodson, Mr. Charles W. Kucinski, Jr. and Mr. Charles J. Piro. Approximately 100 citizens were present.

PRESENTATION OF AWARDS:

Dr. Fadule noted that the Nutley School District believes in honoring our young people who have distinguished themselves, their families and school. He indicated that tonight we will honor fine young people who have achieved well academically. He then introduced Mr. John Jacone, principal of Nutley High School.

Mr. Jacone, on behalf of the high school, thanked the parents for the privilege of working with their youngsters. Mr. Jacone commented that the students being honored tonight achieved above and beyond what is expected in the course of a day. He added that he is very proud of these youngsters. Mr. Jacone then introduced Dr. Paul McCarthy, Director of Guidance at Nutley High School.

Dr. McCarthy explained that Garden State Scholars must be in the top 20% of their class and must have a combined SAT score of 1000 at the end of their junior year. He added that they receive \$500 annually throughout four years of school at a New Jersey college.

SECRETARY'S REPORT:

Mr. Sincaglia presented the Report of the Secretary as of February 28, 1993. (See attached report.)

Mr. Sincaglia apprised the Board of changes in the budget document. He explained that it was expected that there would be two questions on the ballot this year, one for Current Expense and one for Capital Outlay. He indicated that the state passed legislation last week which will consolidate both questions into what is called the General Fund, and this will catch up with what GAAP requires.




