The meeting was opened with Mr. Kucinski leading the Board members and citizens in the Pledge of Allegiance to the American flag.

APPROVAL OF MINUTES:

Copies of the minutes of the Regular Meeting held on November 28, 1994 at 8:02 p.m. being in the hands of each member, reading of same was dispensed. Mrs. Scheckel moved that the minutes be approved, seconded by Mr. Rusignuolo and unanimously approved by the Board.

- A letter from Brooklawn School District asking districts to adopt a resolution and forward copies to the Governor and other political leaders regarding the budget process and the amount of time the state allows districts to produce budgets once figures are released to them.

He commented that the committee had reviewed the requests received from each school and department in the District, noting that these requests had already been carefully scrutinized by Dr. Fadule, Dr. Votto and Mr. Sincaglia. The Budget Review Committee will be looking at all items requested, including those of the Athletic Committee, and will strive to attain a

fiscally responsible budget.

Mr. Rusignuolo commented on New Jersey School Boards Association meetings he had recently attended.

Mrs. Hresko noted that she had attended the program at Franklin School that featured Senator Frank Lautenberg, who is an alumni of Nutley High School, which at the time he attended was located in Franklin School. She stated that the Senator had given a wonderful talk, answered questions from students and in general, the program had been very informative. Dr. Fadule also said the students seemed to relate to Senator Lautenberg, feeling he was one of their own.

Mr. Pelaia commented on the Yuletide Ceremony held at the High School, indicating that it had been a delightful program.

NEW BUSINESS:

Mr. Kucinski commented on the letter from New Jersey School Boards Insurance regarding districts being given the option to self-insure for health benefits. Mr. Kucinski moved that a letter be written, as suggested, to Senator Donald T. DiFrancesco, Mrs. Scheckel seconded and it was unanimously approved by the Board.

Mr. Kucinski also suggested that in response to the letter from Brooklawn School District, the Nutley Board of Education send letters to Governor Whitman and other political officials regarding the amount of time allotted to submit school budgets after state aid and cap figures have been released. Mr. Kucinski made a motion that we participate in this campaign, seconded by Mr. Hermo and unanimously approved by the Board.

Mr. Kucinski spoke about a student planner booklet that he, as Franklin School representative, the Franklin School PTA and Dr. Vivinetto had worked to develop. The project has been completed and Board members will be sent copies of this booklet which includes school rules, study skills, etc. for their review. Mrs. Russo commented that she had seen these booklets for elementary schools and would send in samples she had picked up.

Mr. Hermo announced that he will not be running for office again when his term runs out this year.

Mr. Battaglia commented on the 100th Anniversary edition of The Nutley Sun. He noted that the section on the schools was very well done, but that the Letters to the Editor section did contain some errors in fact. He wished all present a Happy and Healthy Holiday season.

ADJOURNMENT:

There being no further business to come before the Board, on motion made by Mr. Hermo, seconded by Mrs. Scheckel, the meeting was adjourned at $8:25~\rm p.m.$
