The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, January 23, 1995 at 8:00 p.m., with Mr. Sam P. Battaglia, President, presiding.

### ANNOUNCEMENT OF MEETING:

Mr. Battaglia read the following:

### **APPROVAL OF MINUTES:**

Copies of the minutes of the Regular Meeting held on December 19, 1994 at 8:02 p.m. being in the hands of each member, reading of same was dispensed. Mr. Kucinski moved that the minutes be approved, seconded by Mrs. Russo and unanimously approved by the Board.

### **COMMUNICATIONS:**

Mr. Sincaglia presented and read the following communications:

- 1. A letter from the Delaware Valley Regional High School District regarding two resolutions one dealing with the timing of the release of state aid figures and budget submission date, and the other dealing with when the reorganization meeting of the board occurs, their feeling being that more time should be provided between the date of the election and the date of the reorganization meeting.
  - Mr. Sincaglia noted that both of these concerns had previously been addressed by our Board.
- 2. A notice from the Essex County School Boards Association regarding the general meeting which is to take place on January 25, 1995 with Dennis Testa, President, New Jersey Education Association, and Mark Finkelstein, President, New Jersey School Boards Association, as speakers.
- 3. A letter from the Hunterdon Central Regional High School District urging the legislature to allow municipalities to assess local impact fees on new development.

### **SECRETARY'S REPORT:**

Mr. Sincaglia presented the Report of the Secretary as of December 31, 1994. (See attached report.)

Mrs. Hresko moved that the Board accept the Report of the Secretary, seconded by Mrs. Scheckel. On a roll call vote the resolution was unanimously adopted.

### TREASURER'S REPORT:

Mr. Sincaglia presented the Report of the Treasurer of School Moneys as of December 31, 1994. (See attached report.)

Mrs. Scheckel moved that the Board accept the Report of the Treasurer of School Moneys, seconded by Mrs. Hresko. On a roll call vote the resolution was unanimously adopted.

### SUPERINTENDENT'S REPORT:

Dr. Fadule presented and read the following report:

"Second quarter report cards will be distributed on Friday, February 3, 1995.

"Attached is the student enrollment chart of January 3, 1995.

"School will be closed for mid-winter recess - February 20-24, 1995.

"Comments pertaining to the 8th Grade results of the N.J. Early Warning Test."

Dr. Fadule explained that this test is very similar in concept to the HSPT for 11th grade students. He noted that he was very pleased with the results of the 8th grade test, and it is a tribute to all the teachers in the district.

Dr. Fadule noted that Nutley is classified as a "D-E" district, which is our socio-economic group. There are 90 8th grades in the state that are in that classification, and Nutley finished seventh out of the 90 in the per cent of students who passed the test. Dr. Fadule indicated that results like these are particularly gratifying when you consider the high achievement combined with the low cost per pupil. He added that Nutley did very well when compared with the rest of the county.

Mr. Pelaia requested that Dr. Fadule comment on how Nutley compares to the districts in the state that are socio-economically higher. Dr. Fadule responded that Nutley did extremely well compared to higher classifications in the state, adding that our record is better than the average score of the "I" districts.

Dr. Fadule noted that last Friday night a "World Culture and Cappuccino Night" was held, and he heard it was a very fine evening which dealt with foreign languages and world culture. He thanked Dr. Vivinetto and all the teachers who were involved, as well as all the students and parents who assisted.

Dr. Fadule mentioned that he had had the opportunity to attend the Wizard of Oz and he felt it was absolutely outstanding, adding that he had yet to see a high school play which was its equal. He noted that there were five shows instead of the usual three, and every seat of all five shows was sold out.

Mrs. Russo, Mr. Pelaia, Mrs. Hresko and Mrs. Scheckel also expressed their admiration and commendation for everyone involved in the production.

### **CAFETERIA REPORT:**

Mrs. Hresko presented the cafeteria report as of December 31, 1994 showing a 1994/1995 budget of \$586,900.00, contractual orders to date of \$426,673.60, leaving funds available of \$230,920.08.

### **COMMITTEE REPORTS:**

Mr. Kucinski reported that the Budget Review Committee met again this evening and reviewed further budget reductions as well as those made in the past. He noted that the district is busy preparing the budget which will be voted on on April 18. Mr. Kucinski indicated that the Committee is working diligently to prepare a budget which will meet the educational needs in a fiscally responsible manner. He added that state aid figures should be available by Wednesday.

Mr. Piro mentioned that the Athletic Committee met during the first week of January with Mr. Kucinski sitting in on the meeting because of the absence of one of its members. He noted that it was mostly a budgetary meeting and the Committee made a strong recommendation to look again at some of the coaches and programs and try to rearrange something so there could be a girls' freshman soccer program. He added that the recommendation is now in the hands of the administration.

Mr. Rusignuolo reminded the Board members that the Essex County School Boards Association meeting to take place on January 25 is the fourth year in a row that the Presidents of the New Jersey School Boards Association and New Jersey Education Association will be the speakers, adding that it is always an informative and interesting evening.

### **HEARING OF CITIZENS (Resolutions Only):**

Mrs. Eva Pfuhler, 345 High Street, asked for an explanation of resolution #7, Extra Compensation. Dr. Votto responded that it reflects payments to staff for ongoing curriculum and inservice development programs.

(Major accounts are General Fund and Debt Service.)

Mr. Piro presented and moved the adoption of the following resolution, seconded by Mr. Kucinski and unanimously approved by the Board:

BE IT RESOLVED, That the Board of Education accepts the resignation of Mr. Lawrence Tuorto, Assistant Spring Track Coach.

### **HEARING OF CITIZENS:**

Mrs. Sera Shuster, 462 Chestnut Street, asked what payment the Board receives for the rental of the Franklin School to the Nutley Assembly of God. Mr. Sincaglia replied that it is a little over \$6,000 per month for the use of 13 classrooms plus the auditorium and cafeteria and this much more than covers expenses.

Mrs. Shuster then offered a suggestion that the school buses parking at Radcliffe School be moved to the ball field behind Yantacaw School. She then asked a question as to where the revenue received from other districts for transporting students goes, to which Mr. Sincaglia replied that it goes into the General Fund.

Mrs. Shuster then questioned a payment to New Jersey Transit in the amount of \$1,000. Mr. Sincaglia responded that it was for parkway tokens which were used for transporting Special Education students.

Mr. Rory Moore, 12 Essex Street, questioned if parents were mentioned during Dr. Fadule's report on the 8th Grade Early Warning Test, to which Dr. Fadule replied in the affirmative, adding that the support of parents and teachers is what makes us do so well. Mr. Moore then questioned how the district did on the SAT's, to which Dr. Fadule replied that the verbal scores were average and the math scores were above average.

Mr. Moore then asked if the district knew how many of the students going on to college actually graduate, to which Dr. Fadule replied that he did not know and was not sure if it was possible to obtain accurate information on this statistic.

Mr. Moore questioned if the district is thinking of outsourcing custodial services. Mr. Battaglia replied that the Board is reviewing all aspects of the entire budget but no decisions had been made as yet and no recommendations had been made by the Budget Review Committee. Mr. Battaglia noted that cafeteria and transportation outsourcing was also being investigated, but no decisions had been made.

Mrs. Pfuhler questioned how many of our students that go to college receive scholarships. Dr. Fadule replied that the total amount of scholarship money received by Nutley students is almost one million dollars, but he did not have a break down on individual scholarship recipients.

Mrs. Pfuhler then asked if a decision had been made on the boxes placed in voting areas for the students. Mr. Battaglia replied that we had checked with our legal counsel and he understood that the PTA's were looking at the situation as well as at other ideas.

Mrs. Pfuhler inquired why Nutley does not have an organized swim team. Mr. Battaglia replied that Nutley does not have a pool, and also, it is difficult to offer every sport. Mr. Piro commented that

the Athletic Committee has a large "wish list" and swimming is at the bottom of it. Mr. Battaglia noted that the Board provides a stipend for a coach and expenses to assist the swimmers. Mrs. Pfuhler asked several other questions regarding the swim program to which Dr. Fadule responded.

Mrs. Pfuhler then noted that the Ocean Spray Cranberry Company gives grants to encourage women's sports, and the Board could possibly receive \$10,000. She added that other companies do the same thing. She then gave an Ocean Spray grant application to the Board.

Mrs. Susan DeJackmo, 108 Walnut Street, expressed her concerns regarding the privatization of custodial services and urged the Board to carefully investigate all aspects of the proposal. Mr. Battaglia responded that the subject of outside service contracts would be carefully studied and would have to meet a great number of criteria. He added that the Board knows what it has and would really have to be convinced in order to change.

A citizen at 67 Vreeland Avenue asked if background checks would be done on outside service people, to which Mr. Battaglia replied in the affirmative, also noting that we were not at the point of hiring any outside company.

### **OLD BUSINESS:**

### **NEW BUSINESS:**

Mr. Kucinski commented that he had met this week with the Music Boosters group who, this year, would like to have the band camp at a location away from Nutley and which is a dedicated band camp, and he would like the Board to authorize payment of the salaries of the instructors as was done when the band camp was held in Nutley. Mrs. Scheckel questioned what the overall charge would be. Mr. Kucinski responded that he did not know, but the cost would be paid by the students.

Mrs. Russo asked if there is a fee for the instructors to be at the camp. Mr. Kucinski replied in the affirmative, adding that he would like the Board to incur that cost but realizes it may not be in the financial position to do that.

Dr. Fadule noted that because of the budget process everything is up in the air, but the basic idea is a good one because it can foster solidarity and togetherness and a spirit of cohesiveness. Mrs. Hresko commented that the summer band camp is usually on the list for deletion in the event of a budget defeat.

Mrs. Hresko updated the Board members and public on the new communications project that the teachers are having funded by the New Jersey Education Association. The grant is approximately \$2,500 and is to help build communication between parents and teachers. She explained that it is a telephone bulletin board system and the pilot program will take place at Radcliffe School beginning the middle of February and lasting until June of 1996.

Mr. Piro announced that after 11 years as a member of the Board of Education, he would not seek re-election. He noted that he felt the staff in Nutley is outstanding and expressed his thanks to the Board, administration and others for their help. He also noted that he felt Mr. Kucinski was one of the most dedicated Board members in the state. He added that there is a difficult road ahead for the next Board members.

### **ADJOURNMENT:**

There being no further business to come before the Board, on motion made by Mr. Pelaia, seconded by Mr. Kucinski, the meeting was adjourned at 9:10 p.m.
