

The Conference Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, October 7, 1996 at 7:30 p.m. with Mr. Robert J. Rusignuolo, President, presiding.

ANNOUNCEMENT OF ADEQUATE NOTICE:

Mr. Rusignuolo read the following:

CALL OF ROLL:

The members present at roll call were: Mrs. Michele Fleitell, Mr. Vincent Moscaritola, Mr. Franklin J. Patterson, Mr. Joseph C. Pelaia, Mrs. Maria Russo, Mr. Robert Schweikert, Jr., Mr. Louis F. Williams and Mr. Robert J. Rusignuolo. Absent: Mr. Charles W. Kucinski, Jr.

1. Dr. Votto indicated that the Board would be reviewing the attainment of the 1995-96 school objectives and the proposed 1996-97 objectives.

The 1995-96 objectives for the high school were presented by Mr. Cocchiola and Mr. O'Dell, Social Studies Coordinator. Dr. Vivinetto presented the objectives for Franklin School and the elementary school objectives were presented by the respective principals - Mr. Conrad, Mrs. Serafino, Ms. Anello, Miss DiGeronimo and Mr. Calicchio. The 1996-97 objectives were then presented by the elementary principals, Mr. Cocchiola and Dr. Vivinetto.

Dr. Votto noted that these items would be on the agenda at the public meeting of October 28 (see attached).

2. Mr. Sincaglia presented a request from the League of Women Voters to be able to place a banner on the Oval fence which was a reminder to the public to vote on election day.

3. Mr. Sincaglia noted there had been a request which he had discouraged as to running a flea market at Lincoln School. He pointed out that the Board had banned flea markets from the high school a few years ago and that the problems that were inherent there would be as bad or worse at the elementary schools.

After a brief discussion there was consensus that there should be no approval of any flea market at any of the school facilities.

The resolution was moved by Mrs. Fleitell, seconded by Mr. Pelaia and unanimously approved by the Board.
