Board of Education Nutley, New Jersey April 14, 1997

The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, April 14, 1997 at 8:00 p.m. with Mr. Robert J. Rusignuolo, President, presiding.

ANNOUNCEMENT OF MEETING:

Mr. Rusignuolo read the following:

FLAG SALUTE:

The meeting was opened with Mr. Moscaritola leading the Board members and citizens in the Pledge of Allegiance to the American flag.

CALL OF ROLL:

The other members present at roll call were: Mrs. Michele Fleitell, Mr. Charles W. Kucinski, Jr., Mr. Vincent Moscaritola, Mr. Franklin J. Patterson, Mrs. Maria Russo, Mr. Robert Schweikert, Jr. and Mr. Louis F. Williams. Absent: Mr. Joseph C. Pelaia. Approximately 25 citizens were present.

APPROVAL OF MINUTES:

Copies of the minutes of the Special Meeting held on March 24, 1997 at 7:00 p.m. being in the hands of each member, reading of same was dispensed. Mr. Kucinski moved that the minutes be approved, seconded by Mr. Patterson and unanimously approved by the Board.

COMMUNICATIONS:

Mr. Sincaglia presented and read the following communications:

- 1. A notice from the Essex County School Boards Association regarding a workshop on regionalization held on April 12, 1997.
- 2. A Notice to Property Owners from the owner of property located at 121 Brookfield Avenue for permission to erect a second story addition. Mr. Sincaglia indicated that this would have no impact on the district.
- 3. A thank-you note from the family of Giuseppina Violante for the Board's expression of condolence.
- 4. A memorandum from Robert Rusignuolo, Nominating Committee Chair, Essex County School Boards Association, regarding information concerning the opening of nominations for officers and the Board of Directors and other officials of the Essex County School Boards Association for the next school year.

SECRETARY'S REPORT:

Mr. Sincaglia presented the Report of the Secretary as of March 31, 1997. (See attached report.)

Mrs. Fleitell moved that the Board accept the Report of the Secretary, seconded by Mr. Kucinski. On a roll call vote the resolution was unanimously adopted.

TREASURER'S REPORT:

SUPERINTENDENT'S REPORT:

Dr. Votto presented and read the following report:

"New Jersey Middle School Peer Leadership Initiative Program - Miss Hirsch"

Miss Hirsch explained that this is a coordinated state-wide strategy for substance awareness in New Jersey schools, encompassing a group of 10 youngsters in grades 7 or 8. She noted that a series

of five awareness prevention activities will be conducted over the course of the year and the idea is to reach over 200 of their peers. She added that there will be two school-based monitors and a community volunteer. Miss Hirsch mentioned that at the conclusion of the program, surveys, observations, interviews and a family night would take place.

Miss Hirsch also noted that the cost would be \$1,100 and the Nutley Municipal Alliance has agreed to provide funding so there will be no cost to the district. Miss Hirsch further indicated that there is a competitive grant for funding and she feels the district has a very good chance to win funding. She gave credit to Lisa Santosuosso, the district's new Substance Awareness Coordinator, for her assistance in filling out the grant application.

Mrs. Fleitell remarked that the application was beautifully written. Mrs. Fleitell then asked who was head of the Community Alliance, to which Miss Hirsch replied that Anthony lannarone was the Chairman.

Mr. Patterson presented and moved the adoption of the following resolution, seconded by Mr. Moscaritola and unanimously approved by the Board:

CLOSING OF SCHOOLS:

Mrs. Russo presented and moved the adoption of the following resolution, seconded by Mr. Kucinski and unanimously approved by the Board:

BE IT RESOLVED, That the Nutley Board of Education approve that the last day of school for the 1996/1997 school year be changed from Tuesday, June 24 to Friday, June 20, 1997. High school graduation will be conducted on Tuesday, June 24, 1997.

HEARING OF CITIZENS:

Dr. Steven Greco, 248 Vreeland Avenue, noted that he felt that Nutley has a good school system, especially from K-8, but that his problems deal with the high school. He indicated that at the February 24 Board meeting he had brought up a situation whereby the basketball team had practiced late and he was asked by the Board to look into it. Dr. Greco indicated that he had looked into the situation and found that the incident took place on January 25, Mr. Murray, the head coach, was ill and Mr. Gargiulo was in charge, adding that it was a normal practice right after school from 3:30 to 7:30 p.m.

Mr. Rusignuolo cautioned Dr. Greco, noting that he did not want to get into a give and take situation and reminding Dr. Greco that he was allowed three minutes to speak. He also asked that Dr. Greco treat this Board with some respect.

Dr. Greco asked if the Board had an answer to his question. Dr. Votto responded that Dr. Greco had raised the issue with no particulars and his rejoinder (Dr. Votto) was for Dr. Greco to obtain some particulars. Dr. Votto added that now that particulars had been received he would look into the situation.

- Dr. Greco then related an alleged incident concerning an athlete and Mr. Gargiulo, whereby the student had requested that he be allowed to leave practice early. Dr. Greco indicated his wish for the Board to check into Mr. Gargiulo's behavior.
- Mr. Anthony Pergola, 102 Hawthorne Avenue, questioned the status of the hockey survey. Dr. Votto replied that the survey has not been undertaken since the last Board meeting since the district is in transition with a new Athletic Director.
- Mr. Pergola noted that he had been told that he could see the survey before it was handed out, asking if that was proper procedure. Dr. Votto indicated that Mr. Pergola would be able to see the survey. Mr. Pergola then asked if the Board attorney had been contacted regarding his questions. Dr. Votto stated that other districts have been questioned.
- Mr. Pergola then asked a question relating to the athletic budget dealing with All Sports. Mr. Sincaglia explained that All Sports contains expenditures for various sports, not just one sport. Mr. Pergola mentioned that he had asked for copies of the expenses for each sport. Dr. Votto noted that he thought Mr. Pergola was going to contact us. Mr. Rusignuolo suggested that Mr. Pergola contact Mr. Sincaglia for this information.
- Mr. Pergola then remarked that he had presented the Board an article on Nike and asked if anyone had looked at it. Dr. Votto replied that Mr. Pelaia, Chairman of the Athletic Committee, had the article.
- Dr. Greco questioned what is Board policy with regard to coaches being certified and people assisting coaches, relating an incident where someone helped the head baseball coach. He asked if the Board would have a serious problem if someone were injured while being coached by a non-certified assistant. Dr. Votto indicated that only coaches in the Board's employ may work with the youngsters. Dr. Votto further noted that it was his understanding that it was halted the next day after Mr. Zarra was informed.
- Dr. Greco asked how it was possible that no one knew of this situation for three years. Mr. Rusignuolo noted that when we found out it was improper it was stopped immediately. Mr. Sincaglia stated that there is no certification for athletic coaches. He added that, generally speaking, they are teachers, but not always, adding that many coaches in the state are people who are interested in children. With regard to injuries, Mr. Sincaglia explained that the bottom line is whether or not there was any negligence on the part of the Board; it does not necessarily equate that because someone was volunteering, that person is at fault.
- Dr. Greco then asked if the coach should not be reprimanded. Mr. Rusignuolo replied that Dr. Greco was now bringing up a personnel matter which can not be discussed in public.
