The Regular Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, September 22, 1997 at 8:02 p.m. with Mr. Robert J. Rusignuolo, President, presiding.

ANNOUNCEMENT OF MEETING:

Mr. Rusignuolo read the following:

CALL OF ROLL:

RECESS MEETING:

Mr. Williams moved that the Board meeting recess and move to the gymnasium in Radcliffe School, seconded by Mr. Moscaritola and unanimously approved by the Board. The meeting recessed at 8:04 p.m.

RECONVENE MEETING:

The meeting reconvened at 8:10 p.m.

The meeting was opened with Mr. Restaino leading the Board members and citizens in the Pledge of Allegiance to the American flag.

Mr. Williams presented and moved the adoption of the following resolution, seconded by Mr. Pelaia. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the Board of Education appoints Mr. Christopher Santos as a part-time custodian for the 1997/1998 school year, effective September 23, 1997, at the annual salary of \$12,422 (2-3) plus \$1,073 night stipend (prorated) in accordance with the 1997/1998 Buildings and Grounds Salary Guide. (Hired on a 90-day probationary period.)

AMENDING RESOLUTION - Approval
of Contract - Physical Therapy Services:Bonnie Stoeckel

Mr. Patterson presented and moved the adoption of the following resolution, seconded by Mr. Pelaia. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the resolution, Approval of Contract - Physical Therapy Services, for Bonnie Stoeckel, adopted at the August 25, 1997 Board of Education meeting, be amended to reflect an amount of \$15,470.

HEARING OF CITIZENS:

Mr. Mauro Tucci, 1150 Colonial Terrace, expressed his concerns with regard to the job action taking place at Nutley High School, adding that fund raising activities are in jeopardy and many clubs have not yet started. Mr. Tucci remarked that the Student Council has managed to continue but that is just one of many. He also noted that students have tried to go for assistance before and after school and have been turned away and have been turned down when asking for teacher recommendations.

Mr. Tucci requested, in the interests of all concerned, that some agreement be arrived at relatively soon, adding that the students are not taking sides but are acting in their own interest and that of the rest of the school.

Mr. Rusignuolo read the following statement:

"I thank you for your interest and to all of you for coming out tonight. I must say that I anticipated questions such as yours and if you'll indulge us, I'll make the following remarks:

"Firstly, every Board member and teacher, alike, is concerned about the welfare of our students and there has been, and continues to be, a strong commitment to seeing all students succeed.

"Next, we think very highly of our teachers. They are and have been outstanding professionals and rank second to none. I have always been among the first to point that out.

"With regard to negotiations, I am not permitted to speak specifically about the talks while they are under way except that these are trying times and we are all working hard to reach a fair and equitable solution for all. To this end, negotiations are still ongoing. We have met approximately a half dozen times. We have been negotiating in good faith. Differences have been narrowed. We have made progress and we continue to be optimistic and look forward to a successful conclusion, hopefully in a matter of weeks at our mediation session, which is scheduled for October 9th.

"For now, I assure you that this entire Board is thinking of all of you in this community and is looking forward to reaching a fair and equitable agreement. I ask for your cooperation, patience and understanding during the remaining period of time."

Mr. Gary Bell, 3 Webster Street, noted that he had voted for the budget so that the teachers could get the raise to which they are entitled since Nutley has a staff which is second to none, having educated his six children and helping make it possible for them to find excellent jobs.

Mrs. Joan Rubino, 48 North Road, questioned what is going on to bring about this job action, to which Mr. Rusignuolo replied that he is not able to discuss any particulars. Mrs. Rubino remarked that she feels the teachers are doing just fine with the salaries they are receiving at the present time, adding that some teachers deserve more than they are getting and some don't deserve the amount they are receiving.

Miss Laurie Ferrara, 87 Highfield Lane, indicated that she is President of the Senior Class and they are concerned about receiving their fair share as seniors as different events have been postponed and the seniors are worried since this is not fair to them as this is their last year of high school and this is disheartening and tones down everyone's spirits. She added that it is the students' educations and they are receiving the brunt of what is going on and they hope the Board will keep them in mind.

Mr. Rusignuolo thanked Miss Ferrara for her comments, adding that he has spoken with some of the student advisors and they are equally concerned. He indicated that the Board hopes this will be over quickly and things will get back to normal, adding that the district's professionals are committed to the students and their activities. Mr. Rusignuolo noted that the professionals will help the students when things are back to normal.

Mr. Adam Reed, 283 Franklin Avenue, stated that he did not learn a lot in school but the teachers work hard and teach all the other students what they want to know, adding that the teachers deserve whatever they should get, being entitled to every penny.

Mrs. Russo indicated that she wanted to address the children because their concern is with us, adding that we, as a Board, have been very fair with our teachers, appreciating everything they do. She explained that the yearbook and class advisors' duties are part of their job descriptions so these duties will be done. Mrs. Russo noted that the negotiations process is going on and will be handled fairly; it is just something which is happening right now. She stressed that the teachers will do those things they are being paid to do and the students will receive their fair senior year.

Miss Natalie Quevedo, 45 Cleveland Avenue, remarked that she is a freshman and had not done very well in school last year. She expressed her concern about her inability to obtain extra help at this time. She also indicated that she participates in sports and is worried about how her transcript will look as far as helping her enter college, adding that some of the seniors are trying to make their transcripts look as good as possible and this situation will not help them.

Mrs. Barbara Carrino, 38 Lake Street, noted that she is a parent who shares the same concerns as the students and this evening's attendance is a tribute to the teachers. She stated that she was glad to hear that the teachers will continue to do what they are paid for but the Board should consider all the extra things they do for which they are not paid. Mrs. Carrino also noted that she had voted for the budget and wondered why the negotiations process is taking so long. She also noted that her daughter is a senior who is concerned about the effects of these actions which create a great deal of anxiety and which cause more stress for her daughter and many of the students. Mrs. Carrino remarked that she would like to see a quick resolution of this situation.

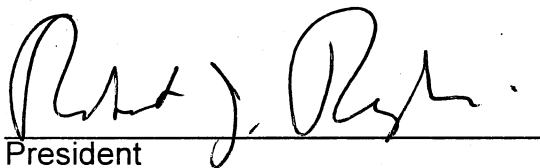

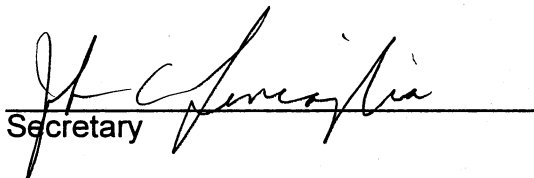

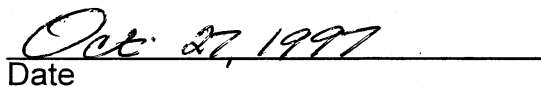
