Mr. Williams presented and moved the adoption of the following resolution, seconded by Mrs. Fleitell and unanimously approved by the Board:



NOW, THEREFORE, BE IT RESOLVED, That the Board of Education adjourn to closed executive session at this time, and



ADJOURNMENT:


