CALL OF ROLL:

The members present at roll call were: Dr. Philip T. Casale, Mrs. Michele Fleitell, Mr. Vincent Moscaritola, Mr. Alfred R. Restaino, Jr., Mrs. Maria Russo, Dr. Joseph P. Scarpelli, Mr. Louis F. Williams and Mr. Joseph C. Pelaia. Absent: Mr. Steven P. Picciano.

1. Mr. Pelaia indicated that the Board would be recessing to executive session to consider personnel matters.

RESOLUTION TO CLOSE MEETING TO THE PUBLIC:

Mr. Pelaia asked Mr. Sincaglia to read the following resolution:

3. Mr. Pelaia asked Mr. Sincaglia what the status was on the information the Board was seeking concerning the proposed development of the ITT property.

Mr. Sincaglia indicated that a preliminary draft had been received from the consultant used, Whitehall Associates, Inc., and this would be followed by a meeting with the Board and Dr. Richardson of Whitehall Associates.

It was noted by Mr. Pelaia that, in light of the very recent letter from the Planning Board indicating they would not be taking information from the Board on September 16, it would be appropriate if we could meet with Dr. Richardson at the Conference Meeting on September 14.

Mr. Sincaglia indicated he would make those arrangements as soon as he was able to contact Dr. Richardson.
