The Special Meeting of the Board of Education of the Township of Nutley, New Jersey was held in the Board Room, 375 Bloomfield Avenue, on Monday, March 8, 1999 at 7:16 p.m. with Mr. Joseph C. Pelaia, President, presiding.

ANNOUNCEMENT OF MEETING:

Mr. Pelaia read the following:

Mrs. Fleitell presented and moved the adoption of the following resolution, seconded by Dr. Casale. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the Board of Education appoints Mr. Carl Stromberg as teacher substitute for the 1998/1999 school year, effective March 9, 1999.

Mr. Moscaritola presented and moved the adoption of the following resolution, seconded by Mr. Restaino. On a roll call vote the resolution was unanimously adopted:

APPOINTMENT - Instructional Aide:Mrs. Janice Aiello

Dr. Casale presented and moved the adoption of the following resolution, seconded by Mr. Picciano. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That Mrs. Janice Aiello be appointed as an instructional aide, effective March 9, 1999, for the 1998/1999 school year at the annual salary of \$7,351 (Step 7), (p/t .5), prorated, in accordance with the 1998/1999 Secretarial Salary Guide.

APPOINTMENT - Grounds:Mr. Joseph Garofalo

Mr. Picciano presented and moved the adoption of the following resolution, seconded by Mr. Moscaritola. On a roll call vote the resolution was unanimously adopted:

BE IT RESOLVED, That the Board of Education appoints Mr. Joseph Garofalo as a grounds employee for the 1998/1999 school year, effective May 10, 1999, at the annual salary of \$25,481 (2-3) which is in accordance with the 1998/1999 Buildings and Grounds Employees Salary Guide. (Hired on a ninety-day probationary period.)

APPOINTMENT - Maintenance:Mr. Stephen Farese

Dr. Scarpelli presented and moved the adoption of the following resolution, seconded by Mrs. Roncaglio. On a roll call vote the resolution was unanimously adopted:

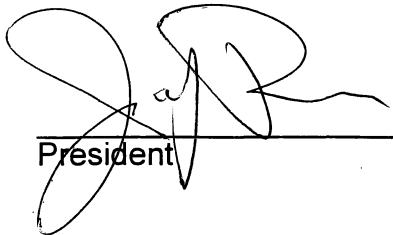
BE IT RESOLVED, That the Board of Education appoints Mr. Stephen Farese as a maintenance employee for the 1998/1999 school year, effective March 22, 1999, at the annual salary of \$29,176 (7-3) which is in accordance with the 1998/1999 Buildings and Grounds Employees Salary Guide. (Hired on a ninety-day probationary period.)

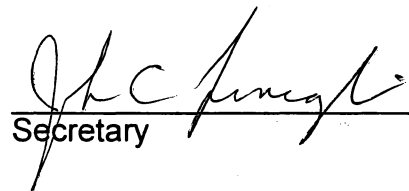
BE IT FURTHER RESOLVED, That the Board approves the application for emergency hiring of Stephen Farese as per the state criminal review procedure.

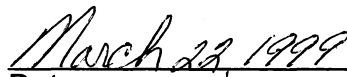
